SUMMARY MEETING REPORT

12th Plenary meeting of GRECO (Strasbourg, 9-13 December 2002)

I. Opening of the meeting

1. The President, Mr Michel GAUTHIER (France), opened the 12th plenary meeting of GRECO on 9 December 2002 at 9.30 am. He welcomed the participants, a list of whom appears in <u>Appendix I</u> to this report. As Mr GAUTHIER was unable to be present from 11 to 13 December, Mr Drago KOS (Slovenia) chaired the meeting on those dates.

II. Adoption of the agenda

2. The meeting agenda was adopted as set out in Appendix II to this report.

III. Statement by the President and Vice-President

- 3. The President told participants that due to his new functions at the Bobigny Prosecution Service (Ile-de-France), he had to leave GRECO. He paid tribute to the work done by all the GRECO members who had helped to make the first evaluation round a success.
- 4. The Vice-President, Mr Drago KOS (Slovenia), reported on his participation in the European Commission–TAIEX anti-corruption seminar (Brussels (Belgium), 6 October 2002) and in the "Fighting Corruption in an Enlarged Europe" round table which the Open Society EU Accession Monitoring Programme (EUMAP) had held, under the auspices of GRECO (Council of Europe, Strasbourg, 18 November 2002).

IV. Statement by the Executive Secretary

- 5. The Executive Secretary of GRECO announced that on 2 December 2002, the Statutory Committee had approved GRECO's budget for 2003. He reported on the progress of informal discussions between the Secretariat and possible new members of GRECO.
- 6. He outlined the report published by the Open Society Institute "Monitoring the EU Accession Process: Corruption and Anti-corruption Policy" (this emphasised the importance of GRECO's work in promoting reform for implementing international legislation to combat corruption in candidate States to accession, argued that GRECO was the most suitable forum for assessing progress in this area following the European Union's enlargement and recommended European Union membership of GRECO). He also reported on preparations for Global Forum 3 (Seoul, 29-31 May 2003) and the contribution that GRECO might make to it.

V. Examination of the draft evaluation report on Albania

- 7. GRECO carried out a first reading of the draft first-round evaluation report on Albania, as set out in Greco Eval I Rep (2002) 9E (P3).
- 8. First, the members of the GRECO evaluation team which had visited Albania Mr Joseph E. GANGLOFF (United States), Mr Håkan ÖBERG (Sweden) and Mr Sandor DUSIK (Hungary) orally presented their assessment of the situation in Albania with regard to action against corruption, in the light of the first-round evaluation themes.
- 9. The Albanian representatives presented GRECO with their comments on the draft report. Afterwards, the interveners from the Czech Republic and the Netherlands, appointed by the GRECO Bureau (20 November 2002) under Rule 29 paragraph 2 of the Rules of Procedure, put their questions on the evaluation report [Greco Eval I (2002) 46 and 47] to the Albanian representatives.

- 10. GRECO held a general debate based on the available documents and explanations provided. It then held an initial discussion on the draft report, paragraph by paragraph, and agreed on the amendments to be made. It concluded by giving the amended draft a second reading.
- 11. After two readings, GRECO adopted the first-round evaluation report on Albania, as set out in Greco Eval I Rep (2002) 9E.
- 12. GRECO asked the Albanian delegation to confirm as soon as possible their authorities' consent to lifting the confidentiality of the report.

VI. Examination of the draft evaluation report on "the former Yugoslav Republic of Macedonia"

- 13. GRECO carried out a second reading of the draft evaluation report on "the former Yugoslav Republic of Macedonia", as set out in Greco Eval I Rep (2002) 7E (P3) second reading. It was recalled that GRECO had considered the draft report at a first reading during its last meeting (GRECO 11, October 2002). GRECO postponed the review and the adoption of the evaluation report upon the request of the authorities of "the former Yugoslav Republic of Macedonia". These authorities committed themselves to send complementary information requested by GRECO.
- 14. First, the members of the evaluation team which had visited "the former Yugoslav Republic of Macedonia" Mr Jorn GRAVESEN (Denmark), Mr Vladimir TURAN (Slovak Republic) and Mr Jean-Pierre BUEB (France) orally presented their assessment of the amendments which they had made to the draft report in the light of the additional information submitted in writing by the delegation from "the former Yugoslav Republic of Macedonia".
- 15. GRECO held a general debate based on the available documents and explanations provided. After a second reading, it adopted the first-round evaluation report on "the former Yugoslav Republic of Macedonia", as set out in Greco Eval I Rep (2002) 7E.
- 16. GRECO asked the delegation from "the former Yugoslav Republic of Macedonia" to confirm as soon as possible their authorities' consent to lifting the confidentiality of the report.

VII. Examination of the draft evaluation report on Malta

- 17. GRECO carried out a first reading of the draft first-round evaluation report on Malta, as set out in Greco Eval I Rep (2002) 8E (P3).
- 18. First, the members of the GRECO evaluation team which had visited Malta Mr William KEEFER (United States), Mr Kazimir ABERG (Sweden) and Ms Isabelle VAN HEERS (Belgium) orally presented their assessment of the situation in Malta with regard to action against corruption, in the light of the first-round evaluation themes.
- 19. The Maltese representatives presented GRECO with their comments on the draft report. Afterwards, the Cypriot and Luxembourg interveners, appointed by the GRECO Bureau (20 November 2002) under Article 29 paragraph 2 of the Rules of Procedure, put their questions on the evaluation report [Greco Eval I (2002) 48 and 49] to the Maltese representatives.
- 20. GRECO held a general debate based on the available documents and explanations provided. It then held an initial discussion on the draft report, paragraph by

- paragraph, and agreed on the amendments to be made. It concluded by giving the amended draft a second reading.
- 21. After two readings, GRECO adopted the first-round evaluation report on Malta, as set out in Greco Eval I Rep (2002) 8E.
- 22. GRECO asked the Maltese delegation to confirm as soon as possible their authorities' consent to lifting confidentiality of the report.

VIII. Final reading and adoption of the draft questionnaire for GRECO's second evaluation round

- 23. GRECO examined the draft questionnaire (GRECO (2002) 28E rev3), as amended further to the discussions held at the training seminar for evaluators in Paphos (Cyprus) from 21 to 23 November.
- 24. It was agreed that it might be difficult for states to gather all the relevant statistics on the various matters raised in the questionnaire; it was therefore decided that some questions could be satisfactorily answered using sample statistics if it was not possible to obtain comprehensive data.
- 25. It was also agreed that the draft questionnaire could be further compressed and simplified, by moving some of the questions from the questionnaire to the checklist that the Secretariat would prepare in order to assist the evaluators for the 2nd round during on-site evaluation visits. On this last point, the Bureau would determine which questions could usefully be transferred to the checklist for the attention of the evaluators, thus shortening the second-round questionnaire and removing some of the detail.
- 26. After a final reading, GRECO adopted the second-round evaluation questionnaire (Greco (2002) 28E rev4) and instructed the Secretariat to forward the final version to all the GRECO delegations after the next Bureau meeting.

IX. Conclusions of the training seminar for GRECO's second-round evaluators

- 27. The Chair, Mr KOS, presented the conclusions of the seminar for evaluators which had been held in Paphos at the invitation of the Cypriot authorities. On behalf of all the GRECO members, he thanked the Cypriot authorities and in particular Ms Eva PAPAKYRIACOU for their impeccable organisation and gracious hospitality.
- 28. The Executive Secretary said that GRECO's general conclusions and the conclusions of the panel rapporteurs appeared in Greco SEM/EVAL II (2002) 4 E/F Provisional/Provisoire. They would be translated into both Council of Europe official languages and made available to every member of the GRECO evaluation teams. All of the documents and reports presented at the seminar would gradually be posted on GRECO website: http://www.greco.coe.int
- 29. GRECO took note of the provisional conclusions of the training seminar for second-round evaluators.

X. Programme of activities for 2003

30. GRECO discussed the draft programme of activities as set out in Greco (2002) 34E and instructed the Secretariat to make a few amendments to the final version that would be forwarded to all members. This final version is dated 13 December 2002.

XI. Procedure for following up recommendations

- 31. GRECO examined the Bureau's proposals concerning the procedure to be followed when monitoring compliance with recommendations [Greco (2002) 35E, paragraphs 13 to 17].
- 32. It was decided that each evaluated country's situation report on its implementation of first-round recommendations should be attached to the GRECO compliance report dealing with the effective implementation of the first-round recommendations by each member.
- 33. GRECO also pointed out that the "observations" expressed in the first-round evaluation reports would not be subject to follow up within the "compliance reports".
- 34. GRECO approved the procedure to be followed for adopting reports on compliance with the first-round recommendations (hereinafter "compliance reports") and amended the relevant provisions of the Rules of Procedure as set out in Greco (1999) 4E Final Rev2.
- 35. GRECO appointed Romania and the United Kingdom as rapporteurs for the compliance procedure concerning Slovenia, and Germany and Poland as rapporteurs for the compliance procedure concerning the Slovak Republic. It agreed to include in its programme of activities for 2003 discussion of a number of draft compliance reports for each of its plenary meetings.

XII. Exchange of views with a delegation from Mexico (Thursday 12 December, 11.30 am - 1 pm)

- 36. GRECO members welcomed the Mexican delegation to Strasbourg and held an exchange of views. They congratulated Mexico on having signed the Criminal Law Convention on Corruption. The Mexican delegation provided GRECO with information on the policy and achievements of the Mexican authorities in combating corruption in recent years. They spoke of their country's interest in joining GRECO and expressed the hope that Mexico would ratify the Criminal Law Convention on Corruption (ETS 173) as soon as possible and become a member of GRECO.
- 37. GRECO asked the Chair to write to Ambassador Porfirio MUÑOZ LEDO, Permanent Observer of Mexico to the Council of Europe, conveying GRECO's hope that Mexico would soon be playing, among its members, a full part in anti-corruption activities.

XIII. GRECO's position on the draft UN convention

- 38. GRECO members examined a paper prepared by the secretariat on the UN Convention on Corruption (Greco (2002) 37E) and held a preliminary exchange of views.
- 39. GRECO asked representatives of member States to raise the issues the paper mentioned with their national delegations involved in the negotiations on the draft UN convention.

XIV. Amendments to the Rules of Procedure

- 40. Further to GRECO's decisions at its 11th meeting, GRECO examined a draft version of the amended Rules of Procedure which the secretariat had prepared on the Bureau's instructions.
- 41. The amendments mainly expanded on the procedure for the preparation, examination and adoption of "compliance reports" referred to earlier in this report.
- 42. GRECO amended its Rules of Procedure as set out in Greco (1999) 4E Final Rev2.

XV. Election of the President, Vice-President and Bureau members for the second evaluation round

- 43. Under GRECO's Rules of Procedure, elections to the posts of President and Vice-President and to the Bureau were to be held at the meeting immediately preceding the beginning of each evaluation round. With the first evaluation round due to end on 31 December 2002, it was time for GRECO members to appoint their new President and Vice-President, and the new Bureau members to sit during the second evaluation round.
- 44. The Executive Secretary drew attention to Article 8 paragraph 8 of the Statute ("The GRECO shall elect its President and Vice-President among the representatives of the members entitled to vote") and Article 9 of the Statute ("There shall be a Bureau composed of the President and the Vice-President (...) and five other persons elected by the GRECO, among the representatives of the members entitled to vote which are, as far as possible, Parties to at least one of the international legal instruments adopted in pursuance of the Programme of action against corruption").
- 45. He also pointed out that, under the Rules of Procedure, the President and Vice-President were elected for two years. As the terms of office of the President and Vice-President were due to expire during the second evaluation round, however, this term would be extended until the end of the second-round, ie June 2005. The non-elected candidates would remain on the list for the duration of the second-round and would fill any future vacancies on the Bureau, in order of the number of votes received.
- 46. In view of the growth in membership, GRECO decided to increase the number of Bureau members from 5 to 7.
- 47. The Executive Secretary announced that:
 - Mr KOS (Slovenia) had applied for the post of <u>President</u> of GRECO and had also been nominated for this post by Moldova and the United Kingdom.
 - Ms VAN HEERS (Belgium) had been nominated for the post of <u>Vice-</u> President of GRECO by the United Kingdom and Moldova.
 - With regard to the nominations for the Bureau, Hungary had nominated Mr Jacek GARTSKA (Poland), Slovenia had nominated Mr Paul STEPHENSON (United Kingdom), Sweden had nominated Mr Georgi RUPCHEV (Bulgaria), Moldova had nominated Mr Kazimir ABERG (Sweden) and the United Kingdom had nominated Ms Lucinda MacMAHON (Ireland).
 - In addition, MM Mark RICHARD (United States), Akos KARA (Hungary), Nedzad HADZIMUSIC (Bosnia and Herzegovina) and Franck ZIENTARA (France) had applied for the posts of Bureau member.

- 48. The elections were conducted by secret ballot and by a majority of the votes cast. The results were as follows:
 - Mr KOS (Slovenia) was elected <u>President</u> of GRECO by 31 votes in favour and 2 blank votes;
 - Ms VAN HEERS (Belgium) was elected <u>Vice-President</u> by 33 votes;
 - Mr GARTSKA (Poland) was elected to the Bureau by 27 votes;
 - Ms MacMAHON (Ireland) was elected to the Bureau by 26 votes;
 - Mr STEPHENSON (United Kingdom) was elected to the Bureau by 25 votes;
 - MM RUPCHEV (Bulgaria) and ABERG (Sweden) were elected to the <u>Bureau</u> ex aequo, with 17 votes each;
 - Mr RICHARD (United States), with 16 votes, would head the list of members who could be called on to fill any future vacancies on the <u>Bureau</u>;
 - Mr KARA (Hungary), outgoing Bureau member, had won 14 votes;
 - Mr ZIENTARA (France) had won 11 votes; and
 - Mr HADZIMUSIC (Bosnia and Herzegovina) had won 8 votes.

XVI. Other business

- 1. Timetable for submitting first-round situation reports (RS I)
- 49. With regard to the monitoring procedure for following up first-round recommendations, GRECO reminded the meeting that each member undergoing evaluation was required to submit a situation report on the action it had taken by their country on the first-round recommendations. GRECO invited members to submit their situation reports according to the approved timetable (see Appendix to GRECO's Programme of Activities for 2003 Greco (2002) 34).
 - 2. Composition of groups of members for the second evaluation round
- 50. In keeping with the Bureau's proposals (GRECO (2002) 35E, paragraphs 11 and 12), GRECO selected the following members to participate in Group A, which would be the first countries to undergo evaluation within the Second Round:
 - Slovenia
 - Slovakia
 - Finland
 - Estonia
- 51. These countries were asked to submit a detailed reply to the Questionnaire for the Second Evaluation Round by 30 April 2003.
- 52. With regard to Group B, GRECO selected the following countries for the second evaluation round:
 - Poland
 - United Kingdom
 - Cyprus
 - Luxembourg
- 53. These countries were asked to submit a detailed reply to the Questionnaire for the Second Evaluation Round by 30 June 2003.

3. Post of honorary president of GRECO

- 54. On a proposal from the representatives of Hungary, the United Kingdom and Lithuania, GRECO decided to consider Mr Michel GAUTHIER (France) as its Honorary President.
- 55. GRECO thanked its first President, Mr GAUTHIER, for the able, fair and efficient manner in which he had chaired GRECO during the first evaluation round (2000-2003).

XVII. Dates of forthcoming meetings

- 56. GRECO noted that the Bureau would hold its 16th meeting in Strasbourg on 13 December 2002 and its 17th meeting in Paris on 21 and 22 January 2003.
- 57. It decided to hold its 13th plenary meeting in Strasbourg from 24 to 28 March 2003 and its 14th meeting from 7 to 11 July 2003.
