I. Opening of the meeting

- 1. The 17^{th} Plenary Meeting of GRECO was opened by the President, Mr Drago KOS (Slovenia). The list of participants appears in <u>Appendix I</u> to this report.
- 2. The President welcomed all the representatives, in particular the delegations of the new Members, Turkey and Armenia, as well as the new representatives appointed by Estonia, Ireland and Greece.
- 3. The President informed representatives that Mr Manuel LEZERTUA had left the GRECO secretariat following his appointment to the post of Head of the Department of Crime Problems, in the Directorate General of Legal Affairs. Mr KOS introduced the new Executive Secretary of GRECO, Mr Wolfgang RAU, who had taken up his duties on $1^{\rm st}$ March.

II. Adoption of the agenda

4. The meeting agenda was adopted as it appears in <u>Appendix II</u> to this report. In future, the agenda would contain an item entitled "adoption of decisions".

III. Communication from the President

- 5. The President informed GRECO that he had addressed a conference held in Rome on 27 February 2004, by the Congress of Local and Regional Authorities of the Council of Europe, on the Code of Conduct for local and regional elected representatives. The aim of the conference had been to promote among local and regional councillors the specific policies adopted by the Council of Europe to combat corruption and foster public ethics at all levels of administration.
- 6. During a recent visit to Serbia and Montenegro, the President of GRECO had met with the Minister of Foreign Affairs, who had assured him that proper preparations would be made for future evaluation visits to his country.
- 7. Finally, the President emphasised the importance of the seminar on conventions to combat corruption and the Council of Europe's monitoring machinery, which had been held in Yerevan (Armenia) on 19 and 20 January 2004, with the participation of three experts from GRECO: Ms Anna HODGSON (United Kingdom), Mr Kazimir ÅBERG (Sweden)¹ and Ms Isabelle VAN HEERS (Belgium, Vice-President of GRECO)². The Council of Europe Secretariat had been represented by Mr Manuel LEZERTUA and Mr Hervé BOUGE. During the seminar, the Armenian authorities had submitted to the Executive Secretary the notice addressed to the Secretary General of the Council of Europe of Armenia's accession to GRECO.

IV. Communication from the Executive Secretary

8. The Executive Secretary reported on the recent visit by the Secretary General of the Council of Europe to Austria, during which he had emphasised the importance that Council of Europe member states which had not yet done so, join GRECO, following recommendations by the Committee of Ministers and the Parliamentary Assembly, as well as by the European Commission and the European Parliament. The Executive Secretary also mentioned that, in Resolution 1365 of January 2004 on "economic aspects of

European Union enlargement: the crucial years ahead", the Parliamentary Assembly of the Council of Europe had reiterated its call for the European Union to join GRECO and to ratify the Criminal and Civil Law Conventions on Corruption.

- 9. The Executive Secretary informed GRECO that a member of staff from the secretariat, Mr Spyros TSOVILIS, had attended an *Anti-Corruption Network* conference, held by the OECD in Paris from 19 to 21 January 2004. At this conference, Russian and Ukrainian representatives had been informed that it was not necessary to ratify the Criminal and Civil Law Conventions on Corruption to become a member of GRECO.
- 10. The Executive Secretary reported on new developments since the 16th Plenary Meeting of GRECO (8-12 December 2003):
- Convention ETS No 173 had been ratified by Azerbaijan on 11 February 2004, by Belgium on 23 March 2004, by Moldova on 14 January 2004, by Iceland on 11 February 2004 and by Norway on 2 March 2004. It had entered into force in respect of Ireland on 1 February 2004 and the United Kingdom on 1 April 2004. It was due to enter into force in respect of Moldova on 1 May 2004, Azerbaijan and Iceland on 1 June 2004, and in respect of Belgium, Norway and Turkey on 1 July 2004. To date, 29 countries had ratified the convention and 17 others had signed it.³
- Convention ETS No 174 had been ratified by Azerbaijan on 11 February 2004 (entry into force on 1 June 2004), by Moldova on 17 March 2004 (entry into force on 1 July 2004) and signed by Latvia on 4 February 2004 and Armenia on 17 February 2004. It had entered into force in respect of Turkey on 1 January 2004 and Hungary on 1 April 2004. To date, 20 countries had ratified the convention⁴, and 18 others had signed it.⁵
- The Protocol on arbitrators and jurors (ETS No 191) had been ratified by Bulgaria on 4 February 2004 and Norway on 2 March 2004 and signed by the Netherlands on 26 February 2004 and Slovenia on 9 March 2004. To date, three countries had ratified the Protocol and 23 others had signed it. Five ratifications were required in order for Protocol ETS No 191 to enter into force.
- The Council of Europe member states which had yet to join GRECO were: Andorra, Austria, Azerbaijan⁶, Italy, Liechtenstein, Russian Federation, San Marino, Switzerland and Ukraine.
- 11. The Executive Secretary reported on the latest Second Round Evaluation visits, which had covered Latvia, Luxembourg, Finland, Poland and Iceland. The evaluation reports on these countries were at an advanced stage of preparation and were expected to be examined at forthcoming Plenary Meetings.
- 12. In order to facilitate the drafting of compliance reports, the Executive Secretary reminded national delegations that when submitting situation reports, it was important to enclose the relevant provisions and appendices in one of the two official languages of the Council of Europe.

V. First Round Evaluation procedure

Examination of the draft evaluation report on the United States of America

13. GRECO undertook an initial examination of the draft First Round Evaluation Report on the United States of America, as set out in Greco Eval I Rep (2003) 2E (P3).

- 14. Firstly, the members of the evaluation team that had visited the United States of America, Mr Jacek Garstka (Poland), Mr Drago Kos (Slovenia), Mr Antti Pihlajamäki (Finland) and Mr Eberhard Siegismund (Germany), made brief presentations of the report with respect to their respective themes.
- The representatives of the United States of America presented the US authorities' comments on the draft report. Following the presentation, the representatives of Portugal and "the former Yugoslav Republic of Macedonia", appointed as interveners by the GRECO Bureau under Rule 29, paragraph 2 of the Rules of Procedure, addressed their questions on the draft evaluation report to the US representatives.
- 16. There followed a general debate based on the documents and explanations supplied. The Group then discussed the draft report paragraph by paragraph and agreed certain amendments. GRECO examined the draft in a second reading.
- After these two readings, the Group adopted the first round evaluation report on the 17. United States of America, as it appears in Greco Eval I Rep (2003) 2E.
- 18. GRECO invited the US delegation to confirm as soon as possible their authorities agreement to lift the confidentiality of the evaluation report.⁷

VI. Second Round Evaluation procedure

Examination of the draft evaluation report on the Slovak Republic

- GRECO undertook an initial examination of the draft second round evaluation report on the Slovak Republic, as it appears in Greco Eval II Rep (2003) 2E (P3).
- Firstly, members of the evaluation team that had visited the Slovak Republic, Mr Hans ABMA (Netherlands), Ms Olga VIDLAKOVA (Czech Republic) and Mr William KEEFER (United States of America), made brief presentations of the report with respect to their respective themes.
- The representatives of the Slovak Republic presented the Slovak authorities' 21. comments on the draft report.
- There followed a general debate based on the documents and explanations supplied, after which the Group discussed the draft report paragraph by paragraph and agreed on certain amendments.
- 23. GRECO examined the amended draft in a second reading.
- After these two readings, the Group adopted the second round evaluation report on the Slovak Republic, as it appears in Greco Eval II Rep (2003) 2E.
- 25. GRECO invited the Slovak delegation to confirm as soon as possible their authorities agreement to lift the confidentiality of the evaluation report.8

VII. Compliance procedure following the First Evaluation Round

Examination of the draft compliance report on Sweden

- 26. GRECO examined the Draft Compliance Report on Sweden, prepared by the two GRECO rapporteurs, Ms Claire HUBERTS (Belgium) and Ms Zuzana STOFOVA (Slovak Republic), as it appears in Greco RC-I (2003) 11E (P3). (The purpose of the report was to assess implementation of the recommendations made by GRECO to Sweden in the first evaluation round. It was based on the situation report forwarded by the Swedish authorities (Greco RS-I (2003) 11E) and additional information subsequently requested by the rapporteurs.)
- 27. GRECO examined the draft report paragraph by paragraph, and agreed on the amendments to be made.
- 28. GRECO adopted the Compliance Report on Sweden, as it appears in Greco RC-I (2003) 11E.
- 29. GRECO invited the Swedish delegation to confirm as soon as possible their authorities agreement to lift the confidentiality of the Compliance Report.⁹

VIII. Observer status with GRECO

30. At the previous Plenary Meeting, participants had been informed that the 22nd meeting of the Bureau had instructed the Secretariat to prepare a revised version of the discussion paper on observer status with GRECO for consideration by the 23rd meeting of the Bureau. Following consultations with the Legal Advice Department of the Directorate General of Legal Affairs, the 23rd meeting of the Bureau had approved document Greco (2003) 27E Rev3. The Group examined the document and adopted it with some minor amendments (Greco (2003) 27E Rev4).

IX. Request for comments

31. At their 872nd meeting, the Ministers' Deputies of the Council of Europe had decided to send GRECO Recommendation 1646 (2004) of the Parliamentary Assembly of the Council of Europe: "Improving the prospects of developing countries: a moral imperative for the world", for possible comments. The GRECO Bureau had subsequently instructed the Secretariat to prepare, in consultation with Mr Paul STEPHENSON (United Kingdom), draft comments for consideration at the 17th Plenary Meeting of GRECO. The Group adopted the comments, as they appear in Greco (2004) 4E Rev, and instructed the Secretariat to forward the document to the Committee of Ministers.

X. Adoption of the Fourth General Activity Report for 2003

32. GRECO examined the draft Fourth General Activity Report of 2003. The Report was adopted, as it appears in Greco (2004) 2E Rev2 and instructed the Secretariat to forward the report to the Statutory Committee and to the Committee of Ministers of the Council of Europe, in accordance with Article 8, para. 1, iii of the Statute. The President of GRECO, furthermore, would be asked to present the report at a hearing during a forthcoming meeting of Ministers' Deputies.

XI. Other business

- 33. GRECO approved the Schedule for Second Round Evaluations, including joint first and second round evaluations, as set out in Greco Eval II (2004) 3bil of 25 March 2004. GRECO also took note of the composition of the teams responsible for the Second Round Evaluation of Members included in Groups E and F (Greco Eval II (2003) 1bil of 25 March 2004).
- 34. The President instructed the Secretariat to contact the OSCE with a view to holding a hearing to discuss this organisation's anti-corruption activities, at the 18^{th} Plenary Meeting of GRECO.
- 35. Participants were reminded that at its 8^{th} meeting on 15 December 2003, GRECO's Statutory Committee had agreed to examine in 2004 the possibility of adjusting the minimum and maximum contributions scale for 2005 in order to reflect the increase in the number of GRECO members. Proposals to this effect would be prepared by the Directorate of Finance in consultation with the GRECO Secretariat, for consideration by the Statutory Committee.
- 36. On the occasion of the forthcoming retirement of Mr Manfred MÖHRENSCHLAGER (Germany) who would also leave his function as German representative to GRECO, the President thanked him on behalf of the Group for the important contribution which he had made to GRECO's work, both in his capacity as German representative and as a member of the Bureau during the First Evaluation Round.

XII. Adoption of GRECO decisions

37. The 17th plenary meeting adopted the decisions, as they appear in Greco (2004) 5E.

XIII. Closure of the meeting and dates of forthcoming meetings

38. GRECO decided to hold the 24^{th} Bureau meeting in Strasbourg from 22 to 23 April 2004 and the 18^{th} Plenary meeting in Strasbourg from 10 to 14 May 2004 (5 days). In order to cope with the growing workload, the Group stressed that the other plenary meetings planned for 2004 might also need to be extended to 5 days. It therefore asked the Secretariat to find the necessary appropriations within GRECO's budget for 2004.
