**25<sup>th</sup> Plenary Meeting of GRECO** (Strasbourg, 10-14 October 2005)

**SUMMARY REPORT** 

#### I. Opening of the meeting

- 1. The 25<sup>th</sup> Plenary Meeting of GRECO was chaired by the Vice-President, Ms Isabelle VAN HEERS (Belgium). The list of participants appears in <u>Appendix I</u> to this report.
- 2. The Vice-President opened the meeting, presented the apologies of the President, Mr Drago KOS (Slovenia) who was unable to attend the meeting. She welcomed all representatives, referring in particular to those who had been newly nominated.

# II. Adoption of the agenda

3. The draft agenda was adopted as it appears in Appendix II to this report.

# III. Information provided by the President

4. The Bureau had, at its 31<sup>st</sup> meeting (Strasbourg, 8-9 September 2005), dealt principally with the modalities of the preparation of the Third Evaluation Round. This matter, including the Bureau's proposals regarding the mandate and composition of the two working parties, would be dealt with under Item 9 of the Agenda. Copies of the Bureau 31 report (Greco (2005) 17E Revised) were available.

# IV. Information provided by the Executive Secretary

- 5. The Executive Secretary reported on the following developments since GRECO's 24th Plenary Meeting (June-July 2005):
  - Ms Lioubov SAMOKHINA had left GRECO's Secretariat to take up a permanent post elsewhere in the Organisation. She had been replaced by Ms Tania VAN DIJK, previously Senior Policy Officer at the Ministry of Justice of the Netherlands, where she had dealt, *inter alia*, with the financing of terrorism and money laundering. Ms Van Dijk had also acted as an Evaluator for the Second Round Evaluation of Ireland;
  - GRECO would face some budgetary problems in 2006. One way in which they would be addressed would be the adoption, as of December 2005, of a "zero-document policy". This practice, which was not unusual for the Council of Europe, would mean that copies of working documents sent to delegations by e-mail prior to a Plenary Meeting, would not be available in the meeting room. It would be established as of GRECO 26 (5-9 December 2005). The Plenary was reminded that working documents for Plenary Meetings were now available, once issued, on the restricted part of GRECO's Website reserved for confidential documents;
  - GRECO had been represented at an Octopus Interface Conference on Combating Economic Crime (Portugal, 28-30 September 2005) by Mr Paul STEPHENSON (United Kingdom, member of the Bureau). Copies of his presentation (Greco Inf (2005) 12) which outlined GRECO's work, were available;
  - Ukraine had deposited its instrument of ratification of the Civil Law Convention on Corruption (ETS 174) and as a result, would become GRECO's 40<sup>th</sup> member on 1 January 2006, date of the entry into force of the Convention in respect of that country. This 40<sup>th</sup> accession would constitute an opportunity for a media event at which journalists could be briefed on GRECO's work;
  - the Minister of Justice of Canada had informed the Secretary General of the Council of Europe that Canada intended to ratify both the Criminal and Civil Law

Conventions on Corruption (ETS 173 and 174). Apparently, no time schedule had yet been established to this effect;

- Italy had expressed its intention to join GRECO and the Executive Secretary had been invited to a Transparency International conference (Rome, 22 November 2005) intended, *inter alia*, to promote Italy's accession to GRECO;
- during the October session of the Parliamentary Assembly of the Council of Europe (PACE), the Secretariat had met with Senator Sadot SANCHEZ, Chair of the Committee on Human Rights of the Mexican Senate. The Mexican delegation to PACE was very interested in GRECO's work and he wished to organise a conference on matters related to the fight against corruption during the second half of 2006. An exchange of views between the Mexican delegation to the PACE and representatives of GRECO's Bureau might be arranged in the margins of the January session of the PACE (23-26 January 2006);
- the May EU Russia Summit during which a "Roadmap for the common space of freedom, security and justice" had been prepared which included a recommendation to the Russian Federation to ratify the United Nations Convention against Corruption (UNCAC) and both the Council of Europe Civil and Criminal Law Conventions on Corruption;
- since GRECO 25, the Criminal Law Convention on Corruption (ETS 173) had been ratified by Luxembourg, bringing the total number of ratifications to 31; the Civil Law Convention on Corruption (ETS 174) by Ukraine, bringing the total number of ratifications to 25; and the Additional Protocol to the Criminal Law Convention on Corruption (ETS 191) by Ireland and Luxembourg, bringing the total number of ratifications to 11;
- the UNCAC would enter into force on 14 December 2005. Four Council of Europe member States (Croatia, France, Hungary and Romania) were among the 33 which had ratified the convention and the European Commission had signed it. The first Conference of States Parties would be held in October/November 2006;
- his participation with GRECO's President in the fourth and last meeting of the Transparency International (TI) Study Group on a follow-up monitoring process for the UNCAC (Berlin, 23-24 September 2005). UNODC involvement in this TI initiative had grown. OECD, DFID (Department for International Development, United Kingdom), SPAI and various TI chapters were also represented. All TI chapters would be consulted on the document the group is preparing on possible UNCAC monitoring processes. It should be available in June 2006 and would be submitted to the first meeting of the Conference of States Parties in October/November 2006. It would present a number of possible monitoring models, including:
- periodic self-reporting of Parties to the UNCAC to the Conference of States Parties and plenary discussions;
- a chamber system, ie clusters of countries monitoring each other;
- contracting out to existing regional mechanisms (GRECO, OAS, etc);
- a separate UN mechanism;
- the intention of the FATF to set up a working party on the relationship between anti-money laundering issues and corruption. The FATF Secretariat had been informed in writing of GRECO's current work on the issue;

- an International Chamber of Commerce (ICC) initiative to prompt further OECD work in the field of private sector bribery, possibly by supplementing the revised 1997 recommendation with a clear prohibition of private sector bribery;
- copies of an International Chamber of Commerce Policy Statement on the UNCAC (Greco Inf (2005) 10) addressing the need for follow-up monitoring and a reply letter from the European Commission (Greco Inf (2005) 11) were available. The setting up of a separate EU anti-corruption monitoring and evaluation mechanism was apparently still on the European Commission's agenda.

# V. Second Round Evaluation procedure

<u>Draft Evaluation Reports on "the former Yugoslav Republic of Macedonia", the Netherlands and Romania</u>

- 6. GRECO examined the draft (P3) Second Round Evaluation Report on <u>"the former</u> Yugoslav Republic of Macedonia".
- 7. Members of the Evaluation Team (cf. list of participants) made introductory presentations. Representatives of the country presented their authorities' comments, which were followed by a first reading of the draft report (paragraph by paragraph).
- 8. Following a second reading, GRECO adopted the Second Round Evaluation Report on "the former Yugoslav Republic of Macedonia" (Greco Eval II Rep (2004) 11E).
- 9. GRECO invited the authorities of "the former Yugoslav Republic of Macedonia" to authorise, as soon as possible, the publication of this report.
- 10. GRECO examined the draft (P3) Second Round Evaluation Report on the Netherlands.
- 11. A member of the Evaluation Team made an introductory presentation. Representatives of the country presented their authorities' comments, which were followed by a first reading of the draft report (paragraph by paragraph).
- 12. Following a second reading, GRECO adopted the Second Round Evaluation Report on the Netherlands (Greco Eval II Rep (2005) 2E).
- 13. GRECO invited the authorities of the Netherlands to authorise, as soon as possible, the publication of this report.
- 14. GRECO examined the draft (P3) Second Round Evaluation Report on Romania.
- 15. Members of the Evaluation Team made introductory presentations. Representatives of the country presented their authorities' comments, which were followed by a first reading of the draft report (paragraph by paragraph).
- 16. Following a second reading, GRECO adopted the Second Round Evaluation Report on Romania (Greco Eval II Rep (2005) 1E).
- 17. GRECO noted with satisfaction that Romania authorised publication of this report.

### VI. Procedure under Rule 32, paragraph 2 of the Rules of Procedure

18. GRECO adopted the Overall Assessment of Information provided by the Delegation of Georgia, pursuant to Rule 32, paragraph 2, al. (i) of its Rules of Procedure, (Greco Eval I (2004) 4E Revised) which had been prepared by its Special Rapporteur, Ákos KARA (Hungary). The conclusions of the overall assessment required the submission of additional information to the Executive Secretary by 31 January 2006. The information provided would be examined by GRECO at its 27<sup>th</sup> Plenary Meeting.

# **VII.** First Round Compliance procedure

<u>Draft Addenda to the First Round Compliance Reports on Estonia, Ireland and the Slovak Republic</u>

- 19. GRECO examined the draft Addendum to the First Round Compliance Report on Estonia. It was based on information provided by the authorities of the country as required by the conclusions of GRECO's First Round Compliance Report. GRECO adopted the Addendum (Greco RC-I (2003) 6E Addendum) and thus terminated the First Round compliance procedure in respect of Estonia.
- 20. GRECO invited the authorities of Estonia to authorise, as soon as possible, the publication of this Addendum<sup>1</sup>.
- 21. GRECO examined the draft Addendum to the First Round Compliance Report on Ireland. It was based on information provided by the authorities of the country as required by the conclusions of GRECO's First Round Compliance Report. GRECO adopted the Addendum (Greco RC-I (2003) 14E Addendum) and thus terminated the First Round compliance procedure in respect of Ireland.
- 22. GRECO invited the authorities of Ireland to authorise, as soon as possible, the publication of this Addendum.
- 23. GRECO examined the draft Addendum to the First Round Compliance Report on the Slovak Republic. It was based on information provided by the authorities of the country as required by the conclusions of GRECO's First Round Compliance Report. GRECO adopted the Addendum (Greco RC-I (2003) 2E Addendum) and thus terminated the First Round compliance procedure in respect of the Slovak Republic.
- 24. GRECO invited the authorities of the Slovak Republic to authorise, as soon as possible, the publication of this Addendum.
- 25. Pursuant to decision 19 of GRECO 24, the Slovenian delegation provided up-dated information on the proposed dismantling of the Slovenian Commission for the Prevention of Corruption. GRECO reiterated the relevance of this matter with regard to the implementation of GRECO's First Round recommendation viii to Slovenia and invited the Slovenian delegation to provide a further update at GRECO 26.

#### VIII. Third Evaluation Round

26. It was recalled that GRECO 24 had adopted a document on the content and preparation of the Third Evaluation Round (Greco (2005) 10E Revised 2). Bureau 31 submitted its proposals to the present Plenary on draft Terms of Reference for

the two working parties to assist GRECO with the preparation of the Third Evaluation Round (Greco (2005) 15E Revised) and on their composition (cf. Greco (2005) 17E Revised).

- 27. GRECO adopted the Terms of Reference of working parties **WP-ETS 173 on the** incriminations provided for by the Criminal Law Convention on Corruption (ETS 173) and **WP-PF on the transparency of party funding** (Greco (2005) 15E Revised 2), having decided that the draft questionnaires to be prepared by the working parties should be focused and clearly set out the information required from respondents. "Toolkits" for the two evaluation topics would need to be submitted to the Bureau no later than 30<sup>th</sup> June 2006 and adopted by the Plenary as early as possible in the second half of 2006 so that evaluation visits could already take place in the first half of 2007.
- 28. The Plenary debated at length the criteria to be borne in mind in the composition of WP-ETS 173 and WP-PF. The Bureau was asked to re-examine its proposals in the light of the debate and to submit revised proposals to GRECO 26 for adoption. It may also need to reflect on how a decision could be reached if a vote on this matter turned out to be unavoidable. It was noted that no country included in the Bureau's proposal chose to withdraw and that GRECO's tight draft budget for 2006 would not allow to cover the participation of a total of more than 12 members in the two working parties.
- 29. Regarding more particularly the composition of the two working parties as suggested by the Bureau (cf. Greco (2005) 17E Revised), it was felt necessary to include a common law jurisdiction in WP-ETS 173; if need be, that member could possibly be associated with the working party (for example, consulted in writing on relevant issues without "physically" participating in WP-ETS 173 meetings). Ireland was indicated as a possible candidate country. It was also suggested that Azerbaijan and Romania be included in WP-PF, in order to achieve a better geographical representation. Doubts were expressed as to the necessity of including more than one Bureau member in each working party.
- 30. The role of the scientific expert in WP-PF, as proposed by the Bureau, was clarified. The task of the expert would be to advise the working party and to draw on extensive, comparative expertise in the field of party funding, including as regards relevant Council of Europe work in this area. It was generally felt that WP-PF would benefit from the presence within the group of such a scientific expert. The Executive Secretary stressed in this connection that it would not be feasible to associate the proposed scientific expert with the working party (ie. through written consultation).
- 31. In order to provide the Bureau with more complete and relevant information upon which to base a revised proposal, the Delegations of Germany, Greece, Ireland and Lithuania were invited to provide the name and further relevant particulars of one expert each to be considered for participation in WP-ETS 173; the Delegations of Azerbaijan, France, Poland and Romania were invited to provide the name and further relevant particulars of one expert each to be considered for participation in WP-PF.

#### IX. Budget 2006

32. The Executive Secretary recalled that GRECO's draft Budgetary Proposals for 2006 (Greco (2005) 14E) had been approved by the Secretary General. Subsequently, they had been approved by the Budget Committee. The draft Budget for 2006, would be submitted to GRECO's Statutory Committee for adoption on 28

- November 2005. The draft Budget would already take account of Ukraine's accession to GRECO on 1 January 2006.
- 33. Budgetary constraints meant that the proposed budget left very little room for manoeuvre. Notably, it would not cover the cost of a start-up workshop to train Third Round Evaluators, nor would it be possible to finance interpretation for meetings of working parties WP-ETS 173 and WP-PF.

# X. Adoption of decisions

34. GRECO adopted the decisions of the 25<sup>th</sup> Plenary Meeting, as they appear in Greco (2005) 18E.

# XI. Dates of forthcoming meetings

35. GRECO's 26<sup>th</sup> Plenary Meeting would be held in Strasbourg on 5-9 December 2005. GRECO noted that its Bureau would next meet in Strasbourg on 7-8 November 2005.
