26th GRECO Plenary Meeting (Strasbourg, 5-9 December 2005)

DECISIONS

At its 26th Plenary Meeting (Strasbourg, 5-9 December 2005), the Group of States against Corruption (GRECO):

adopted the agenda (Greco (2005) OJ26);

Information by the President

2. took note of the information provided by the President, as detailed in the Summary Report of the meeting (Greco (2005) 23E);

Information by the Executive Secretary

3. took note of the information provided by the Executive Secretary as detailed in the Summary Report of the meeting (Greco (2005) 23E);

Second Evaluation Round

- 4. adopted, following two readings, the Second Round Evaluation Report on Greece (Greco Eval II Rep (2005) 6E);
- 5. adopted, following two readings, the Second Round Evaluation Report on Croatia (Greco Eval II Rep (2005) 4E);
- 6. adopted, following two readings, the Second Round Evaluation Report on Ireland (Greco Eval II Rep (2005) 9E);
- 7. noted with satisfaction that the authorities of Greece and Croatia authorise publication of the reports mentioned in decisions 4 and 5 above;
- 8. invited the authorities of Ireland to authorise, as soon as possible, the publication of the report mentioned in decision 6 above;

First Round Compliance Procedure

- 9. adopted the First Round Compliance Report on Moldova (Greco RC-I (2005) 4E);
- 10. invited the authorities of Moldova to authorise, as soon as possible, the publication of the report mentioned in decision 9 above;
- 11. adopted the Addendum to the First Round Compliance Report on Cyprus (Greco RC-I (2003) 13E Addendum) and thus terminated the first round compliance procedure in respect of that country;
- 12. adopted the Addendum to the First Round Compliance Report on Iceland (Greco RC-I (2003) 9E Addendum) and thus terminated the first round compliance procedure in respect of that country;
- 13. adopted an Addendum to the First Round Compliance Report on Slovenia (Greco RC-I (2003) 1E Addendum) and invited the delegation of Slovenia to submit to the Executive Secretary, by 1 March 2006, the additional information requested in the Conclusion of the Addendum;
- 14. noted with satisfaction that the authorities of Iceland authorise publication of the Addendum mentioned in decision 12 above;
- 15. invited the authorities of Cyprus and Slovenia to authorise, as soon as possible, the publication of the Addenda mentioned in decisions 11 and 13 above;

Second Round Compliance Procedure

- approved the list of rapporteurs on Second Round Compliance Reports (GRECO Eval II (2005) 7E);
- 17. agreed that, for financial reasons, only representatives who would take part in the plenary meeting concerned would be appointed as rapporteurs; however, if it was necessary to appoint an evaluator (or a second member of a delegation) to act as rapporteur, participation expenses would be borne by his/her authorities;

- 21. took note that, in accordance with Rule 5, paragraph 3 and Rule 9, paragraph 2 of GRECO's Rules of Procedure, the terms of office of the President and Vice-President as well as of the other members of the Bureau will be extended to the end of the Second Evaluation Round;
