27th GRECO Plenary Meeting (Strasbourg, 6-10 March 2006)

DECISIONS

At its 27th Plenary Meeting (Strasbourg, 6-10 March 2006), the Group of States against Corruption (GRECO):

adopted the agenda (Greco (2006) OJ27);

Information by the President

2. took note of the information provided by the President, as detailed in the Summary Report of the meeting (Greco (2006) 5E);

Information by the Executive Secretary

3. took note of the information provided by the Executive Secretary as detailed in the Summary Report of the meeting (Greco (2006) 5E);

Joint First and Second Evaluation Rounds

- 4. adopted, following two readings, the Joint First and Second Round Evaluation Report on Armenia (Greco Eval I-II Rep (2005) 2E);
- 5. adopted, following two readings, the Joint First and Second Round Evaluation Report on Turkey (Greco Eval I-II Rep (2005) 3E);
- 6. noted with satisfaction that the authorities of Armenia authorise publication of the report mentioned in decision 4 above;
- 7. invited the authorities of Turkey to authorise, as soon as possible, the publication of the report mentioned in decision 5 above;
- 8. approved the composition of the Evaluation Team in charge of the Joint First and Second Round Evaluation of Andorra (Greco Eval II (2003) 1bil of 3 March 2006);

Second Evaluation Round

- 9. adopted, following two readings, the Second Round Evaluation Report on Cyprus (Greco Eval II Rep (2005) 3E);
- adopted, following two readings, the Second Round Evaluation Report on Hungary (Greco Eval II Rep (2005) 5E);
- invited the authorities of Cyprus and Hungary to authorise, as soon as possible, the publication of the reports mentioned in decisions 9 and 10 above;

First Round Compliance Procedure

- adopted the Second Addendum to the First Round Compliance Report on Slovenia (Greco RC-I (2003) 1E Addendum II Revised 2) and thus terminated the first round compliance procedure in respect of that country;
- 13. invited the authorities of Slovenia to authorise, as soon as possible, the publication of the Second Addendum mentioned in decision 12 above;

- took note of the information provided by the authorities of Georgia regarding the implementation of First Round recommendations i, iv, xv, xx, xxi, xxiii and xxiv (pursuant to Rule 32, paragraph 2, al. (i) of GRECO's Rules of Procedure and Decisions 9 and 10 of GRECO 25);
- 15. expressed disappointment about the lack of progress reported by the Georgian authorities in implementing GRECO's First Round recommendations and, in particular, about the fact that the detailed Draft Action Plan with clear deadlines and agencies responsible for its implementation had still not been formally adopted;
- requested the Head of Delegation of Georgia to submit additional information regarding the implementation of recommendations i, iv, xv, xxiii and xxiv to the Executive Secretary by 31 March 2006;
- 17. asked its President to send a letter, with a copy to the President of the Statutory Committee, to the Head of Delegation of Georgia, drawing attention to the non-compliance with the relevant recommendations, in conformity with Rule 32, paragraph 2, al. (ii) of GRECO's Rules of Procedure;

Sixth General Activity Report (2005)

18. adopted its Sixth General Activity Report (2005) (Greco (2006) 1E Final) and instructed the Secretariat to forward it to GRECO's Statutory Committee and to the Committee of Ministers of the Council of Europe, in accordance with Article 8, paragraph 1, iii of the Statute;

- 20. noted that Working parties WP-ETS 173 and WP-PF will hold their first meetings in Strasbourg on 21-22 March 2006;
