**44<sup>th</sup> Plenary Meeting of GRECO**  
(Strasbourg, 6 – 8 October 2009)

**SUMMARY REPORT**

## **I. Opening of the Plenary Meeting**

1. The 44th Plenary Meeting of GRECO was chaired by Mr Marin MRČELA (Vice-President of GRECO, Croatia). Mr Richard ROGERS (Bureau member, United States of America) took the chair during the examination of the draft Addendum to the Second Round Compliance Report on Croatia.
2. The Vice-President opened the meeting by welcoming all representatives, referring in particular to those who had been newly nominated. The list of participants appears in [Appendix I](#) to this report.

## **II. Adoption of the agenda**

3. The agenda was adopted as it appears in [Appendix II](#) to this report.

## **III. Information provided by the President, Delegations and the Executive Secretary**

4. The **Vice-President** conveyed the President's apologies for his absence. He went on to congratulate all those involved in GRECO's 10<sup>th</sup> Anniversary Conference which had been held the day before and had been a highly successful event, gathering a significant number of high-level representatives from member States, international organisations and civil society as well as independent experts. A compendium of texts submitted by speakers and panellists as well as the conclusions presented by the Executive Secretary would be published.
5. He also outlined the discussions held and results of Bureau 50 (22 September 2009), asking participants to refer to the report of the meeting for further details (Greco (2009) 18E):
  - the President had informed the Bureau of his meeting with representatives of Serbia in August, during which he provided them with practical advice for the work of the recently established anti-corruption agency and he and Christophe SPECKBACHER (Secretariat) had participated as speakers in a roundtable on "Public Funding of Political Parties and Abuse of State Resources" (Athens, 17-18 September 2009) organised by the OSCE, representatives of which had expressed an interest in cooperating with GRECO and had been invited to make a written request to that effect;
  - as follow-up to the GRECO 43 (July 2009) decision stressing "the need for enhanced cooperation between GRECO and the relevant institutions of the European Union, with a view to avoiding duplication and promoting synergies", the Bureau had held a first exchange of views on the possible modalities of such cooperation, to be further discussed at its next meeting (Bureau 51, 2 November 2009); in response to questions from the floor as to how to ensure appropriate political support in this context, the Executive Secretary reminded the plenary of the Memorandum of Understanding between the Council of Europe and the European Union, which had been developed at the highest political level within both structures and provided the basis for closer cooperation. GRECO's various exchanges with the relevant EU institutions – which would be continued – were aimed at developing ideas for the practical modalities of such efforts;
  - an exchange of views had been held with representatives of EUROJUST on enhanced cooperation between both bodies which the Bureau felt would be of reciprocal interest, including in connection with GRECO's Fourth Evaluation Round. The Secretariat had been asked to pursue discussions with the competent services of EUROJUST in order to identify concrete modalities for institutionalised and regular exchanges;

- the Bureau had also continued its preliminary consideration of possible themes for the Fourth Evaluation Round and aimed to submit coherent proposals to the plenary for discussion as early as possible in order to allow ample time to the plenary to reach a decision. The Executive Secretary added that it was hoped proposals could be submitted to GRECO maybe even in December, in view of a first discussion at the first 2010 plenary meeting, at the very latest.

6. The **Executive Secretary** reported on the following developments since GRECO's 43<sup>rd</sup> Plenary Meeting (June-July 2009) :

- Belarus would almost certainly soon become a member of GRECO as the agreement concerning immunities and privileges of GRECO representatives and evaluators had been approved by the Committee of Ministers of the Council of Europe, signature by both parties was now pending; another potential candidate was Kazakhstan which had made a formal request to the Committee of Ministers to be invited to become a party to various Council of Europe conventions, including the Civil and Criminal Law Conventions on Corruption (ETS 174 and 173), the appropriate consultation process among non-member States parties to the conventions needed now to be completed; in addition a similar agreement to that established between the Council of Europe and Belarus would also have to be concluded; moreover, Liechtenstein appeared to be considering acceding to GRECO;

- the President would participate in a roundtable to launch the OECD Global awareness raising campaign on foreign bribery (Paris on 9 December);

- the Executive Secretary had been invited, along with representatives of other bodies such as the OECD working group, to Beirut to inform a group of Arab States on the practicalities of GRECO's *modus operandi* to assist them in the preparation of the next Conference of the States Parties to the United Nations Convention against Corruption (Doha, Qatar, 9-13 November 2009);

- copies of a document prepared by the Parliamentary Assembly of the Council of Europe on the protection of "whistle-blowers" were available, it called on member States to adjust their legislation to a set of guiding principles.

7. The floor was handed to delegations. The representative of **France** had recently participated in a conference in Kazakhstan and was pleased to report that he had observed a very strong intention on the part of the authorities of Kazakhstan to engage in serious efforts to fight corruption. A cooperation agreement between the Central Service for the Prevention of Corruption of France and its counterpart in Kazakhstan would be signed that very day.

#### **IV. Third Evaluation Round**

8. The plenary carried out an in-depth reading, principally of the analytical parts of the draft Third Round Evaluation Report on **Malta**, with the participation of the Evaluation Team which had carried out an on-site visit to Valetta. Before adoption, the report underwent a second reading of a draft which had been revised in the light of the discussions held during the first reading.

9. GRECO adopted the Third Round Evaluation Report on Malta (Greco Eval III Rep (2009) 2E - Themes I and II). The authorities of Malta were invited to authorise publication of the report as soon as possible<sup>1</sup>. The deadline fixed for submission

of a Situation Report on implementation of the recommendations contained in the report was 30 April 2011.

10. The plenary noted that, in accordance with the chronology followed during the Second Evaluation Round, Third Round Evaluation visits to Romania, Cyprus, Armenia, Serbia, Montenegro, the Czech Republic, Portugal, Bosnia and Herzegovina, the United States of America, Azerbaijan, Moldova and Andorra would be scheduled in 2010 and that the Secretariat would contact the members concerned individually with regard to deadlines for submitting replies to the questionnaires and the dates of the visits in such a way as to ensure an even and timely distribution of evaluation work throughout the year and between the plenary meetings.
11. The plenary approved the list of rapporteur countries for Third Round Compliance Procedures regarding Finland, the Slovak Republic, Slovenia and the United Kingdom (Greco Eval III (2009) 10E).

#### **V. Second Evaluation Round**

12. The plenary examined the draft Addenda to the Second Round Compliance Reports on **Albania, Croatia, the Netherlands, Spain** and **"the former Yugoslav Republic of Macedonia"**. The drafts were based on information provided by the authorities of the countries concerned as required by the conclusions of GRECO's Second Round Compliance Reports. Following a detailed reading, GRECO adopted the Addenda to the Second Round Compliance Reports on Albania (Greco RC-II (2007) 12E Addendum), Croatia (Greco RC-II (2007) 13E Addendum), the Netherlands (Greco RC-II (2007) 7E Addendum), Spain (Greco RC-II (2007) 10E Addendum) and "the former Yugoslav Republic of Macedonia" (Greco RC-II (2007) 8E Addendum) and thus concluded the Second Round compliance procedure in respect of all five countries. GRECO noted with satisfaction the authorisation from Croatia to publish the above-mentioned Addendum and the authorities of Albania, the Netherlands<sup>2</sup>, Spain and "the former Yugoslav Republic of Macedonia" were invited to do so as soon as possible.

#### **VI. Tour de table – Corruption in Sport**

13. GRECO held a *tour de table* on Corruption in Sport, with the participation of Mr Wolfgang MAENNIG, Professor, Chair of Economic Policy, Hamburg University as keynote speaker and of Mr Stanislas FROSSARD, Executive Secretary of the Enlarged Partial Agreement on Sport (EPAS) of the Council of Europe. EPAS would hold a first meeting, on 2 December, of its a working group to examine the preparation of a draft recommendation on corruption in sport, in which GRECO participation would be welcome and would, in any case, up-date GRECO on progress made. The Secretariat was asked to prepare and publish a summary record of the presentations and ensuing discussions.

#### **VII. Miscellaneous**

14. Following a call from the floor, the plenary discussed reiterating to the forthcoming session of the Conference of States Parties to the United Nations Convention against Corruption (Doha, Qatar, 9-13 November 2009) its previous communications, and agreed to address the following message to the Conference:

"On 5 October 2009 the Strasbourg-based Council of Europe's Group of States against Corruption (GRECO) celebrated its 10<sup>th</sup> Anniversary with a High-level

Conference which brought together a large number of Ministers and Secretaries of State as well as other representatives from 46 member States, several non-member States and international organisations, including the United Nations, and representatives of civil society.

Throughout its ten years of existence GRECO has monitored, on the basis of its peer review methodology, the compliance of member states with six Council of Europe anti-corruption instruments, including the Criminal Law Convention on Corruption (ETS 173) of 1999, issued tailor-made recommendations and subsequently assessed the implementation of these recommendations in practice.

The achievements of GRECO and its member States over the last decade evidence, as highlighted by numerous speakers at the Conference, that international norms are at risk of remaining dead letters if they are not backed up by a credible review mechanism and process.

In light of its broad monitoring experience the Group of States against Corruption encourages the States Parties to the United Nations Convention against Corruption to complement this universal instrument with an effective review mechanism, while avoiding duplication.

Only then will it be possible to address corruption which is a threat to the whole international community in an effective manner.

The Group of States against Corruption confirms its willingness to offer its long-standing expertise and knowledge and to support the implementation of the United Nations Convention against Corruption to the extent possible."

#### **VIII. Adoption of decisions**

15. The decisions of the 44<sup>th</sup> Plenary Meeting were adopted, as they appear in document Greco (2009) 19E.

#### **IX. Forthcoming meetings**

16. GRECO noted that the Bureau would hold its 51st meeting in Strasbourg on 2 November 2009. The 45<sup>th</sup> Plenary Meeting would be held in Strasbourg on 30 November – 4 December 2009.
