- 1. Research across the country on "Ethical code of conduct for civil servants"
  - Report was prepared about research
- Suggestions and recommendations have been notified about ethical codes
- According to recommendations "Ethic commission" was formed as a separated department and number limit of commission has been increased
  - Mechanism on researching of ethic complaints was formed

# Implemented events on fight against corruption in Baku in 2012:

- 2. Good practices on e-government
  - Presidential decreen on establishing e-govermental services was signed in 2007
- ASAN service is an agency of the Azerbaijani government which provides a variety of public services of Azerbaijan. "ASAN service" centers carry out 30 groups of legal services rendered by 10 state entities.
- 3. Training for trainers on "Application of ethical conduct code in civil service field" (16-17 October, 2012, Hyatt Regency Hotel):
  - Topic of training: "Ethics training on example of Turkey"
- **Goal of training:** creation of public discussion condition, providing of complying to ethic conduct codes by high level officials, increasing of participants' knowledge on application of ethical legislation
- **Participants:** 65 civil servants from central executives powers and districts' executive powers of Baku
- Tilman Hop, expert of European Council and Serhan Alamdar, representative in Ankara Office of European Council delivered presentations on international practice and ethical dilemmas on ethic rules, solutions of these dilemmas, proper behavior, ethic principles which civil servant must comply etc. topics.
