EXECUTIVE SUMMARY

This report provides an overview of progress in implementation of the project "Strengthening the Coordination of Anti-Corruption Policies and Practices in Turkey" (TYSAP) for the period of 29 December 2013 to 30 June 2014.

During the reporting period several important activities have been delivered, which include preparation of three Technical Papers, development of draft Investigation Guide for Inspectors, finalisation of Reporting Standards, completion of 3 workshops and 8 working group meetings. In the first 6 months of 2014, 10 actions have been completed. In total, since the start of the project implementation, 20 actions out of 31, as planned in the revised Calendar of Activities, have already been implemented and 10 other initiated.

Project's 3rd Steering Committee Meeting took place on 4 June 2014 where the progress in implementation of activities was discussed and next 6-month calendar of activities agreed. Revisions to the Project Fiche, related to the removal of the LTA position and introduction of a new IT procurement component in the direct grant, was approved by the EU by end-March 2014. The amended Project Fiche was officially communicated to the CoE on 26 May 2014. The revised document was presented at the 3rd Steering Committee Meeting and it was agreed that the CoE would prepare the subsequent revision of the DoA and Budget for the Action by mid-July 2014.

Despite delays incurred during the first year of project implementation, some progress was achieved during the first half of 2014. The project has partially delivered Expected Result 1 (The current legislative framework covering investigations, information sharing, anticorruption strategies and coordination of investigations is analysed and compared with the requirements of international conventions. Based on the results, an investigation guide and reporting standards are developed) and Expected Result 2 (Data regarding investigations of corruption cases is gathered and analysed, and a corruption map of risky areas is produced). Minor progress was made towards meeting Expected Result 3 (Inspectors are trained on developing sector specific anti-corruption strategies, coordinating corruption investigations, modern investigation, reporting techniques, and information sharing).

3 ACTIVITIES AND ACHIEVEMENTS

3.1 Summary of Implemented Activities

Since the start of the project implementation, <u>twenty actions</u> out of thirty one, as planned in the revised Calendar of Activities, have already been implemented and <u>ten</u> initiated. During the reporting period 11 actions have been completed.

Key actions in the reporting period were:

- Completion of a joint workshop to: 1) Discuss Legislative and Organisational Framework regulating Investigations, Coordination and Information-Sharing (Action 1.3); 2) Present the draft Technical Paper on International Standards on Corruption Investigations (Action 2.1); and 3) Identify needs and topics to include in the Investigation Guide (Action 5.1);
- Preparation of two Technical Papers drafted by international STCs (TP on "The UK's Best Practices, Standards and Regulations on Corruption Investigation, Coordination and Information Sharing" and TP on "Corruption Audits in Public Administration: Germany") as supplementary case studies to the Technical Paper "Analysis of Legislative and Organizational Framework Regulating Investigations, their Coordination, Information-Sharing and the Implementation of the Framework";
- Preparation of the Technical Paper "Report on Analysis of National Legislative and Organisational Framework Regulating Corruption Inquiries, Coordination and Information Sharing: Evaluation of Practices and Recommendations";
- Preparation of the draft Technical Paper "Gap Analysis between Turkish System and CoE, OECD, and UN Conventions against Corruption" by a national STC;
- Completion of a joint workshop under Action 3.1 (on "Discussing Gap Analysis Report on Compliance of the Domestic Regulation with Council of Europe Criminal Law and Civil Law Conventions, OECD Convention on Combating Bribery of Foreign Officials and UN-Convention against Corruption (UNCAC)") and Action 4.2 (on "Brainstorm on Draft Policy Report and Discussing Possible Measures and Recommendations for Fulfilling Requirements of International Conventions");
- Preparation of a draft Investigation Guide by a team of national experts and Working Group members;
- Completion of a workshop with participation of international STCs to discuss draft Investigation Guide;
- Development of initial outlines of training programmes to be delivered at different EU/EU-Member state institutions under Activity 7 (Training inspectors on application of training package on use of investigation guide, reporting standards and investigation techniques), Activity 9 (Training inspectors on developing, implementing and monitoring anti-corruption strategies) and Activity 10 (Training PMIB inspectors on coordinating corruption investigations, modern investigation and reporting techniques, enhanced cooperation and information sharing);
- Identification of the EU-Member state institution where trainers from beneficiary institutions will be trained on application of the training package under Activity 7 (Training inspectors on application of training package on use of investigation guide, reporting standards and investigation techniques). Initiation of content and

logistical-related discussions with EU-Member state institutions that will host trainees;

- Identification of the EU-Member state institution where inspectors from beneficiary institutions will be trained on developing, implementing and monitoring anticorruption strategies under Activity 9 (Training inspectors on developing, implementing and monitoring anti-corruption strategies). Initiation of content and logistical-related discussions with EU-Member state institutions that will host trainees;
- Identification of the EU-Member state institution where PMIB inspectors will be trained on coordinating corruption investigations, enhanced cooperation and information-sharing among anti-corruption institutions under Activity 10 (Training PMIB inspectors on coordinating corruption investigations, modern investigation and reporting techniques, enhanced cooperation and information sharing). Initiation of content and logistical-related discussions with EU-Member state institutions that will host trainees.

Expected Result 1: The current legislative framework covering Investigations, Information-sharing, anti-corruption strategies and coordination of investigations is analysed and compared with the requirements of international Conventions. Based on the results, an investigation guide and reporting standards are developed.

Activity 1

The national legislative and organisational framework regulating administrative inquiries and criminal investigations, their coordination (i.e., with law enforcement agencies), information-sharing, intelligence and the implementation of the framework are analysed, reports and legislative proposals (if necessary) are prepared via working groups composed of academicians, public officials and other experts. The "Report on Analysis of National Legislative Framework Regulating Corruption Inquiries, Coordination and Information Sharing: Evaluation of Practices and Recommendations" established that the main legal-institutional bases of administrative inquiries and judicial investigations were well in place in Turkey and many of the coordination and information sharing challenges associated with corruption inquiries and investigations are to be attributed to reasons other than lack of appropriate rules and regulations, such as conjectural conditions, institutional incapacities, or individual failures. It was also noted that initiating new framework legislation (e.g., Law on Preventing, Prosecuting and Punishing Corruption) aiming at consolidating and synchronising provisions from different laws and regulations, which might help to strengthen the existing legal-institutional basis of coordination and information-sharing aspects of anticorruption inspections and investigations on state secrets and commercial confidentiality would help to improve transparency and accountability in the conduct of public affairs in the country. More active and effective involvement of the Prime Ministry's Inspection Board in coordinating and information- experience-sharing between different inspection boards in the public sector would contribute to the improvement of current conditions.

Other Activities and Important Developments

Revision of Project Fiche

Following agreements reached at the 2nd Steering Committee Meeting, which took place on 6 November 2013, revision of the Project Fiche was initiated by the PMIB. The CoE was consulted together with the CFCU and the EUD. The document was submitted to the Turkish Ministry of EU Affairs in December 2013 for circulation to the relevant authorities as required by the procedure and was officially approved by the EU at the end of March 2014. The revised Project Fiche excludes the position of the LTA, introduces an IT procurement component in the value of \in 50,000 of the Direct Grant section, and envisages an increase of costs for STCs, study visits and international trainings. The new Project Fiche was officially submitted to the CoE on 26 May 2014. Subsequent changes to the DoA and Budget for the Action are being prepared by the CoE and are expected to be submitted to the CFCU in the second half of July 2014.

3rd Steering Committee Meeting

Project's 3rd Steering Committee Meeting, attended by all the stakeholders, as well as two representatives from civil society organisations, was held on 4 June 2014. At the meeting, the progress in the implementation of the project was reviewed and the workplan and calendar of activities for the remaining 7 months was discussed and agreed. Revised Project Fiche was also presented, followed by an active discussion on modalities of implementation of the IT component and development of software for data collection. Subsequent revision of the DoA and Budget for the Action will take place during July-August 2014.

3.2 Achievements

This part of the report provides an overview of the progress made during the reporting period in light of achieving the expected results of the project.

From January to end of June 2014 the project has been progressing towards achieving its expected results.

Expected Result 1 (The current legislative framework covering investigations, information sharing, anti-corruption strategies and coordination of investigations is analysed and compared with the requirements of international conventions. Based on the results, an investigation guide and reporting standards are developed).

The drafting of a proposed information-sharing system, an analysis of the national legislative framework regulating administrative inquiries and criminal investigations, and of legislative proposals to improve current coordination and information sharing system have been were ongoing actively since January 2014. A national STC was recruited in late December 2013. Two Working Group meetings and a workshop were held and a draft Technical Paper "Report on Analysis of National Legislative Framework" was produced. The TP is being used for finalising the Investigation Guide and Reporting Standards, which are expected to be completed by the end of July 2014.

Good progress has been made in relation to having reviewed international/EU Standards on Corruption Investigations, Coordination and Information-sharing. A team of international experts produced three relevant Technical Papers covering the general framework in TP "Corruption Investigations by Inspection Bodies: International Standards on Investigations, Including Coordination and Information Sharing" and an overview of two specific country examples of the UK and Germany on corruption investigations by inspection bodies. A relevant workshop was held on 30 January 2014. These TPs have been used as guiding materials for the development of the Draft Investigation Guide.

The work on analysis of the compliance of domestic regulation with CoE Criminal Law Conventions, the OECD Convention on Bribery and the UN Convention against Corruption has been actively ongoing. Two working group meetings and a workshop were held, and two Technical Papers were drafted. One national and two international STCs have been working on compliance analysis and developing policy recommendations for fulfilling the requirements of international conventions. However, for the completion of the activity additional information, including texts of the relevant legislation are necessary. The STCs will complete their work once the beneficiaries will provide the remaining missing information.

Investigation Guide has been drafted. Seven Working Group meetings were held since January 2014 and the draft document was produced in the beginning of May 2014. The Draft Investigation Guide is currently being reviewed by international STCs. The relevant workshop to discuss the Draft Investigation Guide was held on 19 June 2014. Subsequent TPs with expert recommendations and comments shall be completed by the end of June 2014 and the Guide is expected to be finalised by the end of July 2014.

Also, a significant progress has been made in developing Reporting Standards for inspectors. The Draft Reporting Standards have been developed and are currently being finalised. Dissemination of the document can be expected by the end of July 2014.

There has been no progress on drafting a Training Strategy on the use of the Investigation Guide, however as the Guide is currently being finalised, the work on Training Strategy is expected to progress during July - August 2014.

Expected Result No. 2 (Data regarding investigations of corruption cases is gathered and analysed, and a corruption map of risky areas is produced).

Fulfilment of this Expected Result is related to identification of the required methodology and procedures for data collection, as well as creation of special software. Consequently the timing depends on the possible introduction of an IT component in the project DoA.

Currently, a National Consultant is being recruited to prepare a Technical Paper on the Methodology and Procedures for Data Collection.

Expected Result 3 (Inspectors are trained on developing sector specific anti-corruption strategies, coordinating corruption investigations, modern investigation, reporting techniques, and information sharing).

Progress has been made in relation to the identification of an EU-Member state institution where beneficiaries will be trained on developing, implementing, and monitoring anticorruption strategies. Initial outline of a training programme has been shared with the identified institution, which is the French Central Service for the Prevention of Corruption (SCPC). The training is likely to be held in October 2014, based on the availability of the host institution.

Similar progress has been made towards the fulfilment of the activity on training of PMIB inspectors on coordinating corruption investigations, modern investigation and reporting techniques, and enhanced cooperation and information-sharing among relevant EU-anticorruption bodies. The relevant EU-Member state institution to host the training was identified as UK's National Crime Agency and an initial outline training programme was shared with the institution representatives for review and feedback. The training dates are yet to be negotiated with the host institution. Given the slow response from the potential host institutions, certain delays can be expected in implementation of the relevant international training activities.

4 COOPERATION WITH OTHER STAKEHOLDERS

4.1 Counterpart and Beneficiaries

Communication with the beneficiaries on implementation of Workplan of activities has been constructive during the reporting period.

4.2 Other Third Parties

The project team has maintained good cooperation with the European Union Delegation and the Central Finance and Contracts Unit.

5 RISKS AND CONCLUSIONS

5.1 Risks

There is a potential risk of further delays in the project implementation. Any delay in providing legislative input required for the finalisation of the Gap Analysis and Policy Report will inevitably delay completion of Activities 3 (Compliance of domestic regulations with international conventions) and 4 (Preparation of policy report on fulfilling requirements of international conventions).

Lack of availability of experts and summer holiday period may delay completion of certain activities as scheduled in the Calendar of Activities.

Delays incurred in the finalisation of deliverables expected under Activities 3 (Compliance of domestic regulations with international conventions), 4 (Preparation of policy report on fulfilling requirements of international conventions), and 5 (Preparation and dissemination

of Investigation Guide) may cause further postponement of the delivery of Activity 7 (Drafting Training Strategy and training inspectors on collecting and analysing corruption related data), which will also depend on availability of experts identified at this stage.

Introduction of a new IT procurement component and its successful and timely implementation also poses a risk. The failure of the previous tenders, carried out by the contracting authority, to procure the IT software needed for the project has also factored into the risks for successful achievement of Activities 7 (Drafting Training Strategy and training inspectors on collecting and analysing corruption related data) and 8 (Preparation of maps of corruption prone areas and appropriate strategies to tackle those risks). Implementation of the new IT component was dependent on the amendment of the Project Fiche, which was completed by the end of March 2014. The document was officially communicated to the CoE in late May 2014. Subsequently, a change of the DoA and Budget is necessary for the introduction of a new IT component, and considering the lengthiness of procurement procedures, it is expected that a considerable time period will lapse until all the procedures are completed.

Implementation of international trainings envisaged in the project depends on the good will and availability of hosting institutions. Considering the slow response from the EU Member State institutions that have been identified as host agencies, delays might be anticipated in international training activities. However, as a mitigating measure, it has been envisaged that in the case of slow progress with some of the potential host institutions, international trainings will be held in the Headquarters of the CoE in Strasbourg, with the participation of experts from EU/EU Members state institutions.

5.2 Conclusions

Despite delays incurred during the first year of project implementation, considerable progress has been achieved during the first half of 2014 due to sound cooperation and dialogue between partner institutions. If no major delays are incurred and provided that risks identified in the above section do not interfere with project implementation, TYSAP project activities may be completed by the end of December 2014.

As of end June 2014, the project has only partially contributed to meeting Expected Result 1 (The current legislative framework covering investigations, information sharing, anticorruption strategies and coordination of investigations is analysed and compared with the requirements of international conventions. Based on the results, an investigation guide and reporting standards are developed) and Expected Result 2 (Data regarding investigations of corruption cases is gathered and analysed, and a corruption map of risky areas is produced). Minor progress has been made towards Expected Result 3 (Inspectors are trained on developing sector specific anti-corruption strategies, coordinating corruption investigations, modern investigation, reporting techniques, and information sharing).

It is too early to assess the impact of the project, but it is worthwhile underlining the contribution the project has made to enhance the dialogue and experience-sharing between the various inspection boards directly benefitting from the project.

Amendments to the Project Fiche have been approved by the EU in March 2014. The amended Project Fiche was officially communicated to the CoE on 26 May 2014. The DoA and Budget of the Project are expected to be revised in July 2014 in light of Project Fiche changes and will concern the introduction of a new IT procurement component and removal of the LTA position.

The next reporting period will coincide with the end of implementation of TYSAP. The final report is expected to assess overall achievements and deliverables obtained under all ten project activities, including the delivery of international trainings, which are due to fulfil the enhancement of inspectors', auditors', and controllers' expertise in modern investigation and reporting techniques, cooperation, data collection and analysis, information-sharing and developing sector specific anti-corruption strategies, while supporting the monitoring of the implementation of the National Anti-Corruption Strategy.

6 VISIBILITY

Project news and upcoming events are reported on the Council of Europe Economic Crime website (<u>www.coe.int/corruption</u>) under a section which is solely dedicated to the TYSAP project (<u>www.coe.int/tysap</u>). The website report on project activities and ongoing public events is updated on a regular basis. Furthermore, as the Council of Europe's main partner/counterpart in the TYSAP Project, the Prime Ministry Inspection Board has created the link to the project web address on its own webpage.

Until now, TYSAP has produced six Technical Papers and disseminated one Handbook on corruption risk analysis and sector-specific anti-corruption strategies.

The project ensures the visibility of the EU's contribution at all stages of its activities. All reporting, printing materials and information used and disseminated acknowledge that "This project is co-financed by the European Union and the Republic of Turkey", and display the bilateral cooperation logo combining the European Union-Republic of Turkey logo as per the agreed visibility rules.
