Aim	The aim of the presentation to the SCG is to ensure that all participating institutions are aware of the National Risk Assessment and that they understand their role and ensure participation of their representatives in the process.
Outcome	On 8 November 2011, MOLI project team gave a presentation on the National Risk Assessment to the Standing Coordination Group (SCG) for monitoring the implementation of the National Strategy against Money Laundering and Terrorist Financing. Mr Simon Goddard, Long-Term Consultant, explained how the process will be carried out and asked the members of the SCG for their full support in this complex task. Among other high state officials, two State Secretaries were present, Mr Miodrag Djidic (MoF) and Mr Dragan Markovic (MoI), as well as the Assistant Minister of Justice, Mr Slobodan Boskovic.
