Aim	To train up to ten analysts from APML and Ministry of Interior on strategic analysis with an emphasis on improving their reporting skills.
Outcome	From 2-6 April 2012, MOLI Serbia project organised a Study Visit to EUROPOL headquarters in the Hague and to the Belgian Federal Police in Brussels, in order to train eight analysts from APML and from the Ministry of Interior on strategic analysis reporting skills. The objective of the Study Visit is to expose Serbian analysts responsible for coordinating the National Risk Assessment to best practices in areas such as the Serious Organised Crime Threat Assessment (SOCTA) carried out in EUROPOL and the methodology used in Strategic Planning by Belgian Federal Police, who are considered leaders in this field. The delegation also visited the Belgian FIU and exchanged experiences in intelligence-gathering and analysis thereof.

Outcome	On 26 April 2012, the institutions involved in data collection for the purposes
	of carrying out the National Risk Assessment held a meeting at the Ministry of
	Finance to discuss progress and upcoming deadlines for data submission to
	the World Bank. The leaders of Working Groups, consisting of representatives
	from the APML, National Bank of Serbia and State Public Prosecutor's office
	showed a high level of dedication to the process. Mutual coordination of data
	collection was evident, under leadership of the APML and their NRA
	coordinator. Group leaders assessed their progress to date and asked others
	for assistance where necessary to obtain information from remaining state
	institutions involved.
Follow-up	The deadline for submission of data to the World Bank is 20 June 2012. The
	APML will present its progress to date at the next plenary session of
	MONEYVAL from 2-6 July 2012 in Strasbourg.

## OTHER PROJECT RELATED DEVELOPMENTS

On 5 April 2012, LPA attended the meeting of the Donors Group on Public Finance Management organised by the World Bank. ## PLANNED ACTIVITIES FOR THE NEXT PERIOD

- A public hearing will be organised on 22 May 2012 for obligors, NGOs and media representatives in order to include the private and public sectors in the drafting process.
- A two-day Workshop will be organised on 29-30 May 2012 in cooperation with the National Bank of Serbia on supervision of the insurance sector, pension funds and leasing companies.
- Between 11 and14 June 2012, a two-day Workshop will be organised on the risk of abuse of the NPOs sector for the purposes of AML/CFT in Serbia.

#### **CONCLUSIONS**

During the month of April 2012, MOLI Serbia activities mainly focused on delivering Activity 3.3.3. (Study visit for strategic analysts to EUROPOL and Belgian Federal Police) and continuation of Activity 2.3.1. (collection of data for the purposes of the National Risk Assessment). MOLI Serbia project continues without any major obstacles or delays.
