The event consisted of a short presentation by Ms Teodora Lukovic, Local Project Officer regarding the specifics of MOLI Serbia project. Mr Aleksandar Vujicic, Director of APML, spoke on successes and challenges in fighting money laundering in Serbia, and Mr Dragan Djokovic, Adviser to the Deputy Prime Minister, on the fight against corruption in Serbia. After the presentation the floor was opened for a discussion with the members of the press. Media representatives showed a
