## THE STEERING COMMITTEE<sup>1</sup> (SC) PROJECT AGAINST CORRUPTION IN ALBANIA – PACA

## I. <u>SC Membership/Participation</u>

The Steering Committee of PACA Project consists of the following institutions who have designated a permanent member to represent their institution during the life of Project Implementation:

- (1) Department of Internal Administrative Control and Anti-corruption (DIACA)-Main Counterpart
- (2) High inspectorate for Declaration and Assets and Audit (HIDAA)
- (3) Ministry of Education
- (4) Ministry of Interior
- (5) Ministry of Justice
- (6) General Prosecutor Office
- (7) High Council of Justice
- (8) Department for Money Laundering Prevention
- (9) EU Delegation to Albania
- (10) Council of Europe (PACA Team Members and HQ Management).

The Steering Committee meetings will also involve other relevant authorities related to project results and activities. The SC will be jointly chaired by the Project Director (as designated by Main Counterpart Institution, that is DIACA Director, and a Representative of the EC Delegation.

## II. <u>SC Responsibilities</u>

The Steering Committee of PACA project, will take strategic decisions and supervise the proper implementation of the project. The SC during its meetings and deliberations will address the major problems that the project might face. The responsibilities of the Steering Committee are the following:

- a) To make an assessment of emerging needs for sound project implementation;
- b) To approve the overall work plan and the annual work plans;
- c) Recommend strategies in the light of national anti-corruption priorities;
- d) To make recommendations on the translation of newly developed strategies into policy;
- e) To conduct reviews of project reports and other documentation;
- f) To conduct a final review of the implementation; and
- g) To recommend strategies for sustainability and follow up activities;
