



# THE ACTION PLAN OF THE CONFERENCE OF INGOS OF THE COUNCIL OF EUROPE

# 2018-2021

# Adopted by the Conference of INGOs on 29 June 2018

The Conference of INGOs has gradually earned recognition as a political body of the Council of Europe by consistently demonstrating its relevance and commitment to our Organisation's values and priorities. This Action Plan aims to reinforce the voice of civil society in the Council of Europe and sets out the main orientations and specific priorities of the Conference's work for the upcoming 3 years. A large part of the content comes from the roadmaps of the thematic committees and the terms of reference of the working groups. The Action Plan shows how the Conference of INGOs provides both a conceptual and an operational response to the Council of Europe's, and more specifically the Secretary General's priorities, and contributes to the protection of the Organisation's values which are being affected by current political and economic factors.

The Conference of INGOs is a collective body comprising all of the INGOs enjoying participatory status with the Council of Europe (CM/Resolution 2016(3)). On the basis of the Committee of Ministers' Resolution (2005)47, the Conference of INGOs acquired the status of a participant in the intergovernmental committees and their subordinate bodies on an equal basis with the other institutions of the Council of Europe.

### **Our Mission**

The Conference of INGOs is a civil society assembly whose aim is to represent European civil society as the institutional civil society pillar within the Organisation and to promote democracy, human rights and the rule of law through civil society in Europe, alongside the Secretary General, the Committee of Ministers, the Parliamentary Assembly, the Congress of Local and Regional Authorities the European Court of Human Rights and the Commissioner for Human Rights.

#### **Our Vision**

As a representative body, the Conference of INGOs constitutes an institutional connexion between the Council of Europe institutions and 800 million Europeans. Through the Conference of INGOs, the Council of Europe recognises a vibrant, pluralistic, and dynamic civil society to be an indispensable actor of the democratic system, aiming to safeguard a civic space, acting for open, diverse and inclusive societies and accountable governments.

### **Our priorities**

The priorities announced in the Action Plan are organised as follows:

- To protect and reinforce freedom of association and associated rights<sup>1</sup> and to contribute to the democratic security in Council of Europe member states
- 2. To observe and reinforce civil participation in the decision-making within the Council of Europe and in its member states
- 3. To contribute to building an inclusive society and protect access to education and to social, cultural and economic rights by vulnerable groups
- 4. Contribute to the blossoming of a modern European Cultural Identity
- 5. Continue to develop the institutional strengthening process of the Conference of INGOs to respond in a relevant way to the institutional evolution of the Council of Europe and geopolitical challenges.

Gender equality is central to fulfilling the Council of Europe's mission, and is therefore also a priority for the Conference of INGOs.

Three integrated approaches to these priorities are chosen:

- To reinforce gender equality mainstreaming in the work of the Conference of INGO with respect and implementation of the Strategy of Equality 2018-2023 of the CoE
- To integrate the youth perspective and reinforce youth participation in the work of the Conference of INGOs
- To integrate the migration and post-migration perspective (of the migrants and NGOs' which support them) in the work of the Conference of INGOs

The categories of stakeholders concerned by these actions are as follows: (I)NGOs, public institutions, public authorities and public officials, specific social groups, business sector.

All entities of the Conference of INGOs will conduct the actions to contribute to these priorities under guidance of the Bureau and Standing Committee whose roles are to ensure consistency and coherence of the whole Action Plan.

There is still essential that activities achieve the desired results and impacts within the Council of Europe and in its member states. With this in mind, the Conference of INGOs, must be simultaneously close to the grassroots organisations, works for a general interest of civil society and be involved in the high-level decision-making process in the Council of Europe and other international organisations.

### **Our Working Methods**

The Standing Committee is the management body of the Conference of INGOs, composed of the directly elected voluntary members of the Conference of INGOs. The INGOs with participatory status, the invited NGOs and experts, contribute on a voluntary basis to the work of the thematic committees through their working groups, to the debates, side events, the country visits and other activities led by the Conference of INGOs. Among its working methods are the twice yearly sessions which include debates with Council of Europe personalities and institutions.

This Action Plan is supplemented by the Roadmaps of the thematic committees <u>Human Rights Committee</u> <u>Democracy, Social Cohesion and Global Challenges Committee</u> <u>Education and Culture Committee</u> <u>Road map for youth participation (2018-2021)</u>

More specific documents can be developed by the Conference of INGOs bodies in order to precise the expected results and impacts of the actions mentioned in the Action Plan.
