### **Examination of the national reports for Conclusions 2017 of the Charter and Conclusions XXI-2 (2017) of the 1961 Charter**

The Committee is in the course of examining country reports submitted for the current reporting cycle covering Charter provisions relating to “Health, social security and social protection”.

Examination of the situation as regards Hungary, “the Former Yugoslav Republic of Macedonia”, Italy, Serbia, Ukraine, the Republic of Moldova, Turkey, Armenia.

### **Procedure on non-accepted provisions of the Charter (Implementation of Article 22 of the 1961 European Social Charter)**
