## APPENDIX I

#### The CDPC:

#### 4. Activities related to transnational organised crime (TOC): Action Plan

- took note of the information on sub-item 4. b. below, in particular:

#### b. Status of implementation of the Action Plan on TOC

1) **Key area 1** (Enhancing international co-operation through networks):

- <u>Action A2</u> ("Discuss the setting up and use of secure communications for international cooperation"): that Mr Per Hedvall (prosecutor, former Chair of the PC-OC, Sweden) has been appointed as an expert and will be asked to prepare a report on existing initiatives concerning secure communications by Interpol (e-extradition) and the EU (E-codex). His report will be presented to the PC-OC plenary in 2018;
- <u>Action A3</u> ("Build-up the connection of judicial networks"): that Ms Esther George (Solicitor, former Crown Prosecutor, United Kingdom) has been requested to draft a working paper identifying a list of international judicial networks of relevance for the fight against TOC, describing their functions and working methods;
- <u>Action A4</u> ("Establish a mechanism to address judicial co-operation problems), that the PC-OC considered the Action plan's proposal to increase judicial co-operation and to reduce issues arising with non-co-operative States, by the introduction, in the different treaties concerned, of a binding rule for requested countries to send a confirmation of receipt of requests for co-operation and to establish a duty of consultation between the requested and the requesting authorities;
- Action B1 ("Review provisions on international co-operation in CoE conventions and relevant reservations/declarations to them/these conventions"): that the PC-OC Mod identified those reservations and declarations that create obstacles to efficient co-operation, including as regards the fight against TOC. It decided to create three working groups, each devoted to a group of treaties, which would share their work in written consultation under the guidance of a co-ordinator. Each group would be tasked with identifying such reservations or declarations and contact the Parties concerned to see whether any update or withdrawal of these reservations or declarations would be possible. The working groups produced, in respect of each State Party, an agreed list of reservations and/or declarations identified as potentially out-dated and/or creating obstacles for efficient co-operation in the treaty concerned;
- Action B3 ("Development/elaboration and support of model request forms"): that the PC-OC considered the possibility of developing a model request form for extradition requests and agreed that this could be envisaged at a later stage;

2) Key area 5 (Recovery of assets):

Action B1 ("Enhancing the implementation of the existing legal network on the management and disposal of criminal assets"): that the PC-OC Mod had an exchange of views with Mr Gary Balch, Deputy Chief Crown Prosecutor in the UK and representative of the CARIN Network and agreed that while the issue of asset-sharing needed further consideration, international co-operation for recovery itself was still lacking a common legal basis to address important issues such as non-conviction based confiscation, management of assets, return of property to victims and other questions that are not, or not sufficiently, addressed by existing CoE instruments. It concluded that, given the importance of asset recovery it would be worthwhile considering the possible

development of a new binding instrument regulating these issues, either as an additional protocol to an existing treaty or as a convention;

During its 73<sup>rd</sup> plenary, the PC-OC considered, in consultation with the Secretariat to the COP 198, the possibility to develop a binding instrument on international co-operation as regards the management, the recovery and sharing of assets, taking into account the discussion paper by Mr Zimin, as well as the outcome of the survey on Legislation, model agreement and practice in asset sharing and to decide on the follow up;

#### 17. Information provided by the Secretariat

- took note of the information provided by the co-Secretary of the CDPC, Mr Oscar Alarcón Jiménez, on sub-items a. to c. below, in particular:

#### a. CoE Convention on Offences relating to Cultural Property

- that Slovenia, Ukraine and Italy signed this convention on 14 July, 11 September and 24 September 2017 respectively;
- that the European Union (hereafter, EU) is working on a regulation on cultural property in the EU;

#### b. Medicrime

- in relation to the status of signatures and ratifications:
  - a) that Burkina Faso and Turkey ratified the MEDICRIME Convention on 27 July and on 21 September 2017 respectively;
  - b) that the number of Parties to this treaty has thus increased to 11 and, following Article 23 of the MEDICRIME Convention, the first meeting of the Committee of the Parties shall be held within a period of one year following the entry into force of this Convention for the tenth signatory having ratified it (Burkina Faso);
- of the multiple activities carried out by the Criminal Law Division since the last CDPC Plenary meeting with a view to promoting the MEDICRIME Convention, such as:
  - a <u>training course</u> on the MEDICRIME Convention for legal professionals (judges and prosecutors) at the Spanish National School of Judges (from June to December 2017);
  - b) <u>a legal expertise</u> on the compliance of the Armenian criminal code to the MEDICRIME Convention;
  - c) <u>a high-level seminar</u> on "Human Rights and Business Promoting the effective implementation of global and regional instruments", held in Strasbourg (June 2017);
  - d) a <u>CoE convention seminar</u> (4-5 July 2017), at the request of the Ministry of Foreign Affairs of Israel;
  - e) <u>different visits</u> to the CoE from the Malaysian Minister of Law, a group of French magistrates (26-30 June 2017), a group of lawyers and law enforcement officers from Puerto Rico (7 July 2017), a Finnish delegation (22 November 2017);
  - f) the Secretariat participation in different meetings:
    - Hungarian National Office for the Judiciary (4 July 2017) and to the European Union Agency for Law Enforcement Training (CEPOL), where Ms Aija Kalnaja, acting head of operations department of CEPOL, welcomed the idea of drafting a training curriculum addressed to law-enforcement authorities;

- a high level conference entitled "Strategies to fight pharmaceutical crime", held in Milan (Italy) on 5 November 2017 in the framework of the Italian G7 Presidency;
- an international Forum entitled "Good practices against counterfeiting medical products and illegal trade", held on 22 and 23 November 2017 in Lima (Peru);
- g) the translation into Spanish of the Handbook on MEDICRIME for Parliamentarians;
- on the regular co-operation with the Committee of Experts on minimising the public health risks posed by counterfeiting of medical products and related crimes (CD-P-PH/CMED) with a view to promoting the MEDICRIME Convention;
- that a report entitled "A gender perspective on the Falsification of medical products and similar crimes" establishing the links between the MEDICRIME Convention and the gender perspective is currently in progress and will be presented to the CDPC plenary meeting in 2018. This report is the CDPC's contribution to the CoE Gender Equality Strategy 2014-2017;
- of the invitation made by the Secretariat to all those delegations which did not yet send their replies to the Criminal Law Secretariat to do so at their earliest convenience, notably:
   a) the contact details of the point of contact at national level (and the Ministry involved) responsible for the MEDICRIME Convention;
   b) the translation, where it exists, of the MEDICRIME Convention into their official

b) the translation, where it exists, of the MEDICRIME Convention into their official language;

#### c. Trafficking in human organs

- in relation to the status of signatures and ratifications, that Latvia and Ukraine signed the Santiago de Compostela Convention on 30 March and 11 September 2017 respectively and that Moldova, Norway, the Czech Republic and Malta ratified the same convention on 21 June, 12 September, 21 September and 7 November 2017 respectively;
- that Costa Rica submitted its official interest to join the Santiago de Compostela Convention;
- that the Human Rights Sub-Committee of the Joint Standing Committee on Foreign Affairs, Defence and Trade within the Parliament of Australia inquired into the topic of trafficking in human organs and made a request to the CoE to make a submission to the inquiry;
- <u>a CoE convention seminar</u> (4-5 July 2017) was organised in Israel at the request of the Ministry of Foreign Affairs;
