

Appendix 4: Examples of data provided through the CEPEJ-STAT database in regard to the Republic of Azerbaijan.












Caseflow and main efficiency indicators Azerbaijan, compared with European medians (Clearance Rate and Disposition Time), year 2014:


Data for 1st instance courts (criminal, litigious civil and commercial, administrative cases)








Data for 2nd instance courts (criminal, litigious civil and commercial, administrative cases)






Data for Supreme courts (criminal, litigious civil and commercial, administrative cases)
