# CDCPP work programme 2016 – 2017 based on its Terms of Reference

	Terms of Reference
Ο.	Under the authority of the Committee of Ministers, in the framework of the European Cultural Convention, building notably on the outcomes of relevant ministerial conferences, and having regard to the Secretary General's reports on the State of Democracy, Human Rights and the Rule of Law and the relevant decisions by the Committee of Ministers, the CDCPP will oversee the Council of Europe's intergovernmental work in the field of culture, heritage and landscape, and advise the Committee of Ministers on all questions within its area of competence. Taking due account of relevant transversal perspectives, the overall aim is to share information on policy, exchange best practice and develop standards as appropriate relating to culture, heritage and landscape in States Party to the Cultural Convention and other relevant Conventions. With this purpose, the Committee is instructed to:
1.	<ul> <li>(i) act as a forum where States share information and good practices, devise innovative policies and strategies related to the sustainable management of culture, heritage and landscape and contribute to the promotion of intercultural dialogue;</li> </ul>
1.1 Culture	Modalities: Council of Europe Art Exhibitions: expert meetings, new concept Timeframe: 2016-2017
	Expected outcomes: A new concept for Council of Europe Art Exhibitions/ cultural events is developed and suggestions for future activities in line with the new concept are made available by a group of experts.
	Beneficiary(ies): Member States of the Council of Europe (and other States signatory to the European Cultural Convention).
	Current situation: An expert group met twice (December 2015 and May 2016) to revise the concept and methodology for Council of Europe Art Exhibitions, so as to make full use of their potential to promote Council of Europe values in response to current political and social challenges. At its June meeting, the CDCPP approved the proposed concept for new exhibitions/events under the title "We, the Others" and instructed the Bureau to examine how this proposal could be included in the Programme and the budget for the next biennium. In November 2016, the Bureau of the CDCPP suggested possible links with the platform on Culture and Digitisation. The 2017 Platform Exchange was held at the Centre for Art and Media in Karlsruhe, Germany on 19-20 October and offered insights into the underexploited potential of culture, arts and science as a resource for empowering democracy for culturally competent citizens. Further synergies between Art Exhibitions and Platform Exchanges can be developed in the future, pending resources.

	Expected outcomes:
	<ul> <li>The <u>EHD Strategy 2017-2020</u> focuses on:</li> <li>strengthening cooperation at European, regional and local level;</li> <li>supporting national and local actors to foster cross-sectoral and cross-frontier cooperation;</li> <li>empowering communities to take ownership of their everyday heritage;</li> <li>strengthening the role of EHDs in the field of heritage and culture;</li> <li>fostering education and Heritage Education through active collaboration with schools and universities;</li> <li>addressing societal challenges and valorisation of heritage (climate change, migration, radicalisation, education, diversity, identity).</li> </ul>
	The National Coordinators voted on the EHD common themes for the next four years: 2018: The European Year of Cultural Heritage under the following slogan: "European Heritage: The Art of Sharing"; 2019: "Arts and Entertainment"; 2020: "Heritage and Education"; 2021: "Inclusive Heritage" ("Heritage for Everybody").
	In 2018, the EHD Programme, in addition to the Strategic Objectives activities, will provide examples to demonstrate the recommendations and values outlined in the Council of Europe's Strategy 21.
	Beneficiary(ies): Member States of the Council of Europe (50 states signatory to the European Cultural Convention).
	Current situation: In the framework of the 2017 EHD "Heritage and Nature", the Programme published a brochure on <u>"101 Event Ideas"</u> and prepared a draft European visibility strategy, including European press releases and conferences.
	In 2017, there were five specific outcomes:
	<ol> <li>National and regional 'European Heritage Days' events were organised within one weekend, week or month. Fifty participating States were fully engaged in the celebration and promotion of the common European heritage. Current scope records over 70 000 events and 30 million visitors, making the EHDs the most widely celebrated participatory cultural events by the European citizens.</li> </ol>

	<ol> <li>The EHD Network was developed and the role of the EHD Working Groups re-enforced. EHD Working groups are defined as follows: WG1: Heritage Communities; WG2: Visibility and Communication Strategy; WG3: Common theme; WG4: EHD Portal and synergies with other Programmes; WG5: EHD Strategy and Cooperation events; WG6: Heritage Education.</li> <li>The EHD Portal was developed in order to continue providing all Europeans with an equal opportunity to give visibility to their specific heritage within the EHD events. New design of the Portal allowed it to further develop as a truly unique heritage platform, presenting current initiatives in the area of culture and heritage. In 2018, the Portal will be used as a platform for the celebration of the 2018 European Year of Cultural Heritage, with all the necessary preparations implemented in 2017.</li> </ol>
	4. "Heritage and Nature" was developed and adopted as a 2017 pan-European celebration theme. Synergies with other activities of the Council of Europe (European Landscape Convention, Bern Convention, Major Hazards, EUROPA), the EC DG for Environment, Natura 2000 and NGOs (Europa Nostra, Interpret Europe) were implemented.
	<ol> <li>Three thematic workshops on relevant topics were organised: "Heritage Interpretation" (7-8 June 2017, Brussels, Belgium); "Heritage and Sustainable Development" (11-12 September 2017, Helsinki, Finland); and "Heritage and Education" (23-24 November 2017, Bonn, Germany).</li> </ol>

	Timeframe: 2016-2017
	Expected outcomes: States share information on innovative landscape policies and strategies, and identify good practices.
	Beneficiary(ies): Member States of the Council of Europe and, in particular, 38 States Parties to the European Landscape Convention.
	Current situation:
	National Landscape policies - http://www.coe.int/en/web/landscape/workshops
	The 19th Council of Europe Meeting of the Workshops for the implementation of the European Landscape Convention on <i>"The implementation of the European Landscape Convention at local level: local democracy"</i> was held in Brno, Czech Republic, on 5-6 September 2017; see <u>www.coe.int/en/web/landscape/19th</u> ). The Meeting was organised by the CoE – Secretariat of the European Landscape Convention – under the auspices of the Czech Chairmanship of the Committee of Ministers of the Council of Europe, in co-operation with the Ministries of the Environment, Regional Development, Agriculture, Culture, and School, Youth and Sport of the Czech Republic, in partnership with Mendel University in Brno and South Moravian Region. Over 150 participants from member and non-member States of the Council of Europe attended. The Meeting aimed to present experiences of national policies adopted or being developed at local level, considering the provisions of the Convention. Four Workshops addressed instruments for the implementation of the Convention at local level, experiences taking into account the landscape dimension at local level, and local democracy: participation and commitment. Participants expressed the wish that on the occasion of the First

International Landscape Day of the Council of Europe, which was held on 20 October 2017, local authorities should be invited to celebrate the landscape as "an essential component of people's surroundings, an expression of the diversity of their shared cultural and natural heritage, and a foundation of their identity" (Article 5.a of the European Landscape Convention. 	Expected outcomes: A Cultural Policy Peer Review enables reform of cultural policies in line with Council of Europe standards and best practice.
	Beneficiary(ies): One member State of the Council of Europe (of 50 states signatory to the European Cultural Convention).
	Current situation: In 2016, the Ministry of Culture of Ukraine requested a peer review of the country's cultural/cultural heritage policy with a view to decentralising the functions of the central administration at local and/or regional level. An expert visit took place on 12-15 March 2017. Peer-Review countries included Austria, France, Italy, Spain and Sweden. The review report – including targeted recommendations for action – was finalised in April 2017 and submitted to the Ukrainian authorities in May.
	Following previous exchanges with the Ministry of Culture of Albania, assistance is being provided in the drafting of a national cultural strategy. An expert visit took place in November 2017 and a second visit may take place in early 2018, offering elements of peer review to the Albanian authorities in the framework of a policy workshop.
2.2 Cultural Heritage	As a follow up to the work of the group of experts on technical assistance carried out in 2016 in producing a comprehensive report on the lessons learned from the pilot projects carried out in South-East Europe, the Caucasus, and the Black Sea region, a publication has been finalised and should be available in draft format to the CDCPP Bureau members in December.

	Compendium Management System Following the Cyprus Assembly of Compendium Stakeholders and Experts (Nicosia, 30-31 March 2017), consultations were organised on the consortium's draft statutes with all stakeholders (CoE, CDCPP, ERICarts, Compendium Authors, interested cultural institutions). The CDCPP had its final consultation on the draft in June 2017, as requested at the CDCPP plenary meeting. A host country for the consortium was found (the Netherlands) which kindly agreed to pay the legal costs to set up the Association, incorporated finally on 21 October 2017. The consortium, now known as the Compendium of Cultural Policies and Trends Association (CCPT) had its official launch on 9 November at the 16 <sup>th</sup> Assembly of Compendium Experts, organised within the framework of the Czech Republic Chairmanship of the Committee of Ministers of the Council of Europe. As part of this launch, the CCPT's first General Assembly and first Board Meeting were held. To date, the CPPT has 12 members: Albania, Belgium, Council of Europe, CUPORE (Finland), European Association of Cultural Researchers (ECURES), ERICarts, France, Iceland, Latvia, Romanian National Institute for Cultural Research and Training, Switzerland, United Kingdom. The Netherlands will join in the near future, but has to finalise the legal details of its membership. Poland is interested to join, but also has to finalise the legal details of membership. The CCPT has a functioning Board of 6 members: Chair – Marjo Mäenpää (CUPORE, Finland), vice Chair – Siobhan Montgomery (Council of Europe Secretariat), treasurer – Anna Villarroya (Chair of ECURES Board), Secretary – Jean-Cédric Delvainquière (France), members – Kimmo Aulake (Chair of the CDCPP) and Carmen Croitoru (Director of the Romanian National Institute for Cultural Research and Training). The next Board meeting will be held in 2018 in Helsinki, possibly together with the next General Assembly and the first Assembly of Compendium Experts. The final Board member will be chosen by the CCPT's Assembly of Co

I. HEREIN Network

#### Organisation of thematic workshops:

- a. Organisation of heritage in Europe: workshop in June 2016 with the participation of six volunteer national coordinators. The aim of this workshop was to analyse theme 1 "organisations" of the national reports published on the HEREIN system and to produce a report on the organisation of heritage in Europe. This report which is based on the contents of the national reports and additional information obtained through the HEREIN network will be published in PDF format and made available on the HEREIN web page in 2017.
- b. Thesaurus: workshop in October 2016 to set up an appropriate research tool for the thesaurus. Ten national coordinators participated from countries that have participated in creating the thesaurus and the webmaster to take account of the specificities and technical limitations of the needs identified: enlargement of audience, review of the terms, renewed presentation, etc.

#### Organisation of a first preparatory meeting

Following the Audit of the HEREIN IT system commissioned in 2016 and in preparation of the discussion by the CDCPP of the future developments of the HEREIN network and system, a workshop was organised in April 2017 with the participation of both CDCPP members and HEREIN national coordinators. The aim of this workshop was to discuss concrete proposals for decisions related to the following topics:

- Discussion of the results of the IT Audit commissioned by the Secretariat;
- Identification of the core public to be addressed by the HEREIN website;
- Reorganisation of the present website to facilitate its usage;
- Pertinence of the thematic studies with respect to the HEREIN main goals;
- Involvement of HEREIN national coordinators in future developments;
- Increase of the coherence of planned activities with the CDCPP's political orientations.

Creation of a new collaborative space

In order to foster all-year round exchanges between the HEREIN National Coordinators, a dedicated collaborative space has been launched.

Organisation of a second preparatory meeting

Following the decisions on HEREIN taken at the June CDCCP meeting and the confirmation/renewal of National Coordinators, a workshop was organised in November 2017 to present the new tools available for the HEREIN Network and to define the concrete proposals of activities for 2018 that will include:

- Completion/revision of the Country Profiles;
- Modification of the structure of National reports;
- Setting up of thematic workgroups on specific issues;
- Development of additional thematic sections in the HEREIN website.

### HEREIN Guidelines

A draft manual for network coordinators, initially drafted in 2015, will be reviewed in the light of the future goals of the HEREIN network and system for final distribution in 2018.

### Communication – Promotion

- a. Two newsletters (June and September 2016) have been distributed to network members to inform them about the latest developments.
- b. Contacts have been pursued with EHHF, European Historic Houses, JHEP.

## Participative surveys ("crowdfinding")

- a. A participative survey on the heritage of historic cableway installations was launched by Switzerland and completed in January 2017.
- b. Two additional participative surveys (on restorers' regulations and on industrial heritage) are currently active on the Collaborative Space.

	To ensure exchanges of information and monitoring of the implementation of the Convention in the various member States of the Council of Europe, a document setting out the landscape policies pursued in the member States was produced on a regular basis and presented on the occasion of the Council of Europe Conferences on the European Landscape Convention ( <u>CEP-CDPATEP</u> (2009) 3; <u>CEP-CDPATEP</u> (2011) 7; <u>CEP-CDCPP</u> (2013) 5; <u>CEP-CDCPP</u> (2015) 5).
	The use of the European Landscape Convention Information System, set up pursuant to Recommendation <u>CM/Rec(2013)4</u> of the Committee of Ministers to member States on the European Landscape Convention Information System of the Council of Europe and its glossary, permit access online to information concerning national and regional policies that have been developed ( <u>https://rm.coe.int/09000016802fc144</u> ).
