## Introduction

The Ad Hoc Committee of Experts on Roma and Traveller Issues (CAHROM) held its 15th plenary meeting in Athens, Greece, on 22-25 May 2018. The meeting was chaired by Ms Tatjana Andjelić (Montenegro), Chairperson of CAHROM, and by Mr Ján Hero (Slovak Republic), Vice-Chairperson of CAHROM. The agenda, as adopted by the Committee, appears in the Appendix to this report. The list of participants is available from the Secretariat.

## Items for publication on the CAHROM website

The Committee endorsed and approved the publication on its website of the following documents:

- the thematic report on the teaching of Roma history, including Roma Holocaust, in textbooks and school curricula [document CAHROM (2017)32];
- conclusions of the thematic report on Roma and Travellers' access to justice with a gender focus, pending the adoption of the full report by written procedure [CAHROM (2018)5];
- the report of the study visit to the UK Forced Marriage Unit on child and forced marriages within Roma and Traveller communities [CAHROM (2017)33];
- the updated list of CAHROM thematic groups/visits 2018-2019 [CAHROM (2018)2rev];
- the updated guidelines for CAHROM rapporteurs, pending their approval by written procedure [CAHROM (2018)3].

## **Gender representation**

At the 15th plenary meeting of CAHROM, the 36 member States present were represented by 19 women and 17 men, or 52.8 % and 47.2 % respectively.

## Items discussed and decisions taken by the CAHROM

The Committee,

- 1) following opening remarks by the Alternate Minister of Social Solidarity and the Special Secretary on Roma Inclusion, both within the Ministry of Labour, Social Security and Social Solidarity of Greece, held an exchange of views with various Greek authorities, representatives of regional and local authorities and Roma civil society, covering priorities of the Greek National Strategic Plan for Roma Inclusion, such as the social solidarity income (SSI), free medical care and warm meals in kindergartens, the fight against poverty and school dropouts, the setting up of 240 community centres, housing and infrastructure projects, and a mapping and classification of 375 Roma settlements; took note of the coordination and supervisory work of the Special Secretariat on Roma Inclusion, the work of community centres, of the General Secretary on gender equality, of the General Secretary on human rights, of the Special Secretary on citizenship related issues and of the Greek Ombudsman on equal treatment;
- 2) visited on 25 May 2018 the municipality of Megara, its community centre and the Roma settlement in Vlychos within the Regional Unit of Western Attica and met with the mayor, the deputy mayor, the technical team for ongoing housing and infrastructure projects and representatives of the local Roma community;
- 3) **welcomed** the positive developments taking place in Greece at policy, legislative and project levels and **took note** of the general support from the Roma civil society as regards these developments;
- 4) **instructed** the Secretariat to circulate all presentations delivered by the Greek speakers;

- 5) **took note**, following a presentation by the representative of the Central Union of Municipalities of Greece (KEDE) and the Spokesperson on Roma and Traveller Issues of the Congress of Local and Regional Authorities of the Council of Europe, of the setting up of an intermunicipal Roma network comprising 24 Greek municipalities which will act as a national interlocutor for the European Alliance of Cities and Regions for Roma Inclusion; **took note** that 16 of these municipalities signed on 12 April 2018 the Declaration against anti-Gypsyism, which is available for signature on the Alliance website in 23 languages and has received more than 100 signatures so far;
- 6) Under recent developments at national and international levels, **took note** of the consequences of the current financial situation of the Council of Europe on the work of the Roma and Travellers Team and the CAHROM in particular; **took note** of the nomination of Mr Jeroen Schokkenbroek, former Special Representative of the Secretary General for Roma Issues, as new Director for Anti-Discrimination, as well as of developments concerning the European Roma Institute for Arts and Culture (ERIAC), including the Committee of Ministers' decision to carry out an evaluation of the work of ERIAC in 2018; **supported** the request expressed by "the former Yugoslav Republic of Macedonia" to see ERIAC more active in the Western Balkans; **agreed** with Sweden's proposal to invite ERIAC's Executive Director at its next meeting for an exchange of views;
- took note of recent developments presented by the FRA, the OHCHR and the European Commission (DG NEAR), and in particular took note of the findings of the April 2018 FRA report showing that anti-Gypsyism remains a persisting concern and barrier to Roma inclusion; of the OHCHR position paper on human rights in the Multi-Annual Financial Framework Post-2020, in particular aspects related to Roma rights; of the 2018 Commission Enlargement Strategy for the Western Balkans and its Roma integration components; of the preliminary findings of the DG NEAR-UNDP-World Bank Regional Roma Survey in the Western Balkans and preliminary findings of the Returnee study in the Western Balkans, as well as of recent developments in DG JUST, such as the ongoing independent evaluation on the EU Framework for National Roma Integration Strategies which shall be published around the end of autumn; took note of the fact that the next EU Platform for Roma Inclusion, to be held in Brussels on 8-9 October 2018, would focus on health and housing inequalities, and that the launch of the 2<sup>nd</sup> phase of the joint CoE/EC programme on Roma women's access to justice "JUSTROM2" had just taken place in Athens, Greece, on 22 May 2018;
- 8) **took note** of the request from the Joint Council on Youth Rapporteur on Roma issues addressed to EU member States to have a stronger minorities' focus at the level of the European Union recalling a European citizens initiative "Minority SafePack" on that request that received 1.3 million signatures of support and reached the necessary threshold in 11 EU countries to be considered by the European Commission;
- 9) **took note** of the new Instruction of the French Government to give a new impetus to the resorbtion of illegal encampments and shantytowns, and of various innovative aspects of the revised Slovenian National Roma Integration Strategy in the fields of education, housing, social integration and employment; **took note** of written information provided on recent developments submitted by Norway and the Russian Federation:
- proceeded with a tour de table and oral responses from Croatia, Finland, Norway, Spain, Sweden, and the United Kingdom, as well as remarks from the OSCE-ODIHR, to the open question addressed by Germany to other CAHROM members, i.e. "Which member States collect data specifically on antigypsyist (antiziganist) crimes? How is this data collected and what have their experiences in collecting this data been like?"; decided to fix at 12 June 2018 the deadline for submitting written information to the Secretariat that would then be circulated to the CAHROM member on behalf of Germany;

- examined and endorsed the CAHROM thematic report on the teaching of Roma history, including Roma Holocaust, in textbooks and school curricula following a visit held in Košice, Slovak Republic, on 7-9 November 2017 [document CAHROM(2017)32], the report of the study visit to the UK Forced Marriage Unit on child and forced marriages within Roma and Traveller communities held in London on 7-8 December 2017 [document CAHROM (2017)33], as well as the conclusions of the thematic report on Roma and Travellers' Access to justice with a focus on women following a visit held in Helsinki, Finland, on 21-23 March 2018 [document CAHROM (2018)5];
- discussed follow-up to the thematic report on addressing and combating trafficking of human beings within Roma communities, with a focus on street children and prostitution [document CAHROM (2015)7] following the visit held in Tirana, Albania, on 4-6 March 2015, as well as follow-up to the thematic report on child/early and forced marriages within Roma communities in the context of the promotion of gender equality [document CAHROM (2015)8] following the visit held in Bucharest, Romania, on 27-29 April 2015;
- agreed that the full report of the thematic visit to Finland on access to justice would be approved by written procedure and published on the CAHROM public website, once the experts of this thematic group have endorsed it, and that the report on addressing and combating trafficking of human beings within Roma communities, with a focus on street children and prostitution, would be updated with new developments through an appendix and recirculated to the CAHROM for written endorsement and publication on the CAHROM website;
- took note that the proposed Terms of Reference of CAHROM for 2018-2019, include under "specific tasks" the drafting by the CAHROM of a CM Recommendation on the inclusion of the teaching of Roma history, including Roma Holocaust, in textbooks and school curricula; considered that the CAHROM thematic report on the teaching of Roma history, including Roma Holocaust, in textbooks and school curricula following the visit held in Košice, Slovak Republic, on 7-9 November 2017 [document CAHROM(2017)32], as well as other existing relevant Council of Europe, OSCE-ODIHR and IHRA texts and materials, could serve as a basis for a preliminary draft; agreed to set up a working group that would be composed of five CAHROM members (Armenia, Finland, Germany, the Slovak Republic as Vice-Chair, and Switzerland) and a consultant, as per CAHROM Terms of Reference; agreed to invite Ms Mirjam Karoly, former OSCE-ODIHR CPRSI Senior Adviser and now member of the Committee on the genocide of Roma of the International Holocaust Remembrance Alliance (IHRA), to be the consultant, and invited OSCE-ODIHR and other interested international observers to contribute to the drafting process;
- took note of recent developments in the Czech Republic, namely the purchase by the Czech Government of the pig farm in Lety; took note of OSCE-ODIHR's efforts in teaching and informing about the Roma Holocaust, including through reports, an ODIHR specific dedicated web page, and the joint CoE/ODIHR website on the Roma and Sinti genocide;
- heard a presentation by Dr Franz Salm-Reiffersheidt, Ambassador at large for Roma people of the Sovereign Order of Malta about projects conducted in 8 member States (Albania, Austria, Belgium, Croatia, Hungary, Romania, the Slovak Republic and Ukraine), including *inter alia* sanitary facilities, ambulances, kindergartens, tutory lessons, parental/mother consulting, apprenteeship, music schools, football clubs, riding lessons, summer camps, agricultural and factory projects; **took note** of the Order of Malta's willingness to develop similar projects in Bulgaria, the Czech Republic and Slovenia; **took note** of the interest expressed by the President of the Greek Roma Women's Association to see the Sovereign Order of Malta becoming also active in Greece;
- 17) as regards the planning of CAHROM thematic visits, **took note** of an oral summary on the thematic visit on enhancing the effective realization of Roma children' compulsory school education as the most efficient tool towards the mid-term improvement of the situation of Roma communities,

and added value of ensuring access to vocational education for Roma youth, held in Chişinău and Vulcăneşti, Republic of Moldova, on 24-26 April 2018;

- took note that a thematic visit on Roma access to employment, with a focus on Roma women and youth, would be held in Enschede and Tilburg, the Netherlands, on 12-14 June 2018, and that Finland, Greece, the Republic of Moldova, Poland, Spain and "the former Yugoslav Republic of Macedonia", as well as representatives of the Youth Department, the ROMACT project team and the European Commission (DG NEAR) would participate;
- 19) **took note** that a thematic visit on Roma integration, policy development and coordination practices in countries with a small Roma population would be held in Rīga, Jelgava and Jūrmala, Latvia, on 3-5 October 2018, and that Estonia, Finland, Georgia, Lithuania, Norway and Slovenia, as well as representatives from ECMI and OSCE-ODIHR would participate;
- 20) **took note** that a thematic visit on solving the lack of identity documents and statelessness would be held in Tirana, Albania, on 14-16 November 2018, and that Bosnia and Herzegovina, Italy, Montenegro, Serbia, "the former Yugoslav Republic of Macedonia" and Ukraine, as well as representatives of ECMI and the EU Delegation in Albania would participate:
- took note that a thematic visit on governmental support for the promotion of Romani arts and culture and Holocaust remembrance, as well as related international cooperation, would be held in Berlin, Germany, early 2019; instructed the CAHROM Bureau to proceed with the selection of the partner countries among those having expressed interest (Austria, Belgium, Latvia, the Republic of Moldova, Norway, the Slovak Republic, Sweden, Switzerland, Ukraine and the United Kingdom), giving priority to countries that have less participated in thematic visits so far, and taking into consideration their motivation and experience related to the topic;
- took note that a thematic visit on the promotion of Romani culture(s) and the impact of traditions in the development and implementation of national Roma integration policies, including how to address possible opposition between customary law and state legislation, would be held in the Russian Federation in June 2019, and that Croatia, Lithuania, Poland, the Slovak Republic, Slovenia and "the former Yugoslv Republic of Macedonia", as well as ECMI, would participate;
- took note of new proposals for future thematic visits, namely on national experiences of social and/or geographical mapping of Roma communities and their concrete impact on policy developments proposed by "the former Yugoslav Republic of Macedonia"; on health related issues including reproductive health and vaccination proposed by Finland and supported by Spain; on Roma migrants and refugees proposed by the Republic of Moldova; on how to stimulate Roma participation in governmental institutions proposed by the Republic of Moldova and supported by ECMI; on Roma self-reliability and responsibility to participate in society as any other citizens proposed by the Netherlands;
- instructed the Secretariat to circulate the updated guidelines for CAHROM rapporteurs [document CAHROM (2018)3] to the entire committee for written endorsement by 12 June 2018;
- 25) **heard** a presentation from Lord Bourne of Aberystwyth, Parliamentary Under Secretary of State, Minister for Faith, Ministry of Housing, Communities and Local Government, United Kingdom, on disparities experienced by the Gypsy, Roma and Traveller communities in England;
- took note of the mapping and classification of Roma settlements and camps in Greece, as well as other existing geographical and/or social mapping practices in Bulgaria, Croatia, Hungary, Italy, Poland, Portugal Serbia, Sthe lovak Republic, Spain, and Sweden; took note that such mapping does not exist in Germany, Lithuania, Luxembourg or Norway; took note that in Belgium

and Switzerland only a mapping of halting sites of nomadic populations exists and that in France a mapping of the population (mainly Roma) living in illegal settlements and shanty towns takes place twice a year; **took note** that Croatia was finalising its own mapping and that "the former Yugoslav Republic of Macedonia" started a social mapping in 14 local self-governments under an IPA project; **agreed** to keep this item on the agenda of its next meeting with a focus on monitoring and results of social mapping, as it was suggested by the representative of "the former Yugoslav Republic of Macedonia";

- 27) **heard** a presentation on the newly-established institutional framework on transitory relocation in Greece, which includes the development of housing complexes according to social housing principles and the improvement of hygienic and environmental conditions as a preliminary stage to the inclusion of Roma living in unacceptable conditions;
- heard a presentation from Ms Irene Pfisidou from the European Centre for the Development of Vocational Training (CEDEFOP) on initiatives undertaken after the Council of Europe's 4<sup>th</sup> Dialogue with Roma and Traveller civil society "Transition from Education to Employment" (Strasbourg, September 2017); took note that CAHROM members could communicate questions or experiences through the CEDEFOP representative of their online platform; took note that a call to submit good practices on vocational and education would be soon circulated via the CAHROM Secretariat:
- 29) **took note** that Croatia under its Chairmanship of the Council of Europe's Committee of Ministers would host an International Seminar entitled "*Transition from education to employment for Roma youth*" on Brijuni island on 25-26 September 2018 which would be an opportunity to provide additional follow-up to both the 4<sup>th</sup> Dialogue with Roma and Traveller civil society and the November 2017 EU Roma Platform; **invited** CAHROM members and observers to indicate by the end of June 2018 to the Secretariat their interest in participating in this event, whilst keeping in mind that due to a limited budget and seats available, not all CAHROM participants would be able to participate;
- 30) had an exchange with Ms Béatrice Fresko-Rolfo, Rapporteur of the Parliamentary Assembly of the Council of Europe on her forthcoming report on Forced Marriage in Europe, as well as with the Special Secretary on Roma Inclusion under the Greek Ministry of Labour, Social Security and Social Solidarity, and a representative of the Department of Social Protection and Fighting against Multiple Discrimination under the General Secretariat on Gender Equality of the Greek Ministry of Interior on the situation regarding child/forced marriage in Greece; took note of the proposal made by Albania to further reflect on a methodology that could help member States in addressing child and forced marriages, in particular within Roma and Traveller communities; agreed with Albania's proposal that the Council of Europe/CAHROM could initiate guidelines/a broader campaign regarding child/early and forced marriages;
- 31) **took note** of the conclusions, recommendations and follow-up initiatives of the 6<sup>th</sup> International Roma Women's Conference "Political participation: the case of Roma and Traveller women" (Strasbourg, 6-7 November 2017) presented by the CAHROM Gender Equality Rapporteur; **took note** of the message delivered by the Congress Spokesperson on Roma and Traveller Issues who encouraged municipalities to form structures for political participation, such as the national Roma networks set up in Greece and Ukraine, and underlined the importance for political parties of setting-up measures to encourage especially Roma and Traveller women to enter into politics;
- 32) **heard** a presentation from the representatives of the Advisory Council on Youth and the Joint Council on Youth Rapporteur on Roma issues about the conclusions of the coordination meeting of International Roma Youth Networks (FERYP, ternYpe, Phiren Amenca, European Youth Foundation), results of recent Roma youth political participation activities organised in member States, as well as recent and future events under the Roma Youth Action Plan (RYAP);

- 33) heard a presentation from the Secretariat about the objectives of the 5<sup>th</sup> Council of Europe Dialogue with Roma and Traveller civil society entitled "Roma and Travellers' Political Participation as voters and candidates" that would be held in Strasbourg on 20-21 June 2018;
- agreed to hold its 16<sup>th</sup> plenary meeting in Strasbourg from 16 to 19 October 2018;
- **agreed** to include on the agenda of its next meeting the following items:
  - election of the 2019 CAHROM Bureau and (re-)appointment of CAHROM rapporteurs;
  - exchange with a representative of the French Ministry of Education and discussion on the follow-up to the thematic visit to Paris and Goussainville, France, 5-7 October 2015, on the schooling of newly arrived allophone children ("EANA") and children of itinerant and traveller families ("EFIV");
  - examination of new thematic reports (exact list to be confirmed);
  - discussion with the Secretariat of the European Charter for Regional or Minority Languages on follow-up to the two CAHROM thematic reports addressing Romani language and other languages spoken by Roma communities in Europe (thematic visits to Croatia and Austria);
  - presentation by a member of the IHRA Committee on the Genocide of Roma (CRG) on the Roma-related work of the International Holocaust Remembrance Alliance (IHRA);
  - examination of a preliminary draft CM recommendation on Roma history teaching, including Roma Holocaust, in textbooks and school curricula;
  - discussion on state and external donors' budget allocation to national Roma integration strategies (proposal by Albania at the 14<sup>th</sup> CAHROM meeting);
  - further discussion on practices concerning the geographical and/or social mapping of Roma and Traveller communities;
  - feedback from the Brijuni Seminar on transition between education and employment;
  - discussion on Roma youth challenges (proposal by the Republic of Moldova);
  - exchange with Ms Timea Junghaus, ERIAC Executive Director (proposal by Sweden);
  - exchange with Mr Fernand de Varennes, UN Special Rapporteur on minority issues, on Roma in the Americas (decision taken at the 14<sup>th</sup> CAHROM meeting);
  - exchange with the Permanent Observer of Canada to the Council of Europe on follow-up to the issue of pre-boarding screening of international passengers of Roma ethnic origin to Canada (decision taken at the 14<sup>th</sup> CAHROM meeting);
  - exchange of views with ad hoc rapporteurs of the 5<sup>th</sup> Council of Europe Dialogue meeting with Roma and Traveller civil society;
  - presentation of UK work on tackling hate crime and anti-Gypsyism and projects promoting better inclusion and tolerance in schools and better integration through health, education and socialies (proposal by the United Kingdom at the 14<sup>th</sup> CAHROM meeting);
  - presentation by "the former Yugoslav Republic of Macedonia" of a new law for Social Protection which includes specific provisions on anti-trafficking;
  - as a side event, exhibition on Roma during the First World War (proposal by Serbia);
  - as a side event, screening of a movie "Yeniche Sounds" ("Unerhört Jenisch") with Stephan Eicher (proposal by Switzerland);
- 36) **thanked** the French authorities for their invitation to host one of the 2019 CAHROM plenary meetings, probably in Toulouse, under the French Chairmanship of the Council of Europe's Committee of Ministers, pending final decision on the programme of the chairmanship;
- 37) **took note** of the draft abridged report circulated by the Secretariat and **agreed** to adopt the final abridged report by written procedure by 6 June 2018.
