WORKING GROUP OF THE CONSULTATIVE COUNCIL OF EUROPEAN PROSECUTORS (CCPE-GT)

Report of the 21st meeting Paris, 15 – 16 June 2017

Document prepared by the Secretariat Directorate General I - Human Rights and Rule of Law

I. INTRODUCTION

- 1. The Working Group of the Consultative Council of European Prosecutors (CCPE-GT) held its 21st meeting in Paris on 15-16 June 2017. Mr José Manuel SANTOS PAIS (Portugal), Vice-President of the CCPE, chaired the meeting¹.
- 2. The agenda and the list of participants are n Appendices I and II respectively.

II. COMMUNICATION BY THE PRESIDENT AND MEMBERS OF THE BUREAU AND WORKING GROUP OF THE CCPE

- 3. Mr SANTOS PAIS informed the Working Group about an invitation for the CCPE to participate in an international high-level conference on the "Binding Effect of Judicial Decisions"².
- 4. Mr Cédric VISART DE BOCARME (Belgium) confirmed his participation in this conference on behalf of the CCPE.

III. PREPARATION OF THE OPINION NO. 12 ON THE RIGHTS OF VICTIMS, WITNESSES AND VULNERABLE PERSONS

- 5. The members of the Working Group examined the draft Opinion (document CCPE-GT(2017)3Prov4), which contains the contributions of the members of the Working Group and of the Secretariat.
- 6. Before this meeting, it was already decided to change the title of the Opinion into "The role of prosecutors in relation to the rights of victims and witnesses in criminal proceedings". Such title would more exactly describe the purpose and scope of the Opinion. It would of course focus on different types of victims and witnesses, including first of all those who are vulnerable due to their age, gender or other characteristics.
- 7. The Working Group started its consideration of the draft from hearing the views and suggestions of the Bureau members, who commended the draft, pointing out, at the same time, to certain repetitions and overlapping sentences/phrases which still appeared in the text. The Working Group members agreed and proceeded to detailed discussion on each paragraph of the draft. It recalled the necessity to draft, at the end of the text, concrete and efficient recommendations.
- 8. It was in particular pointed out that some thematics were missing in the current text such as compensation of victims, mediation procedures, the importance of defence rights.
- 9. The Secretariat was requested to integrate the last comments of some Working Group members to be received immediately after the meeting, and then to send the final version to all members of the Bureau and the Working Group for their comments to be submitted by 9 September 2017. After that, the Secretariat would prepare the integrated version of the draft Opinion, send it to the Bureau for final approval, and subsequently would send to all members of the CCPE for their comments before the plenary meeting of the CCPE.
