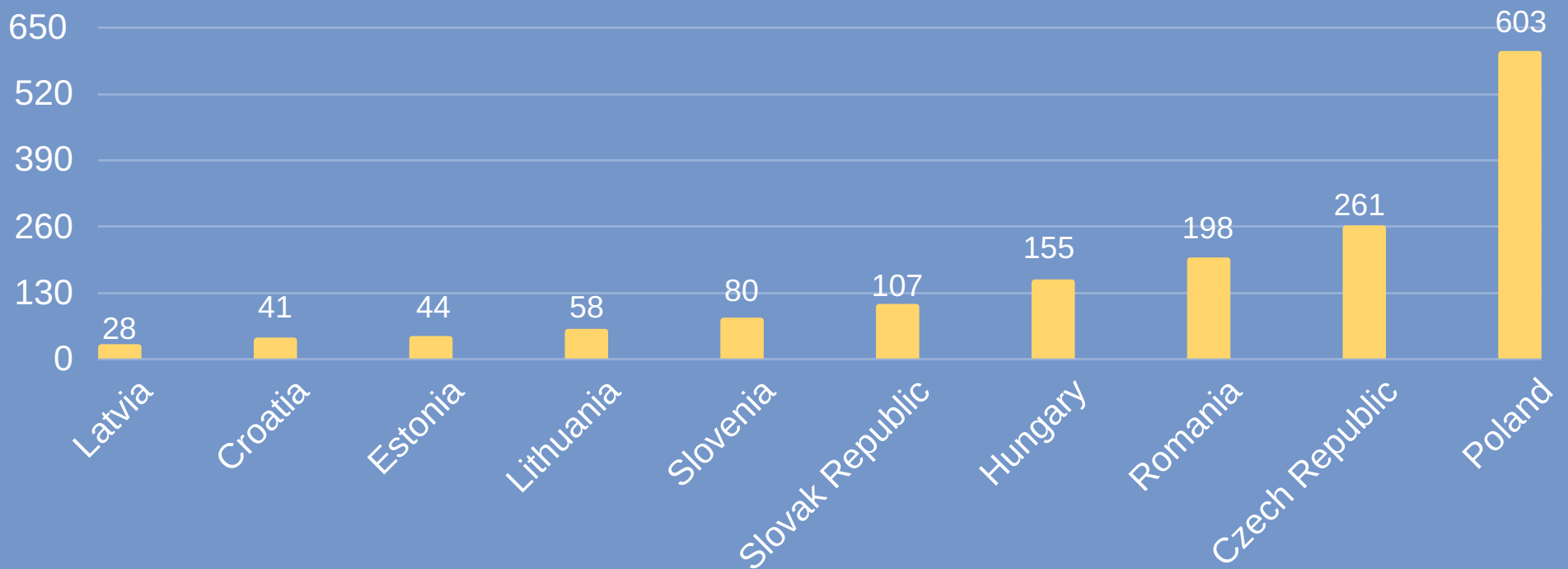

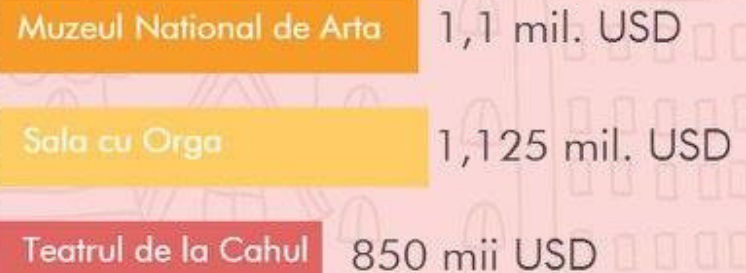
ROMANIA

 - o **Education:** vocational training focusing on access to the labour market and self-employment, teacher education, equipment of educational facilities;
 - o **Healthcare:** basic healthcare, nutrition programme, education of the population and public awareness of prevention and healthcare, education of healthcare personnel;
 - o **Good governance and building of civil society:** public finance management, public sector reform, enhancement of rule of law and public participation in democratic processes, SSR, activities of civil experts within international crisis management;
 - o **Agriculture and forestry**
 - o **Water and sanitation**
 - o **Energy**
 - o **Support of market environment development and small and medium enterprises**
