### 1. BACKGROUND

The European Programme for  $\underline{\mathbf{H}}$ uman Rights  $\underline{\mathbf{E}}$ ducation for  $\underline{\mathbf{L}}$ egal  $\underline{\mathbf{P}}$ rofessionals (HELP) of the Council of Europe (CoE) aims at assisting legal professionals (judges, prosecutors and lawyers) and other professionals to effectively apply the European human rights standards in their daily work. This is done by developing and implementing high-quality, tailor made online courses on various human rights related topics.

### HELP's three pillars are:

- the HELP Network;
- the HELP online courses; and
- the HELP Training methodology.

The HELP Network is the only European peer-to-peer human rights training network. It consists of representatives of national training institutions for legal professionals (judiciary schools and Bar associations) from the CoE member States and beyond. Other international organisations, as well as some NGOs, are partners of the Network, including the main international associations of legal professionals (European Judicial Training Network (EJTN), Council of Bars and Law Societies of Europe (CCBE), etc.).

The HELP Annual Network Conference is the main gathering of the HELP Network members and partners. It provides a forum for discussion on ways of enhancing human rights training results and on how to improve effective co-operation among all members and partners of the HELP Network. ### 2. THE 2019 HELP NETWORK CONFERENCE

In 2019, the Council of Europe is celebrating its 70 years' anniversary. Hence the title of this year's CoE HELP Annual Network Conference is 'HELP: celebrating the 70<sup>th</sup> anniversary of the Council of Europe'.

This year's Conference aims at:

- highlighting the impact of training of legal professionals in strengthening human rights, democracy and rule of law in Europe,
- reinforcing the HELP Network and providing a forum for exchanges among its members (e.g. challenges, issues and topics in human rights training; stocktaking and planning of HELP network actions at cross-border or national level)
- presenting the developments in HELP since the 2018 Conference:
  - an update on the HELP Projects and initiatives; and
  - newly developed HELP courses.

The <u>newly developed/updated HELP courses</u> will be presented to the participants (the first four developed with financial support from the Justice Programme of the EU):

- Family Law and Human Rights
- Procedural Safeguards in Criminal Proceedings and Victims' Rights
- Radicalisation Prevention Evidence in Counter- Terrorism cases
- Updated course on Data Protection and Privacy Rights
- CPT Standards (Standards of the European Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment)
- Access to Justice for Women

During the Conference, HELP Network members will be presented **tools on the HELP online platform** which will help strengthen their interactions and networking (Focal and Info Points page, tutors page).

### Working group sessions

On the second day of the Conference, three Working group sessions will be held. The objective of these sessions is strengthening the exchanges between the HELP Network members coming from different regions where the HELP Programme is active.

1) Working group 1: HELP Network in the EU MS

2) Working group 2<sup>1</sup>: HELP Network in Eastern Partnership countries. HELP in the Russian

Federation

3) Working group 3: HELP Network in the Western Balkan. HELP in Turkey

The Working Group discussions will focus on topics of particular interest for the regions. The key points of discussion in the Working Group will be reported to the plenary of the Conference.

Upon conclusion of the Conference, the <u>HELP Roadmap</u> for the 2019-2020 HELP activities will be formulated.
