- 1. Opening of the meeting by Anna Rurka, President of the Conference of INGOs
- 2. Nomination of the Rapporteur of the meeting: Katarzyna Sokołowska

- 5. Creation of a Conference of INGO Expert pool

**Decision**: Anne Kraus will further discuss with Karl Donert the details concerning the application procedure for the expert pool. An announcement will be made during the plenary meeting on Friday to motivate all INGOs to support the process. After approval of the application procedure (and the application form) by the Bureau, the call will be sent out around 15 September.

6. Summer session 2018 – division of responsibilities, setting the goals and expected results

**Decision:** Division of responsibilities was made. Katarzyna Sokołowska and Robert Bergougnan would help with the registration prior for General Assembly of OING-Service on Wednesday morning. Maritchu Rall and Richard Pirolt would help with the registration for the meeting of the Conference of INGOs on Friday morning.

7. Change of dates of the sessions of the Conference of INGOs in 2019. **Decision** : During the plenary meeting on Friday (29.06.2018) the reasons for the proposal to

change the 2019 session dates would be explained and the Bureau would submit the proposals to a vote.

Action plan 2018-2021 and operationalisation of the integrated approaches (retro planning) ('30) **for discussion and decision Decision**: A timeline covering all actions would be submitted the Bureau to help to assess any improvements. **Decision:** A common domain (ingo-coe.org) has been set up which will allow for separate e-mail addresses for members of the Standing Committee and the Committees. Richard Pirolt would take care of giving out the e-mail addresses during the session.
