#### Framework text

The Education and Culture Committee of the Conference of INGOs of the Council of Europe has begun a three-year mandate during which it will focus on producing a multifaceted publication setting out an up-to-date definition of European cultural identity.

The above focus has been chosen in the light of worrying developments:

- the return of populist movements, which, in turn imply the existence of an identity crisis in Europe.1 The discrepancy in Europe between the economic and political spheres is pushing our societies towards openly national/nationalist isolationism rather than harmonious living and is creating a vacuum for the growth of populist parties. We have a duty, as defenders of interculturalism, to respond to our populations' thirst for identity not by dividing our citizens, but by bringing them together.
- In a context where globalisation has led to imbalances, populism and violence, the Council of Europe is a benchmark for unity, vigilance and solution-finding, both reducing discord and guaranteeing the protection of human rights. As defenders of the rule of law and the values of democracy, we have a duty to propose a modern account of the various ingredients of European cultural identity.

The definition we build will aim to reflect European plurality and perpetual construction, bringing together past and future, memory and change. It will include the roots of European tangible and intangible heritage, such as humanism, democracy, citizenship and human rights, all of which are defended by the Council of Europe. It will strive to promote intercultural dialogue. It will include the idea that Europe is a living organism evolving in a constantly changing, even unstable, environment. Our ability to transform destabilising factors, such as the arrival of new populations, into opportunities depends on the robustness of our shared convictions.

Our aim is therefore the following: to generate from within civil society a multifaceted definition of European cultural identity that will renew our shared values. Terms such as 'definition' and 'identity', which are inherently rigid, must not mislead: we do not aim to inscribe who we are in stone. The proposed publication aims to provide food for thought that everyone (individuals, towns, states, institutions) may appropriate, thus encouraging a variety of unique, open-minded and civic approaches to diversity in our contemporary intercultural world.

In this context, the Education and Culture Committee has decided to organise a discussion between INGOs and European political actors (ambassadors, ex-ministers etc.) on the construction of these modern foundations of European cultural identity.
