- ✓ the convention was **ratified** in 2007


Elaboration of national policy –

Sustainable Development Strategy of Latvia until 2030

Latvia 2030 was approved by Parliament in June 2010 and it defines state spatial priorities, territories of national interests and includes **“Spaces where nature protection, landscape, natural and cultural values are concentrated”**

Process of elaboration of the Strategy

Responsible institution for Landscape policy – Ministry of Environmental Protection and Regional Development (MoEPRD)

In 2011 **A working group** that includes representatives from ministries, planning regions, as well as universities and NGOs, was established for elaboration of the Strategy

Landscape Policy Strategy was approved by the Government in 2013

Aim and priorities of the Strategy

To identify and plan the necessary measures and define the competences of the parties involved in the implementation of the convention

Priorities:

1. Improvement of landscape governance and legislative framework
2. Building of understanding about landscape values and enhancement of education, expert training and research in the field of landscapes.

Most important actions of the Strategy

- ✓ Define valuable landscapes on national and local level;
- ✓ Prepare landscape plans for nationally valuable landscapes;
- ✓ Prepare electronic Landscape Atlas;
- ✓ Prepare suggestions for improvement of legislative framework in spatial planning;
- ✓ Prepare guidelines for evaluation, management and planning of landscapes at local level;
- ✓ Organise different activities for society about landscapes.

First evaluation of Strategy

In 2017 a first mid-term evaluation of the Strategy was carried out and a report was prepared by MEPRD.

The report includes information relating to the implementation of priorities of Strategy and also implementation of the convention in local municipalities.

Activities in local municipalities

A lot of practical activities on the implementation of the convention, such as site greening, joint landscaping, competitions for the most treasured house and others - mostly planned and implemented in the short or medium term up to 7 years

A long-term challenge (over 7 years) - landscape planning in spatial development documents:

- Spatial Development Strategies
- Territorial plans

Spatial Development Strategies




- The importance and value of landscapes have been described by about 80% of local municipalities
- There is a tendency that municipalities near the capital describe the value of landscapes less frequently than the average of all Latvian municipalities

Territorial plans




- More than 90% of the Territorial plans include general conditions for the preservation of landscapes
- Only 50% of these plans have spatially-defined valuable landscapes with specific conditions

- ✓ For 6th Session of Landscape Award of the Council of Europe, Latvia is organising the national selection in 5 regional contests

- handing in historical and current photos, sharing memories and future wishes


2nd phase – Development of electronic storage for landscape treasures

3rd phase – Regional discussions and gala forum with exhibitions






Public participation – unexpected activity in 1st phase


