Resolves as follows:

- 1. The financial statements of the Enlarged Partial Agreement on Sport for the year ended 31 December 2017 are approved (CM(2018)100 add, page 41).
- 2. The unexpended appropriations for the financial year 2017 amounting to €6 288.65 as shown in the budgetary management accounts (CM(2018)100 add, page 41) presented by the Secretary General, are cancelled.
- 3. Approval is hereby given to the apportionment of the 2017 financial year net surplus of €6 288.65 among the members of the Enlarged Partial Agreement, as indicated in the appendix to this resolution.
- 4. Having regard to the Programme and Budget for 2018-2019 (CM(2018)1-rev);

Resolves as follows:

1. The budget of expenditure and the budget of receipts for 2019, totalling €814 100 according to Table A appended hereto are hereby approved on a provisional basis.

- 2. Approval is hereby given to the apportionment, among the states which are members of the Enlarged Partial Agreement on Sport of the contributions for 2019 totalling €814 100 according to Table B appended hereto.

Appendix V

Summary of the intervention by Mr Zoran Verovnik, Chair of the EPAS Governing Board

Different to some other declared European institutions, the Council of Europe is a true house of democracy and human rights. EPAS is a proud part of it and following an evaluation within the framework of its 10th anniversary in 2017, EPAS focuses on and aims to promote a more ethical, more inclusive and safer sport in Europe. This work continues in 2018.

The flagship event on our programme of activity is the 15th Council of Europe Conference of Ministers responsible for sport, which will take place in Tbilisi, Georgia, on the 16 October 2018. The conference will provide an excellent and timely opportunity to discuss the issue of good governance (alternative term being "corruption") in sport, as well as the question of human rights in sport. The Ministers responsible for sport from the 50 states parties to the European Cultural Convention and from partner states of the Council of Europe, as well as representatives from the world of sport and from other international organisations involved in sport, have been invited to take part in the conference (the GR-C was informed about this conference on Tuesday, so I won't go into any further detail).

In the context of the afore-said standards of the CoE, and being a house of democracy and human rights, EPAS has drafted its work around three core pillars, **Ethical sport**, **Inclusive sport** and **Safe sport**:

Ethical sport

- EPAS is involved in the <u>International Partnership against Corruption in Sport</u> consisting of – among other stakeholders – the OECD, the UNODC and the IOC: the CoE/EPAS co-ordinates Task Force 3. This task force aims at developing common benchmarks with good governance indicators to support sport organisations and public authorities to address risks of corruption – e.g. term duration/limits, transparency, financial reporting, conflict of interest.

Several meetings already took place and more are planned in 2018, including meetings of the European contact group.

- EPAS has set up a <u>database on alleged corruption cases</u> DACCS. 84 new alleged corruption cases were detected in 2016. The cases of 2017 are currently being analysed.
- EPAS co-operates with Play the Game in the framework of the <u>Sports Governance Observer (SGO)</u> project. The SGO is a benchmarking tool that enables national and international sports leaders to improve the governance of their federation.
- EPAS took over the follow-up of UNESCO's <u>MINEPS/Kazan Action Plan</u> (= Unesco's conference of sports ministers): CoE/EPAS co-ordinates Action 3 of the Action Plan which will develop international guidelines on sport integrity (covering doping, discriminations, manipulations, corruption, sexual violence etc.). This process will provide an opportunity to promote the Council of Europe's expertise in addressing sport integrity issues at global level.

Inclusive sport

- EPAS has started preparatory work for its <u>diversity conference 2019</u> on <u>gender equality</u> which will be organised in close co-operation with our ALL IN joint project. The project "<u>All In: towards gender balance in sport</u>" is an EPAS project which started in April 2018 and will last until October 2019. It is a joint project, which is run thanks to support from the EU. Its aim is to roll out a data collection campaign on the commonly agreed gender equality indicators. This project helps monitor the Recommendation of the Committee of Ministers to member states on gender mainstreaming in sport (2015/2) and helps to support member states with useful data for steering their gender equality policies in the field of sport.
- EPAS is finalising the publication of a good practice <u>handbook</u> on <u>inclusive and innovative</u> approaches to physical education and sports training to promote diversity in sport.
- EPAS organised <u>evaluation visits</u> on the <u>European Sports Charter</u> to Georgia (February 2018) and Norway (March 2018).
- EPAS launched the <u>Internet Platform</u> of project promoters using sport as a vehicle to facilitate the <u>inclusion of migrants</u> in the host country. Some 40 projects were uploaded. A meeting of these project promoters is foreseen in the second half of 2018 to exchange ideas and information and to share good practices.

Safe sport

- CoE/EPAS launched the <u>Start to Talk</u> initiative in April 2018 in Madrid to fight sexual violence and harassment in sport. Start to Talk is a follow-up initiative of the "Pro Safe Sport" and "Pro Safe Sport+" joint projects. The Committee of Ministers was already informed about this initiative. We are now in the process of identifying EPAS member states which are interested in launching a national campaign, developing awareness-raising events or enhancing their policies and standards. EPAS will provide capacity building and technical assistance to implement a Start to Talk campaign.
- A pool of child protection experts was set up. A conference will be organised in the second half of 2018.

Particular challenges

- One EPAS member state withholds its annual fee.
- Withdrawal of Denmark
- Seconded official on long-term sick leave since January 2018

Co-operation with the sports movement

- Co-operation with the sports movement takes place through our Consultative Committee, which gathers a diverse set of sports organisations from across Europe and beyond.
- The MoU with UEFA, and the future MoU with FIFA, will offer new opportunities in addition to the already signed MoU with WADA (signed at the 14th Conference of Ministers in 2016 in Budapest). EPAS is about to conclude a partnership agreement to become a partner of MESGO, a graduate training course in sport management and governance, organised by five universities. The

CoE standards and actions in the field of sport will be promoted to executives from sports organisations as part of the curriculum of this training course.

Following the enumerated actions and programme activities we can conclude that the strength of EPAS lies in its INCLUSIVENESS and OPENNESS to the sports movement and the NGO structures.
