# **Enlarged Partial Agreement on Sport (EPAS)**

# 14th meeting of the Statutory Committee

10 November 2017, 14:00 – 16:00

Committee of Ministers room Palais de l'Europe, Strasbourg

# **Decisions**

The Statutory Committee, under the terms of Article 5 of the Statute of the Enlarged Partial Agreement on Sport (EPAS), composed of the representatives to the Committee of Ministers of the member states of the Agreement<sup>1</sup>, chaired by Mr Rémi Mortier, Ambassador Extraordinary and Plenipotentiary, Permanent Representative of Monaco, held its 14<sup>th</sup> meeting in Strasbourg on 10 November 2017. The list of participants is featured in **Appendix I** of this document.

# The Statutory Committee:

I. Adopted the agenda as it appears in the **Appendix II** to this document;

- II. Noted the verbal report presented by the Secretariat concerning membership and observer requests to EPAS by new countries, international sports federations and sport NGOs;
- III. Noted the verbal report presented by Mr Frédéric Sanaur, Chair of the EPAS Governing Board, concerning the present priorities and ongoing activities of EPAS (see **Appendix IV**);
- IV. Took note of the total amount of members' compulsory contributions to EPAS foreseen for 2018;
  - At the request of a delegation, amended the Draft Programme and Budget in order to clearly reflect EPAS's commitment in supporting ratifications of the Convention on the manipulation of sports competitions and to mention the list of non-governmental partners;

- Took note of the 2018-2019 biennial programme, as well as the draft budget for the period to 31 December 2018 for this Enlarged Partial Agreement;
- Took note of the draft 2019 budget, in conformity with the biennial programme, and took note of Resolution EPAS/Res(2017)2 as it appears in **Appendix III** to this document;
- Agreed that a final version of these documents will be submitted to the Statutory Committee for adoption by written procedure, once the Ministers' Deputies will have taken the decision concerning adjustments to the ordinary budget.
- V. Noted that the decisions concerning the salary adjustment will be taken based on the general decision of the Committee of Ministers within the framework of the ordinary budget, without increasing the budget envelope.
- VI. Agreed that the date of the next meeting of the Statutory Committee will take place in September 2018, the exact date being communicated in due course by the Secretariat.

# DRAFT Resolution EPAS-Res(2017)2 concerning the Enlarged Partial Agreement on Sport 2018-2019 Budgets

(Adopted by the Statutory Committee on ... 2017)

The Statutory Committee, under the terms of Article 5 of the Statute of the Enlarged Partial Agreement on Sport (EPAS)<sup>2</sup>, composed of the representatives on the Committee of Ministers of the member states of the agreement.

Having regard to Resolution CM/Res(2007)8 of 11 May 2007 authorising the establishment of the Enlarged Partial Agreement on Sport;

Having regard to Articles 19, 21 et 28 of the Financial Regulations;

Having noted the changes in the EPAS membership for 2018, compared to 2017;

Having regard to the Programme and Budget for 2018-2019 (CM(2017)130);

#### Resolves as follows:

- 1. The biennial programme 2018-2019 as it appears in document CM(2017)130 is hereby approved.
- 2. The budget of expenditure and the budget of receipts for 2018, totalling  $\$40\ 100$  according to Table A appended hereto are hereby approved.
- 3. The budget of expenditure and the budget of receipts for 2019, totalling €844 300 according to Table A appended hereto are hereby approved on a provisional basis.
- 4. Approval is hereby given to the apportionment, among the states which are members of the Enlarged Partial Agreement on Sport of the contributions for 2018 totalling €840 100 according to Table B appended hereto.
- 5. The total of the budget of receipts shall be a function of actual receipts. The budget of expenditure and receipts will be adjusted accordingly in the course of the financial year.
- 6. Took note that the salary adjustment will applied *mutatis mutandis* within the total of €840 100 on the basis of a general decision taken by the Committee of Ministers on the Ordinary budget.

Speaking Notes of Mr Frédéric Sanaur

### **UPDATE ON EPAS ACTIVITIES IN 2017**

by Mr Frédéric Sanaur, Chair of the EPAS Governing Board, on the occasion of the 14th meeting of the EPAS Statutory Committee on Friday 10 November 2017

2017 marked the 10th anniversary of EPAS, whose aim is to make sport more ethical, more inclusive and safer:

# A) More ethical:

The priority sports ethics issue is the fight against corruption in sport – follow-up to the 14th Council of Europe Conference of Ministers responsible for Sport

- 1) One of the activities resulting from the Budapest Conference is to promote good governance in sport at national level / mobilising and co-ordinating between governments
- -> To this end, EPAS is preparing a draft recommendation of the CM and a handbook on good practices concerning what can be done at national level to improve good governance in sports organisations.
- 2) Establishing dialogue with the international sports movement on standards and measures
- -> Setting up of the International Partnership against Corruption in Sport (IPACS), which brings together international organisations, sports organisations and states, along with the OECD, the IOC and the UK government. A task force co-ordinated by the Council of Europe is going to seek to draw up common standards for states and international sports organisations concerning various aspects of good governance.
- 3) Development of research to improve knowledge of corruption in sport
- -> Establishment of the Database on Alleged Cases of Corruption in Sport (DACCS) to list cases mentioned by the press and examine the action taken on them, both by sports organisations and by states.

There is also co-operation with GRECO and participation in the Sports Governance Observer project, which measures the governance of national sports organisations.

### B) More inclusive

On the occasion of EPAS's 10th anniversary, a conference was held under the aegis of the Cypriot Chairmanship of the CM to review its strategy for promoting "diversity in and through sport". A website compiling projects involving good practices in terms of integrating migrants through sport is now online.

In 2018, a joint project with the European Union should enable us to roll out on a large scale a system for collecting data on gender equality in sport, on the basis of the indicators developed in 2016.

### C) Safer

The issue of the regulation of martial arts and combat sports allowing or seeking knockouts, for instance mixed martial arts, is a source of concern for many states. A group of experts has examined the issues relating to these activities and a draft recommendation is being prepared with a view, in particular, to limiting the health risks and protecting minors more effectively. In addition,

a specific joint project has also been carried out in 2017 concerning the issue of sexual abuse of children in sport. Under the heading Pro Safe Sport +, it has enabled us to expand our range of services, tools and reference works on the issue of child protection in sport. These will be maintained and further expanded by EPAS following completion of the joint project.

EPAS is also using its network and its know-how to help promote the Convention against the Manipulation of Sports Competitions. We hope that it will be possible for the convention to enter into force quickly, in spite of the political and procedural controversies currently preventing EU member states from ratifying it. This is because the convention is central to the efforts to mobilise states, sports organisations and the sector here. It is a significant achievement of the Council of Europe and it is unfortunate that it has not yet entered into force.

Lastly, I should like to mention that there are two ministerial events on the EPAS programme of activities: a ministerial conference to be held in Georgia in October 2018 and an informal event due to be held in Moscow in July 2018 on the sidelines of the Football World Cup.

In conclusion, I should like to thank the secretariat for being so committed and enabling EPAS to keep its promises.
