The aim of this meeting is to take stock of progress made in the implementation of the Council of Europe Framework Convention for the Protection of National Minorities and to discuss the steps taken and/or foreseen to implement the recommendations contained in the Second Opinion of the Advisory Committee adopted on 23 February 2007 and in the corresponding Resolution of the Committee of Ministers adopted on 9 July 2008.
