PROGRAMME OF ACTIVITIES 2009 ON THE EUROPEAN LANDSCAPE CONVENTION

AND PLANS FOR SOME ACTIVITIES IN THE PERIOD 2010-2011

(The layout is based on the articles of the European Landscape Convention).

1. The following activities will be carried out with priority in 2009:

- 5th Conference of the Council of Europe on the European Landscape Convention (Strasbourg, 30-31 March 2009);

– Establishment of a Council of Europe Database on the European Landscape Convention on the Website of the Convention, based on the Recommendation CM/Rec(2008)3 of the Committee of Ministers to Member States on the guidelines for the implementation of the European Landscape Convention;

- Organisation of the First Session of the Landscape Award of the Council of Europe according to Resolution CM/Res(2008)3 of the Committee of Ministers;

- Organisation of the 8th meeting of the Workshops of the Council of Europe for the implementation of the Convention in cooperation with the *Swedish National Heritage Board*, on "*Landscape and driving forces*", Malmö (Sweden), 8-9 October 2009.

2. Activities with an asterisk in the table below will be developed depending on voluntary contributions or sponsorship. Delegates of the Member States of the Council of Europe are invited to make other possible proposals for the Programme of activities. Some have already been proposed for 2010-2011.
