Draft amendments to the Law on Ombudsperson, the Draft Law on Protection from Discrimination and the Draft Law on Gender Equality.

Rights 2013-2017;

- A comprehensive training –of –trainers programme on human rights for the staff members of the OIK;
- 10 round tables on modalities of co-operation between civil society and the OIK;
- Two study visits for the representatives of Kosovo human rights institutions and civil society, with the aim to familiarise the participants with the practice of application of European human rights standards at national and international levels: the first visit to the CoE headquarters in Strasbourg, the second to national human rights institutions of Poland, including Polish Ombudsman office, specialised Ombudsmen and other state organs in charge of human rights protection.
- Two study visits for the staff members of the OIK to European human rights institutions were organized: a five-day study visit for 15 representatives of the OIK to the Northern Ireland Human Rights Commission in Belfast, UK, and a visit to the Danish Parliamentary Ombudsman (Copenhagen, Denmark) was organised on 20-25 January 2014 for 15 OIK staff. The focus of both visits was on the methodology of data collection, complaints handling procedures, reporting mechanism and follow up activities taken by state authorities after receiving the recommendations from national human rights bodies.
- Translation into Albanian and Serbian of more than 30 documents on human rights including the case-law of the ECtHR, the Practical Guide on Admissibility Criteria to the ECtHR, "the ECtHR in 50 questions". The Council of Europe handbooks on the "Right to respect for private and family life", "Right to freedom of thought, conscience and religion" and on the "Right to property under the ECHR";
- A two-day in-depth media training for more than 20 OIK staff members; three two-day workshops for the civil society (20 - 25 participants each) and two one-day round tables at municipal levels on public outreach.
- A three-day training seminar for participants from OIK and civil society on how to carry out preventive visits against illtreatment to places of deprivation of liberty and on reporting techniques;
- An international conference "Complementarity of Purpose: Ombudsperson Institutions and the judiciary for the protection of Human Rights — European best practice and regional experience" was organised in co-operation with the UN OHCHR stand-alone Office in Kosovo. The conference's objective was to

bring together the representatives of the National Human
Rights Institutions, judicial bodies, the Constitutional Courts,
international organisations and the civil society from Kosovo
and South-eastern Europe to share their experience, challenges
and best practices.
