## Council of Europe | Study on Violence in Youth Institutions

## Aim

The 47 *member states* of the Council of Europe will be invited to inform us 1) on their knowledge of the prevalence of violence in youth institutions in their country and 2) on their knowledge of the compliance with the European rules for juvenile offenders subject to sanctions or measures as far as violence against juveniles in institutions is concerned.

## Study proposal

First, we selected the most essential topics to obtain a useful overview of the current state of affairs on this subject in the 47 member states. Second, we designed a study method to effectively obtain a large amount of reliable data in all 47 member states. Third, we designed the questionnaire.

After the meeting on the 25<sup>th</sup> of September 2013, we would like, firstly, to improve the study proposal by using the comments of the PC-CP members; secondly, to develop the design of the practical data collection that is realizable regarding available resources; thirdly, to perform a pilot.

## Method

- 1. Via the Council, 47 contact persons will be approached to participate
- 2. We ask the participants to:
  - a. Collect all recent and published literature <sup>1</sup>(year 2000-2013) of studies that research violence in youth institutions<sup>2</sup>;
  - b. To summarize the results that were found in their studies, following the topics that we provide in a standardized list/questionnaire;
  - c. To provide important a) missing information and b) additional information regarding institutional facilities that was not found in the provided literature, in the second part of the standardized questionnaire;
  - d. To provide us with digital copies of the publications.

## Questionnaire

We would like to use a digital questionnaire. In this way, it is easier to sum op the information from the literature, as follows from the attachment (see CONCEPT Questionnaire on violence in youth institutions).

## **CONCEPT** Questionnaire on violence in youth institutions

#### Introduction

Violence in juvenile detention institutions is a wide spread phenomenon and highly problematic. One of the main conclusions of the 3rd Plenary Meeting of the Committee for Penal Cooperation (PC-CP) of the Council of Europe in March 2013 was that there is no need for additional standard setting in the field of violence in youth institutions. Instead, there is a strong need for practical measures to sharpen the existing rules and develop effective implementation strategies. This questionnaire forms part of a study conducted by the Council of Europe and Leiden University that aims to provide more insight in the presence of preconditions for the prevention of violence as well as effective responses to violence and to define best practices.

The study focuses on violence against juveniles in conflict with the law who are deprived of their liberty in youth institutions as part of the juvenile criminal justice system (*inter alia*, pretrial detention and incarceration after conviction). It aims to cover all forms of violence, that is: 'all forms of physical or mental violence, injury and abuse, neglect or negligent treatment, maltreatment or exploitation, including sexual abuse' (art. 19 UN Convention on the Rights of the Child), which also includes forms of ill-treatment (torture and other forms of inhuman or degrading treatment or punishment) prohibited under art. 3 European Convention of Human Rights and Art. 37 (a) UN Convention on the Rights of the Child). It addresses the following forms of violence: violence against/by juveniles by/against staff; violence against juveniles by other inmates (juveniles or adults); self-harm (see also Joint report of the Office of the High Commissioner for Human Rights, UNODC and the SRSG on Violence against Children on prevention of and responses to violence against child juvenile justice system, A/HRC/21/25, 26 June 2012).

## Procedure of this questionnaire

First, we ask the participants to collect all recent and published literature (year 2000-2013) of studies that research violence in youth institutions. Second, in order to effectively obtain a large amount of reliable data on the topic, we ask participants to summarize the literature, by means of this standardized questionnaire. We also ask states to provide us with digital copies of the publications.

The questionnaire is divided into two parts: part A dealing with information found in relevant literature on violence in youth institutions, that has been studied in your state. To summarize the results that were found in these studies, we ask states answer questions on the topics that we provide in a standardized list/questionnaire. In part B of the standardized questionnaire, we ask states to provide important missing/additional information that was not found in the literature. The final question aims to offer the opportunity to list good or best practices regarding the prevention or redress of violence in youth institutions.

Most headings and questions are self-explanatory and need no further clarification. Where explanations are necessary, they are provided in footnotes.
