General information about the Project SPCC-KY is a Council of Europe/European Union joint project, aimed to support the relevant institutions in the Kyrgyz Republic to enhance capacities in preventing and combatting corruption.

The activities of the project include:

- Raise awareness of Kyrgyz authorities on the Council of Europe anticorruption standards and its monitoring mechanism (GRECO) as well as mutual legal assistance mechanisms;
- Strengthen anti-corruption (prevention and combating) legislative framework in line with CoE treaty and soft law;
- Improve framework and capacities concerning whistleblowing protection;
- Review/update strategies on anti-corruption;
- Increase capacities to streamline policy coordination between the institutions;
- Develop anti-corruption, ethics, and conflict of interest capacities of authorities at the central and local level;
- Develop operational guidelines and methodologies for the analysis and the management of the asset declarations;
- Develop sectoral anti-corruption assessments and plans of action;
- Review of investigation methodologies and operational procedures on corruption related offences aimed at increasing their efficiency;
- Train the trainers and members of the judiciary, prosecution and law enforcement on specialised economic crime related investigations and

adjudication;

• Train judiciary, prosecution and law enforcement on the application of code of ethics/conflict of interests.

The main beneficiary institutions in Kyrgyzstan are: the General Prosecution Office, the Defence Council, the Anti-corruption Council of the Government and the Department to Prevent Corruption; the Ministry of Justice; the Supreme Court; the Financial Police, the Department of Specialized Expertise of the Parliament.
