GREVIO agreed to invite state representatives of Albania and Denmark to attend its next meeting in order to conduct dialogues on the state reports.

4. <u>Agenda item 14</u> Exchange of views with the Council of Europe Commissioner for Human Rights, Nils Muižnieks

In the light of a number of recent policy and legislative developments surrounding the issue of "gender" and the decriminalisation of gender-based violence against women, which could be perceived as undermining the Istanbul Convention, and following the exchange of views with the Commissioner for Human Rights, GREVIO agreed on the text of a public statement to be issued in their name, on the occasion of International Women's Day (8 March 2017).

5. Agenda item 16 Proposal for Amendment to the Rules of Procedure

GREVIO agreed to amend its Rules of Procedure, as set out in document GREVIO (2017)5.
