### Up to 200 Prison Staff Trained on Managing Prisoners with Mental Health Problems



From 7 to 15 February, the Council of Europe and European Union organised training sessions for 8 groups of prison directors and other non-medical personnel of the penitentiary system on managing prisoners with mental health problems. In total, up to 200 participants were trained from different prisons of East as well as West Georgia. Participants learnt about different mental health related issues in prisons, including assessment and treatment approaches with psychiatric patients, medical examination upon admission to prison, psychiatric care and treatment plans, therapeutic and rehabilitative psychosocial activities in prison, etc.

## Increasing the number of trained medical staff on documenting the injuries



On 4-6 February 2017 the Council of Europe Office in Georgia and European Union Delegation organised two day training sessions for the doctors working in the temporary detention isolators of the Ministry of Internal Affairs of Georgia.

During the training the participants received the comprehensive knowledge on how to document the injuries inflicted upon the alleged torture and other cruel, inhumane and degrading treatment or punishment of prisoners according to the recently approved instructions for the doctors.

## First Training Programme in Georgia for Psychiatric Nurses

## Support to the Police Academy to enhance learning process for Temporary Detention Isolators' staff

## Development of the tools for Suicide Prevention Programme



The Council of Europe Office in Georgia and European Union Delegation are continuing to support the Ministry of Corrections in successful implementation of the Suicide Prevention Programme in prisons. With the purpose of further strengthening the Programme the Council of Europe international consultants developed several tools.

Debriefing tool and protocol aiming at hot and cold debriefing for staff, to minimise stress and burnout were drafted; a form according to which the data related to the suicide as well as suicide attempts will be collected by the local coordinators and the Suicide Prevention Programme managing Council was developed.
