**FOOTBALL EMBRACES THE FIGHT
AGAINST ANTI-GYPSYISM**

Briefing note





INTRODUCTION

The Dosta° ! Campaign “Enough! Go beyond prejudice, meet the Roma!” aims to:

- raise awareness of the prejudices and stereotypes concerning the Roma;
- to bring non-Roma closer to Roma citizens by promoting understanding and active participation in breaking down the barriers caused by prejudices and stereotypes;
- fight against anti-Gypsyism.

It was created by the Council of Europe under the joint Council of Europe and European Commission programme on Roma in South- Eastern Europe “Equal rights and treatment for Roma in South- Eastern Europe”(2006-2007). Since 2007 the campaign has been extended to all Council of Europe member states. Since then 18 Council of Europe member States have joined the campaign.

° Dosta means “enough” in the variant of the Romani language spoken in the Balkans, where the campaign was initiated..

In September 2016, the Dosta! Campaign joined UEFA's RESPECT Campaign to reinforce the fight against anti-gypsyism, racism and violence and in particular the violence against women and children.

Furthermore it aims to raise awareness of all aspects of racism and discrimination in football among members of the football family, to propose practical solutions addressing the issue of discrimination in football and to share examples of good practices involving different parties in different settings – e.g. clubs, NGOs and fan groups.

The campaign is also reaching out to supporters online through a dedicated dosta.org website created in 30 languages.

In September and October 2016, the Dosta! & RESPECT Campaign during the opening ceremonies of UEFA games in Romania was promoting the fight against anti-gypsyism at stadiums. Such activities are sending out strong and decisive message against discrimination. ”
