### **List of Decisions**

The European Committee on Crime Problems (hereafter CDPC), meeting in Strasbourg under the Chairmanship of Mr Jesper Hjortenberg, decided:

#### 1. Opening of the meeting

 to take note of the opening address of Mr Jan Kleijssen, Director of the Information Society and Action against Crime Directorate, Directorate General of Human Rights and Rule of Law, on the most recent developments in the Council of Europe and in the Directorate, in particular those activities relevant to the work of the CDPC;

#### 2. Adoption of the draft agenda

- to adopt the agenda without amendments (the list of participants and the agenda appear in Appendices I and II respectively);

#### 3. Future activities and priorities of the CDPC for 2014-2015

- to instruct its Bureau to prepare a preliminary draft terms of reference of the CDPC for the years 2016-2017 to be approved at the next plenary session in June 2015, taking into account the discussions held during the plenary session;

#### 4. Review of Council of Europe legal instruments in criminal matters

#### a. <u>Review of the Council of Europe Conventions within the direct responsibility of the CDPC</u>

 to take note of the information provided by Mr Carlo Chiaromonte, Secretary to the CDPC, on the state of play concerning the process of reviewing CoE conventions in criminal matters and in particular on the document containing information about the conventions under the direct responsibility of the CDPC;

- to take note of the presentation made by Mrs Marie Pfammatter, Ph.D. in Law, LL.M., (BMGavocats and University of Geneva) and Mr Alessandro Chechi, Ph.D. in Law, (Art-Law Centre, University of Geneva), on the European Convention on Offences relating to Cultural Property (ETS No. 119) and thank them for the excellent presentation;
- to examine the document prepared by the Secretariat, make some comments on its structure and contents and propose amendments to it;
- as regards the five conventions (plus one protocol) under the direct responsibility of the CDPC:
  - 1) not to proceed, for the time being, with the updating or modernisation of the Convention on the Punishment of Road Traffic Offences (ETS No 52);
  - 2) to continue reflecting on the Convention on the Compensation of Victims of Violent Crimes (ETS No 116) with a view to its possible updating and modernisation;
  - 3) as regards the European Convention on Offences relating to Cultural Property, that the subject matter is of interest and to instruct the Secretariat to prepare, together with Mrs Pfammatter and Mr Chechi, a memorandum addressing some "core" questions to member States related to the main issues highlighted in the document, to send this memorandum to all member States and to instruct the Bureau to examine the replies received and make concrete proposals for the CDPC's next plenary session;
  - to postpone its final decision with regard to the Convention on Insider Trading (ETS No. 130) and its Protocol (ETS No. 133) considering that updating these two texts may not be of particular interest for European Union member States that already apply European Union legislation on this issue;
  - 5) not to proceed, for the time being, with the updating or modernisation of the Convention on the Protection of Environment through Criminal Law (ETS No. 172);
- on the basis of the discussions held, to instruct its Bureau to draw some precise conclusions on each convention to be presented at the next CDPC plenary session;

#### b. <u>Review of the CoE Conventions by other CoE bodies</u>

- to take note of the presentation by Mr Bragi Gudbrandsson, Chair of the Committee of the Parties to the Lanzarote Convention, holding an exchange of views with him on subjects related to the work carried out by the Lanzarote Committee;
- to examine the responses provided by other committees/bodies responsible for criminal law conventions and to endorse the outcome of these responses with regard to the follow-up to be given to the relevant conventions;

# 5. Drafting a document/report with a view to identifying new forms of behaviour that have emerged in the recent past in connection with the use of modern technologies and that have brought to light possible lacunae in the existing criminal offences/law

- due to the fact that the preliminary draft report prepared by the consultant on this issue was completed only a few days before the CDPC plenary meeting and is currently being translated into English, to instruct its Bureau to examine the content of this preliminary report and of the questionnaire prepared by the consultant and present these documents at the next CDPC plenary session in 2015;

# 6. Follow-up to the 31st Council of Europe Conference of Ministers of Justice (Vienna, 19–21 September 2012): "Responses of Justice to Urban Violence"

#### a. International conference on urban violence (Lisbon, 23-24 October 2014)

#### b. Responses of justice to urban violence involving juveniles

 to take note of the information provided by the Secretary to the CDPC, Mr Carlo Chiaromonte, on the follow-up to the last Conference of Ministers of Justice and in particular 1) on the international conference that took place in Lisbon on the subject of "Urban violence" on 23-24 October 2014 and 2) the developments related to the drafting of a working paper and the questionnaire prepared by a consultant on the question of responses of justice to urban violence involving juveniles;

- to take note of the presentation by Prof Sebastian Roché, Head of the Security and Cohesion Department at the University of Grenoble, who delivered a keynote speech at the Lisbon Conference, holding an exchange of views with him on questions related to urban violence;
- that the outcome of the Lisbon Conference and in particular its conclusions should be brought to the attention of the Committee of Ministers of the Council of Europe as one of the main results of the follow-up to the Vienna Conference;
- that a small working group should be set up under the auspices of the CDPC to continue working on some of the most important issues related to the general question of urban violence, as highlighted in the Conclusions of the International conference that took place in Lisbon and that the findings of the working group should be presented at the next CDPC plenary meeting;
- as regards the work carried out by the consultant on the issue of responses of justice to urban violence involving juveniles, to instruct the Secretariat to send the final amended version of the questionnaire to all member States;
- to instruct the Bureau to examine the replies received and to prepare a summary of these replies for the next CDPC plenary in June;

# 7. Council for Penological Co-operation (PC-CP) - Exchange of views with the Chairman, Mr Mauro Palma

- to take note of the information provided by Mr Palma concerning the main outcome of the last PC-CP meetings, holding an exchange of views with him;
- to take note of the reports on 1) violence in institutions for juvenile offenders, 2) the use if quasicompulsory measures as alternatives to imprisonment and 3) the use of restorative justice in prison and to instruct the Secretariat to send the first and the third document to the Committee of Ministers for information;
- to request that the PC-CP elaborate draft criteria to constitute valid consent given in the context of quasi-compulsory framework, for further consideration by the CDPC;
- to approve the proposal made by the PC-CP plenary to keep the issue of restorative justice on the PC-CP agenda and to broaden the scope of the study to include also the use of restorative justice in probation work;
- to approve the proposal made by the PC-CP plenary to include the issue of radicalisation in prisons and probation in next year's work programme;

# a. Follow-up to the 19th Council of Europe Conference of Directors of Prison and Probation Services, 17-18 June 2014, Helsinki and the next conference

- to take note that the 20th Conference of Directors of Prison and Probation Services, "Strategic Challenges in Prisons and Probation", will take place in Bucharest on 9-10 June 2015;

## b. Evaluation of the Committee of Ministers recommendations in the field of execution of penal sanctions and measures

 to approve the proposals made by the PC-CP for review, promotion and implementation of the relevant Committee of Ministers recommendations;

#### 8. Prison overcrowding

 to take note of the setting up of a Drafting Committee on Prison overcrowding which will hold its first meeting on 8-9 December 2014 in Strasbourg;

#### 9. Promotion of the Integrity of Sport against the Manipulation of Results, notably match-fixing -Feasibility of an Additional Protocol to the Council of Europe Criminal Law Convention on Corruption (ETS No. 173)

 taking into account the decision by the GRECO in September 2014, and on the basis of the previous work carried out by the CDPC on the issue and in particular of the replies by member States to a questionnaire sent to all CDPC delegations according to which "in the majority of countries that replied, corrupt practices in the non-profit sector are covered by existing legislation", to confirm its view already expressed in May 2013 that, at this point, there appears to be no need for an Additional Protocol to the Council of Europe Criminal Law Convention on Corruption and to instruct the Secretariat to transmit this CDPC opinion to the Committee of Ministers in response to their request contained in paragraph 4. of the CM Decisions taken at the CM 1145th meeting of 13 June 2013;

- to draw attention to the fact that GRECO is welcome at any time to return to the CDPC with a renewed and reasoned opinion as to the need for an Additional Protocol;

# 10. Document/guidelines containing "Model provisions" defining a certain number of rules to be duly considered by the expert committees in their drafting work as the base to be followed during future negotiations of any possible convention on a criminal law matter

- to take note of the information by Mr Hans-Holger Herrnfeld on the work carried out so far in the drafting of the document "Model provisions project";
- to examine the document "Model provisions project" and make some proposals to amend it;
- to instruct the Secretariat, together with Mr Hans-Holger Herrnfeld, to revise the documents on "Model provisions project" and "Elements for an Explanatory Report", following the outcome of the plenary session debates, and to send these documents to all CDPC delegations for possible written comments (two months deadline) ahead of a final revision of these two documents that will be sent to all CDPC delegations well in advance of the next plenary meeting;

# 11. Committee of Experts on the operation of European conventions on co-operation in criminal matters (PC-OC)

- to take note of the list of decisions of the 667th meeting of the PC-OC held on 18-21 November 2014 and of the information provided by Ms Anita van de Kar, Secretary to the PC-OC, in particular on the implementation/assessment of the conventions for which the PC-OC is responsible;
- to give the PC-OC mandate to prepare a draft protocol to amend the Additional Protocol to the Convention on the Transfer of Sentenced Persons;
- to approve the proposal made by the PC-OC to ensure a follow up to the special session on international co-operation as regards the seizure and confiscation of proceeds of crime, including the management of confiscated goods and asset sharing, which was held on 19 November 2014 as a first follow up to the White Paper on Transnational Organised Crime;
- to adopt an opinion based on the opinion of the PC-OC on recommendation 2.2 of PACE Recommendation 2041 (2014) on "improving user protection and security in cyberspace" (possible update of ETS No. 30) and instruct the Secretariat to send it to the Committee of Ministers;

#### 12. Activities related to transnational organised crime; "White Paper"

- to take note of the presentation made by Ms Ianina Gabriela Lipara, Legal Specialist, European Judicial Network;
- to examine the document prepared by the Secretariat containing general elements that should be included in the future Action Plan, to discuss its content and to make some proposals for amendments to the document;
- to instruct the Secretariat to send the document to all CDPC delegations for possible comments by 28 February 2015;
- to instruct the Secretariat, together with the assistance of a consultant and the Chair of the CDPC, to prepare a draft Action Plan to be submitted to the CDPC at one of its next meetings;

#### 13. Terrorism

- to take note of the information provided by the co-Secretary of the CODEXTER, Mr Kristian Bartholin, concerning the activities carried out by the CODEXTER, and in particular the future work on foreign terrorist fighters;
- to express its willingness to collaborate closely with the CODEXTER in any other activity of common interest;

#### 14. Information provided by the Secretariat

- to take note of the information provided:

#### a) Medicrime:

- by the co-Secretary of the CDPC, Mr Oscar Alarcón, concerning the activities carried out by the Criminal Law Division to promote the MEDICRIME Convention and to encourage more ratifications of it;
- to welcome the fact that Moldova is the 4th country to have ratified the MEDICRIME Convention (14 August 2014);
- the conclusions on the 3rd regional conference entitled "MEDICRIME Convention: a key took against organised crime", held in Skopje, "The former Yugoslav Republic of Macedonia", on 19-20 June 2014;
- to invite delegations to provide the Secretariat with: a) the contact details of the Focal Point at national level (and Ministry involved) responsible for the MEDICRIME Convention; b) the translation, where it exists, of the MEDICRIME Convention into their official language.

#### b) Trafficking in organs

- by the Spanish delegation that Spain will host the opening ceremony for signature of this convention in Santiago de Compostela on 25 March 2015;

#### c) Dangerous Offenders

 concerning activities carried out by the Criminal Law Division, to promote the Recommendation CM/Rec(2014)3 of the Committee of Ministers to member States concerning dangerous offenders;

#### d) Cybercrime

- the Bureaux of the CDPC and the TC-Y had a working breakfast meeting on 4 December and discussed matters of common interest;

#### e) Information on the latest developments in the cooperation

 by Ms Tanja Rakusic-Hadzic on the on-going co-operation projects in the field of prisons and police, and in particular two multilateral meetings on health care in prisons and on electronic monitoring;

#### 15. Elections

- to elect Ms Tanja Trtnik (Slovenia) as a member of the Bureau;
- to renew the mandates of the Chair and vice-Chair of the CDPC, respectively, for one year;
- to renew the mandate of Mr Antanas Jatkevicius (Lithuania), PC-CP Working Group member, for two years;

#### 16. Any other business

Request by Denmark for a friendly settlement procedure:

1. the CDPC, sitting under the Chairmanship of its vice-Chair, received the request for a friendly settlement put forward by one delegation in accordance with the Appendix to Recommendation No.R (99) 20 of the Committee of Ministers to member States concerning

the friendly settlement of any difficulty that may arise out of the application of the Council of Europe conventions in the penal field;

- 2. the CDPC took note that it was informed by the same delegation that since bilateral dialogue had so far not given results, it had decided to request a friendly settlement;
- the CDPC took note of the setting in motion of the procedure in accordance with Article 10 of the Appendix to Recommendation No. R (99) 20 by the requesting State and of the readiness expressed by two other delegations to participate in a possible working party in line with the Recommendation once this procedure also involves the requested State;
- 4. the CDPC also took note that the other delegation involved in the difficulties under review stated that although it valued highly multilateral co-operation within the CDPC, it opposed categorically the consideration of the matter at hand at a multilateral level. The same delegation expressed a clear preference to address the issue bilaterally and stated its readiness to continue bilateral dialogue;

The CDPC noted that Denmark made the following statement:

Denmark notes that Turkey opposed the consideration of the matter at multilateral level. Denmark also notes that Turkey expressed a clear preference to address the issue bilaterally. On this background, Denmark expects that Turkey swiftly will provide Denmark with precise and satisfactory answers to our legitimate questions and requests in the matter at hand.

The CDPC noted that Turkey made the following statement:

Turkey is at the forefront of the global counter-terrorism efforts. It remains committed to combatting terrorism in all its forms under the all-inclusive road map formulated by the UN Global Counter-Terrorism Strategy. In this vein, Turkey has become party to all international instruments and concluded bilateral agreements with over seventy countries. Turkey expects all members of the international community to fully comply with their obligations in this regard. Meanwhile, the matters which are under consideration at bilateral level between the relevant countries need not to be brought to the floor of CDPC.
