List of Decisions

- The Bureau decided to instruct the Secretariat to continue its work on elaborating the draft terms of reference of a working group on Jurisdiction and a roadmap.
- The Bureau appointed the Vice-Chair, Eric PLANKEN, the Netherlands, to represent it at the CoE co-organised workshop "Cooperation against Cybercrime in South Asia" on 5-6 April in Colombo, Sri Lanka.
- The Bureau decided to move the T-CY Plenary session form June to 23-24 November 2011, in order to organise joint celebrations with the Project on Cybercrime (Octopus Conference) of the 10th Anniversary of the Cybercrime Convention on 23 November.

The Bureau instructed the Secretariat to produce promotional material aimed at the decision-makers, if possible, to be ready for 23 November 2011. The Bureau will propose possible names of experts to be involved by the end of March.

- The Bureau instructed the Secretariat to prepare a new version of Preliminary Draft Opinion on criteria and procedure for accession of non-member states to the Budapest Convention by the end of April.
- The Bureau instructed the Secretariat to draft a new version of the document by Mr VERDELHO, Portugal, setting out a list of priorities for the forthcoming years by the end of April. The reworked document should be presented for discussion at the 2011 Plenary.
