#### **SUMMARY MEETING REPORT**

Document prepared by the Directorate General Human Rights and Rule of Law

#### **BRIEF FOREWORD**

#### The PC-GR-DD:

- adopted the agenda;
- took note of the information provided by the Secretariat on the state of play of the draft recommendation on dangerous offenders and its commentary;
- welcomed the draft recommendation on dangerous offenders and its first preliminary draft commentary, in particular taking into consideration the short time-frame within which it has been prepared;
- took note of the comments made by the CDPC on the preliminary draft recommendation on dangerous offenders as well as the comments made by the Registry of the European Court of Human Rights (ECtHR);
- examined in detail the draft recommendation and its preliminary draft commentary and made general comments, in particular:
  - considered and confirmed the scope, definition and basic principles of the draft recommendation on dangerous offenders;
  - considered including references to the existing Council of Europe recommendations on probation rules and to the European Prison Rules in the draft recommendation;
  - reached a common agreement on the definition of violence, treatment and secure preventive detention;
  - agreed to develop further some concrete rules in the commentary of the draft recommendation;

- developed some rules in Part VI of the draft recommendation entitled "Monitoring, staff and research" and introduced a new part devoted to the follow-up to be given to this recommendation:
- adopted the draft recommendation and agreed that the Secretariat would fine-tune the commentary of the draft recommendation in light of the discussions held.
- 1. The Ad hoc drafting group on Dangerous Offenders (PC-GR-DD) held its third and last meeting in Paris on 18-20 September 2013. The list of participants is appended to this report (Appendix II).

## I. Opening of the meeting and adoption of the agenda

2. The agenda was adopted (see Appendix I).

# III. Information by the Chair and the Secretariat

- 3. Mr Sławomir Buczma, Chair of the ad hoc drafting group, welcomed all the participants and apologised for those representatives who were not present at the meeting.
- 4. The Chair welcomed the presence of the observers to the ad-hoc drafting group, in particular the Chair of the PC-CP, Mr André Vallotton, and the representative of the CPT, Mr James McManus. He also welcomed and thanked the representative of Penal Reform International, Mr John Podmore, for taking an active part in this last meeting of the group.
- 5. With a view to properly clarifying to the members of the group all the stages of the drafting process and the methodology to be used during the 3rd meeting, the Chair described the work carried out so far and in particular since the group's 2nd meeting:
  - the draft recommendation was presented to the plenary meeting of the CDPC in May where it was welcomed by the members of the CDPC taking into consideration the short time-frame within which the group had prepared it. The members of the CDPC examined and endorsed its content and provided some minor changes, which have been included in the draft recommendation.
  - following the 2<sup>nd</sup> meeting of the group, and in light of the discussions held, some amendments have been introduced in the draft recommendation.
  - some written comments to the draft recommendation were received from the representatives of Norway and the United Kingdom. These comments were to be presented and discussed in detail during the current meeting.
  - with a view to harmonising the whole recommendation, the Secretariat drafted a document with some proposed amendments which are be discussed.

### IV. Presentation of the preliminary draft recommendation on Dangerous Offenders

# 1. The PC-GR-DD:

- took note of the presentation provided by the Chair and the scientific expert on the draft recommendation on dangerous offenders and its commentary;
- took due account of the comments made by the CDPC on this draft recommendation on dangerous offenders;

- examined in detail each provision of both the draft recommendation and its commentary;
- agreed on the scope, definitions and basic principles of the draft recommendation. It confirmed
  that its aim is to tackle mainly those offenders who have been convicted of a very serious
  sexual or a very serious violent crime against person(s) and who present a high likelihood of
  reoffending with further very serious sexual or very serious violent crimes against person(s);
- reached a common agreement on the definition of violence, treatment and secure preventive detention:
- considered the risk assessment principle;
- identified new measures to be set up by the competent authorities in preventive supervision;
- developed some rules in Part VI of the draft recommendation entitled "Monitoring, staff and research" and introduced a new part devoted to the follow-up to be given to the future recommendation by the CDPC;
- discussed the necessity of co-ordinating the actions of various agencies and supported multiagency co-operation among prison administrations, probation workers, social and medical services and law enforcement authorities.
- 2. In the light of the discussions, the participants considered that the risk management of dangerous offenders should have the long-term aim of their safe reintegration into the community in a manner consistent with public protection from the risk posed by the offender.
- 3. The PC-GR-DD agreed on the appropriate order of the different parts, headings and subheadings of the draft recommendation on dangerous offenders and its commentary.

## VI. Other business

- 4. The PC-GR-DD:
  - decided to adopt the draft recommendation on dangerous offenders;
  - requested that the Secretariat further complete the commentary of the draft recommendation according to the comments made during the current meeting.
