Background Information on the Countries of the Visegrad Group

The very first initiatives in, what is called today Global Development education (GDE), originated already in the 1990-ies in some of the four Visegrad countries (V4), i.e. Czech Republic, Poland, Slovakia and Hungary - V4). However, the very first attempts to develop comprehensive programs in this area, in the formal and non-formal education fields, go only back to the years 2004-2006. Only in the last couple of years, different stakeholders started to engage more intensively in GDE, namely non-governmental organisations (NGO's), schools, pedagogic institutions, universities, ministries of foreign affairs and education among others. Initial multistakeholders initiatives have been established with the crucial support of national governments, development NGO platforms, European Commission (EC) and the North South Centre of the Council of Europe (NSC).

Following in the footsteps of some 'old' EU member states (EU-15), the Visegrad countries, more recently identified the need to give GDE a more comprehensive structure, to clarify the concept of GDE and to work on the improvements to integrate GDE in school curricula. Recent initiatives leading to the development of national GDE strategies or equivalent approaches, have been supported in all four Visegrad countries. In some cases, some countries have been more successful and have advanced to a larger extent with the conceptualisation of a strategic approach to GDE. Nevertheless, this challenging process to develop a comprehensive strategic document for GDE have not been formally adopted by any of the four central European countries concerned, thus leaving space for further efforts and improvements.

Moreover, an evolution has taken place in terms of understanding of GDE and its relation to Official Development Assistance (ODA) at a global level - in the 'old' EU-15 as well as in 'new' EU-12 countries. In recent years, a number of diverse concepts have emerged such as global education (GE), global development education (GDE), development education (DE) and awareness raising (DEAR) or education towards global citizenship. Since the 'new' EU-12 countries joined the European Union (EU) the primary aim of GDE has originally been to promote foreign development cooperation and projects. While these development projects have mainly been implemented in the global South, GDE projects and activities have taken place predominantly in Europe, bringing awareness to development cooperation at large. However, in recent years, many actors have further developed their understanding of GDE, emphasising the need for education towards global citizenship which is necessary for all citizens given the ever increasing interdependency of our societies, and thus, removing the aforementioned division between GDE activities in the North and development projects in the South.

Besides the focus of the EU-12, including the V4–countries, on the (common) understanding and meaning of GDE, initiatives have been carried out around other subjects related to the relatively low conscience of global issues in the societies of the EU-12 countries. The topics discussed by development education actors in this regard, have been e.g. to elaborate on the identification of the most appropriate tools for awareness-raising. Therefore, bringing the current debate at global level, to the context of the V4 countries, as well as clarifying the diverse concepts related to GDE, is crucial.

Another very important topic linked to the discourse of GDE is the funding possibilities and mechanisms of GDE. In most V4 countries, the emergence of GDE initiatives has been supported by special funding mechanisms created in the

framework of Official Development Assistance (ODA) throughout the last 5-8 years. However, the current trends and financial crisis is creating severe difficulties to gain financial support for GDE activities. As a matter of facts, budgets for GDE have been cut in several V4 countries and, furthermore, threats of shifting funding originally allocated for GDE activities to projects carried out in the global South, does exist as a realistic option. In order to break current negative trends in the V4 region, the proposed regional seminar for the central European countries, aims at brining in the current global debate in a (sub-)regional context and, thus, help in clarifying the 'raison d'être' of GDE and developing a deeper understanding of the GED concept and, furthermore, motivate the key stakeholders to engaged in and support of GDE. By bringing together multiple stakeholders (NGO activists, representatives of governmental structures and agencies, local authorities, teachers and other school actors, donors and European institutions) and creating space for interactions and discussions, exchange of knowledge and experiences, providing spaces for the possible joint initiatives, the event aspires to search answers to the following questions:

How has global development paradigm change been reflected in the Visegrad countries? How is GDE understood in this particular region? What is the vision of the respective key actors in the field on GDE? What have been the outcomes of efforts to develop GDE national strategies in the region? How can the V4 countries cooperate to foster joint efforts in advancing the development of GDE national strategies? How can such strategic approaches be put successfully into practice? What can the V4 countries learn from more experienced partners in the EU context (peer learning) as well as from the global South? How different European initiatives (initiated by e.g. NSC, EC) have been or could be utilized in V4 countries?

Objectives

- To exchange and jointly discuss existing perspectives on concepts of GDE to reach a better understanding of the concept;
- To identify common challenges in the Visegrad countries and exchange information on best practices with GDE experts from the V4 region, other European countries/institution as well as with experts from the global South;
- To provide the space and opportunities to develop joint action and collaboration within and beyond the Visegrad countries;
- To promote GDE as an integral part of education as well as of development cooperation in the Visegrad countries;
- To elaborate recommendations for furthering GDE in the V4 countries.

FoRS has been strongly focusing on GDE on the national level since its inception in 2004. More than two thirds of FoRS members are active in this area and therefore formed the following working groups: "Global Development Education" for formal education in primary and secondary schools, "Public Awareness" for non-formal education (both groups have merged recently) and "Development studies" for formal education at universities. With respect to public awareness, FoRS has acted as a partner in the campaign Czech Against Poverty that has been running since 2005 and is the most widely known campaign related to development cooperation in the Czech Republic. FoRS also contributed to the development of the national GDE strategy in 2009-2010.
