Background Information on the Countries of the South East Europe and Mediterranean region

In 2008 a Joint Management Agreement (JMA) was signed between the North-South Centre of the Council of Europe and the European Commission for raising awareness of global interdependence and solidarity through global/development education and youth cooperation in Europe and beyond.

In the framework of this JMA, a series of national and regional seminars were organised in the new EU member states between 2009 and 2011. These seminars brought together different stakeholders, among practitioners and policy-makers, with the aim to discuss the situation of global/development education in the respective country and to promote national policy recommendations and practices.

The assessment of this initiative, made in 2012, revealed the following key-findings:

Overall an interest in GE/DE in the South East Europe region could be noticed, especially among teachers and education practitioners. Yet this has not been accompanied by an adequate institutional commitment towards supporting and strengthening GE/DE. Given the lack of investment and institutional support in the field, the civil society sector is not sufficiently strong to lead the process of GE/DE policy development. As a result a long term planning at the level of policy and national education reform is still to be encouraged.

In **Bulgarian** formal educational system GE or DE are not parts of the curriculum. Citizenship education, as a component of different school subjects contains some of the thematic areas of GE and DE, such as human rights, knowledge for active citizenship etc. Through citizenship education and through school subjects, such as geography and economics, philosophy, history, GE and DE are incorporated in the curriculum and are more recognized among teachers. Even with the qualitative difference which GE and DE brings to teaching, these remain, sporadic attempts implemented by innovative and open minded school principals and teachers. Lately, along with citizenship education, also health education, education for sustainable development, and intercultural education are included in the language of a draft of a new Law on Education which is still under discussion. One more step from the CSOs and Ministry side is needed for GE and DE to become part of this new wording.

Among the Mediterranean countries, **Cyprus** has a longer tradition in development cooperation and aid. In spite of its 2006/2010 Medium Term ODA Strategy, Cyprus does not have a proper GE/DE strategy. There is continuous interest in GE/DE although there are no financial resources available. The Ministry of Education and Culture has recently established an inter-sectoral committee for Global Education, which is now meeting regularly together with CSOs to coordinate GE activities within the education system.

Similarly to Bulgaria, **Malta**'s engagement in development policy mainly emerged after its accession to the EU. In 2007, the Maltese Ministry of Foreign Affairs published the Overseas Development Policy. A national strategy for GE/DE does not exist so far but there are ongoing discussions about it between the NGO

platform SKOP and the Ministry of Foreign Affairs. According to the national report, the main challenges that Malta faces when it comes to GE/DE is "both a weak commitment from institutions and a civil society sector that is not strong enough to lead such initiatives."

Romania has been involved with global education processes at the level of teachers networks since 2001. Since its accession to the EU in 2007, it focused primarily on development cooperation policy and within this context on development education. As part of this process it has developed its National Strategy on International Development Co-operation Policy with five percent of the budget for development co-operation activities allocated to development education activities. In the follow up of the national seminar, efforts to develop a national GE/DE strategy were made; this was however done solely by the government, without a consultation process with civil society organisations.

After the political changes in Romania, lack of continuity and dialogue can be observed with regards the strategy as well as the insurance of adequate support to GE/DE. It has to be noted that a great diversity of somehow contradictory voices has appeared in the survey. On the one hand, claims that curricular reform has taken place before the seminars were started, and that the reforms did not really include GE/DE principles and approaches, on the other.

With the accession of **Slovenia** to the European Union in 2004, the parliament adopted the strategic document Resolution on International Development Cooperation of the Republic of Slovenia (2008–2015) of which development education and awareness-raising are an integral part. In 2007, the Ministry of Education and Sport prepared conceptual Guidelines for Education for Sustainable Development that represents the first official document in the field of global education. Given its non-operational and not binding character, Slovenia does not possess a national strategy that would guarantee the necessary support to GE/DE. Since the financial crisis, GE/DE projects and programmes have been cut.

In 2012, as a follow-up to this process, the 2^{nd} Global Education Congress – *Education, Interdependence & solidarity in a Changing World* - gathered practitioners and policymakers in Lisbon to assess the work achieved since the first Global Education Congress held in Maastricht in 2002 (which established an European strategy framework for the enhancement of global education to 2015) and to reflect on issues at stake to be prioritised until 2015.

Among the GE/DE activities developed since 2002, the outputs of the national and regional seminars were taken into consideration in the drafting of the Global Education Congress Strategic Recommendations covering the following five areas of work:

1) national strategy development and implementation; 2) curricular reform; 3) continuing professional development of educators; 4) quality support and monitoring; 5) campaigning and outreach.

The recommendations of the Lisbon GE Congress were also built up on the recommendation of the Council of Europe Committee of Ministers to member states on education for global interdependence and solidarity, the first legal framework for global education, adopted in May 2011.

In order to assure the continuity of this successful process, a second JMA was signed for the period 2013-2015. During this period a series of regional seminars will be organised to assess the work developed so far, namely the implementation phase of the GE/DE national strategies adopted in Czech Republic and Slovakia, and to follow up on the recommendations of the 2nd European GE Congress. In addition, kick-off seminars will be organised in EU acceding and candidate countries. A closing conference, meant to be the 3rd GE Congress, will take place in 2015.

The outputs of these regional seminars shall also contribute to the implementation strategy of the Lisbon GE Congress recommendations - to be equally monitored annually through a multistakeholder meeting - and to the definition of the agenda of the 3^{rd} GE Congress foreseen in 2015.

Objectives

Having the recommendations of the Lisbon GE Congress as an overarching framework in relation to: 1) national strategy development and implementation; 2) curricular reform; 3) continuing professional development of educators; 4) quality support and monitoring; 5) campaigning and outreach, the objectives of the regional seminar are:

- to exchange and jointly discuss existing perspectives and recent developments on the concept and practice of GE/DE, both in terms of policy making and curricula development;
- to identify common challenges in the SEE-Med countries and exchange information on best practices between GE/DE experts from the region, other European countries and/or organisations such as the NSC, EC, CONCORD/DEEEP and GENE, as well as with experts from the global South;
- to promote GE/DE as an integral part of education;
- to provide the space and opportunities to develop joint action and collaboration within and beyond the SEE-Med countries;
- to elaborate recommendations for furthering GE/DE in the SEE-Med countries and establish priorities, and if possible benchmarks, until the 3rd GE Congress in 2015.
