3. Communication by the Chair and by the Secretariat

The Committee is invited to take note of the information presented orally by the Chair and the Secretariat concerning developments of importance for its work since the 31st Plenary Meeting notably that the new Council of Europe Convention on Offences relating to Cultural Property was adopted on 5 May and opened for signature in Nicosia on 19 May. On the same day, during the Ministerial Session the Ministers of Foreign Affairs of the Council of Europe examined issues related to the Council of Europe actions on terrorism and particularly the progresses made in the implementation of the Action Plan on the Fight against Violent Extremism and Radicalisation Leading to Terrorism (2015-17) and the next steps to be undertaken in the forthcoming years. 4. Future work and activities of the CODEXTER

The Committee shall discuss its future work and activities. In particular, Delegations are invited to examine the draft new Terms of Reference for the Committee for the years 2018 and 2019. The proposed changes to the current Terms of Reference concern a general broadening of the tasks of the Committee to not only cover the legal issues related to counter-terrorism, but also prevention and de-radicalisation/disengagement. In particular, it is proposed that the Committee shall be responsible for elaborating and overseeing the implementation of a comprehensive Council of Europe Counter-Terrorism Strategy for the years 2018-2022. Among the legal tasks is the possible development of a pan-European legal definition of terrorism and the updating of the provisions on financing of terrorism contained in Convention 198. Finally, it is proposed to change the name of the Committee from the "Committee on Experts on Terrorism (CODEXTER)" to "Steering Committee on Counter-Terrorism" to better reflect the change of status of the Committee. The draft Terms of reference presented to the Committee has been prepared on the basis of the previous Terms of reference of the CODEXTER for 2016-2017 and the changes proposed appear in track changes. The Committee shall examine the new Terms of reference for the years 2018 and 2019 and approve them. This document will then be transmitted to the Committee of Ministers of the Council of Europe for final adoption.
