### Summary

Before joining Europol, for seven years I was an investigator of THB and FII linked to Africa which included collateral crimes and frequent international cooperation with other countries, police forces and institutions.

My first first duties in the Policía Nacional were as the head of a team on international relations within the Counter Terrorism Division, where I organised visits, exchanged information with bilateral Liaison Officers and multilateral organisations, and represented the CTD in international fora.
