# EUROPRIS BACKGROUND

- Formed in 2011
- 'Strengthening mutual trust in the European judicial area – A Green Paper on the application of EU criminal justice legislation in the field of detention' (Brussels, 14.6.2011, COM(2011) 327)
- Network of prison and correctional practitioners across Europe
- Promoting Professional Prison Practice
- 30 member jurisdictions
- Expert Groups, including FD909 Transfer of Prisoners and Foreign National Prisoners

# WHAT IS EPIS?

- European Prison Information System (EPIS)
- Enhancing practitioners' cooperation, networking, exchange of information and best practice and to support transparency and knowledge sharing
- Central resource of data related to prisons and corrections across Europe
- Provide insight and answers to commonly asked questions
- Platform as an expandable knowledgebase

# WHO CAN USE EPIS


- The service exists primarily to provide information to European Prison Agencies and practitioners

Accessible on a number of levels

- - Public
- - National Agencies Administrators
- - National Agency Personnel
- - Internal

# HOW IT WORKS

- Accounts restricted to authorised users only
  - Domain based permissions
  - Data can be filtered based on certain criteria
  - Comparison functions
  - Reporting

# SYSTEM FEATURES

Modular system consisting of several components:

- - Organisational and Establishment Profiles
- - Knowledge Management System (KMS)
- - Register of Experts
- - Projects
- - Benchmarking

Section 7: Technology (5 questions)

Section 8: Finance (7 questions)

Section 9: Purposeful Activity (9 questions)

Section 10: Security & Order (7 questions)

Section 11: Welfare and Cultural Issues (8 questions)

Section 12: Throughcare (2 questions)

Section 13: Head Office (6 fields)

Section 14: Head of Service (10 fields)



# THE ORGANISATIONAL PROFILE (CONT.)

Records can be created for each facility/establishment (399 to date)

Section 1: General (10 fields)

Section 2: Head of Establishment (5 fields)

Section 3: Establishment Information (7 questions)

Section 4: Welfare (5 questions)

# THE KNOWLEDGE MANAGEMENT SYSTEM (KMS)

- Addresses duplicate requests and 'lost' information
- Provides a narrative explanation of prison practices
- Questions relayed via managed process by EuroPris staff
- Average 3 questions per month
- 87 topics on the system (400+ questions, 850 responses)

# THE FUTURE

- Providing 'hands-on' training and information workshops to staff
- Further development to support the work of partners and expert groups
- Continue to encourage support for contribution (12 countries complete)
- Link data on EPIS to the e-Justice Portal, part of the Multiannual European e-Justice Action Plan
