### Strengthening the anti-money laundering institutions in Georgia

#### Who will benefit?

- ▶ Ministry of Finance (including the Revenue Service, Investigation Service and Accounting, Reporting and Auditing Supervision Service of the Ministry of Finance )
- ▶ Financial Monitoring Service of Georgia
- ▶ Chief Prosecutor's Office

#### Why is the project being run?

- ▶ Enhance compliance of anti-money laundering/countering financing of terrorism legal and institutional framework in Georgia with the applicable international standards and good practices

#### How will the project work?

- ▶ Through combination of policy/legislative and capacity building actions specifically tailored to address each of the expected aims

#### What are the expected results?

- ▶ Effective measures for mitigation of risks of money laundering and terrorism financing at the national level are elaborated
- ▶ Capacities to investigate, prosecute and adjudicate money laundering and terrorist financing cases is enhanced
- ▶ Compliance of anti-money laundering/countering financing of terrorism regulatory/supervisory legal framework and capacities of supervisors and monitoring entities to implement anti-money laundering/countering financing of terrorism obligations is reinforced

#### How much will it cost?

- ▶ The total budget is 250,000 Euros
- ▶ 90% is funded by the European Union and 10% by the Council of Europe. The programme is implemented by the Council of Europe

#### How long is the project?

- ▶ The project runs from 1 January 2018 to 31 December 2018
