Municipalities are responsible in providing Faroese lessons with financial support from the Ministry of Education. Individuals responsible and involved will share their work, teaching approach, and experiences from both teaching and interactions in the classroom with students.
14.15-15.25	Labor Market Integration Similar to other countries, having an occupation hand-in-hand with the one's qualification or education for immigrants is still a rarity in the Faroes. In this discussion, invited employers will share their experiences and the impacts hiring immigrants, a researcher from the Faroese university's thoughts on the missing gap between immigrants and labor market, and lastly, what the unemployment scheme is doing in this area.
15.30-16.30	Services and organizations in the city Representatives from services and organizations will share about their work and their integration approach along with their thoughts and/ or challenges. The healthcare service to families, religious organizations, and the city library will be represented in this thematic discussion.
