Strengthening child friendly justice through effective cooperation and coordination among different Barnahus-type services in the regions of Spain

Context

The joint EU DG Reform – Council of Europe project “Strengthening child friendly justice through effective cooperation and coordination among different Barnahus-type services in the regions of Spain” is implemented by the Council of Europe in close collaboration with the Ministry of Social Rights and Agenda 2030 during the period of 06/07/2022-31/10/2024. It is co-financed by the EU Structural Support Reform Programme. Barnahus is a leading European model for a child-friendly multidisciplinary and interagency response to child sexual exploitation and abuse.

The project will support the Spanish Government in improving relevant legislation, policies and tools to introduce the Barnahus model in three selected pilot regions and in strengthening the capacity of relevant professionals working for and with children. The project is divided into two main components:

1. Improving the legislative and policy framework to introduce the Barnahus model in Spanish regions;
2. Strengthening capacities of relevant professionals.

Under Output 2.3 of the project, the development of training tools and programmes is foreseen. The new version of the HELP course on child-friendly justice (2023) has been translated and adapted to the Spanish context for different professionals working for and with children, particularly to judges, prosecutors and lawyers and to the staff working at forensic and medicine Institutes.
