European Confederation of Youth Clubs (ECYC)

Cafébabel Strasbourg

Created by Erasmus students in Strasbourg in 2001, Cafébabel is a participatory online magazine written by young people and for young people in Europe

Available in 6 languages, French, English, German, Spanish, Italian and Polish - the site is fed daily by a network of 1500 young authors, translators, photographers and videographers, who exchange on Europe as they live it everyday.

Association des Avocats Numériques / Digital Lawyers Association

The Association of Digital Lawyers was created in July 2016 by Maitre Romain OMER and Maitre David-Olivier GUILLAIN in order to take into account and to determine the modalities of use of the digital in the profession of lawyer. The association aims to welcome all the lawyers concerned by the place of digital in their activities.

Our approach is not to pit lawyers using new technologies with the rest of the profession, but rather to create a reflection and debate with legal professionals and digital experts on the place and scope of new technologies in the exercise of the law. These exchanges make it possible to reflect on changes in the activity, to feed the debate, to share good practices and to propose concrete solutions. In this logic of sharing and exchange, we have various stakeholders interacting in the reflection and we encourage industry professionals to adapt to the digital uses of their profession.
