

Peculiarity of the Penitentiary Police


Treatment and care of offenders











- The participation of the Penitentiary Police in the inter-agency coordination unit based at the Ministry of Interiors;
- Penitentiary Police officers assigned to the National Anti-mafia Directorate;
- the possibility, in case of specific prisoners' escorted transfers, to use the airplanes of the Finance Police ("Guardia di Finanza")





- detailed monitoring activity to prevent the risk of radicalization to violent extremism
- On subjects imprisoned for crimes of international terrorism and under observation due to activity of proselytism and criminal recruitment






- a) **monitoring**, for the subjects sentenced for or charged with crimes of international terrorism;
- b) **supervision**, for the inmates close to violent extremist ideologies who could carry out activities of proselytism and recruitment:
- c) **signaling**, for prisoners whose behavior needs to be further analyzed.



- All Information are shared in the <u>Committee of Anti-terrorism</u> <u>Strategic Analysis</u> (CASA)
- The members of that Committee are:
 - the State Police,
 - the Carabinieri,
 - the Finance Police (Guardia di Finanza),
 - the Department of Penitentiary Administration and
 - the Intelligence Agencies



Information from prisons shared with the CASA members (2015-2016)






Management of the DNA Databank Laboratory, in cooperation with other law enforcement agencies. Staff: 28 persons, including technician managers, biologists





22nd CDPPS Lillestrom - Norway

- Collaboration with the Ministry of Interiors: new IT procedure, Certificate for the identification of the foreign inmate (CIDES):
- to avoid that non-EU former prisoners, for their certain identification after release, have to stay in the Centers for Identification and Removal
- All the Police Stations can access information on prison life useful to ascertain foreigners' identity



Inter-professional training within the penal system



- An integrated training system for the prison, probation and juvenile justice staff
- Based upon decentralized training and training on-thejob,
- to include also workers from local bodies involved in offenders' social reintegration.
- The exchange of information and knowledge through the integrated training is crucial to share goals and responsibilities

High-ranking officers of the Penitentiary Police have been participating, for the last ten years, in inter-agency training activities organized by the *Italian Specialization School for the Law Enforcement Agencies*.



22nd CDPPS Lillestrom - Norway

- The Course of Criminal Analysis, subdivided into two levels includes topics such as:
 - criminal analysis of the context;
 - analysis of national and internationals scenarios of the threats;
 - analytic instruments of the decision-making process;
 - structure and function of the Committee of Anti-terrorism
 Strategic Analysis (CASA) and the international terrorism;
 - study of different types of mafia criminal organizations

Some training courses held at the International High Training School for the fight against organized crime:

- "Human Being trafficking Migrants trafficking"
- "Instruments and procedures for the prevention of organized crime"
- "Undercover Operations"





School for the fight against organized crime:

- "Terrorism and subversive extremism", about the following topics:
 - terrorist and subversive networks in Europe and the Italian peculiarity of the CASA;
 - terrorist and subversive networks in the Middle East;
 - modalities of approach to anti-terrorist investigations in the Italian experience of the National Prosecutor Office;
 - management of organized crime prisoners and of potential "justice collaborators" also with reference to the processes of violent radicalization in prisons.
