### The context:

An annual event since it was established in 1994 by the North-South Centre of the Council of Europe, the Lisbon Forum has been a distinctive platform bringing together high-level participants from Europe, neighbouring regions and other continents to share experience, good practice and expertise.

Themes of the Forum have been closely related to the core mission of the Council of Europe: to promote democracy, human rights and the rule of law.

At their 125<sup>th</sup> Session in Brussels on 19<sup>th</sup> May 2015, the Committee of Ministers of the Council of Europe reiterated their determination to make a strong contribution to the fight against violent extremism and radicalisation leading to terrorism, firmly based on the respect of human rights, rule of law and democracy, adopting a <u>political declaration</u> and an <u>Action plan</u>.

Building on the expertise and core mission of the North-South Centre to promote dialogue between North and South, foster solidarity and promote global interdependence the **2015 Lisbon Forum** will take place **3-4 December 2015** in Lisbon, Portugal under the theme *"How to combat radicalisation and terrorism: prevention tools and shared knowledge in the Mediterranean and European space."* 

LF2015 will gather quadrilogue actors from Europe and the Southern Mediterranean with a view to:

- Further develop ideas and outcomes from the <u>World Forum on Democracy</u> and contribute to implementation of the Council of Europe <u>Action Plan</u>;
- Share tools and knowledge and promote good practices to prevent and combat radicalisation;
- Identify concrete measures to promote interdependence, democratic citizenship and inclusive societies in the Mediterranean and European space;
- Adopt operational conclusions and recommendations addressed to all quadrilogue actors that can serve to prevent and combat radicalisation and terrorism.

LF2015 will be organised with contributions from a wide range of partners – from within the Council of Europe and beyond – who have developed substantial knowledge and know-how in this field. Participants will be drawn from international organisations, relevant ministries in European and Southern Mediterranean states, parliaments, local authorities and civil society. A series of roundtables contextualising the subject and opening the path to more in depth discussions in workshops will be developed along three main axes:

- Rule of Law and Democratic responses : A bulwark against radicalisation
- Preventing radicalisation through education and dialogue
- Empowering young people and women to prevent and combat radicalisation

The Lisbon Forum 2015 is organised in the framework of the South Programme II: *Towards strengthened democratic governance in the Southern Mediterranean*, financed by the European Union and implemented by the Council of Europe. It will seek to contribute to the overall objectives of South Programme II to support constitutional processes, the consolidation of a common legal space and the creation of formal and informal networks between Europe and the countries of the Southern Mediterranean.
