One permanent method measuring quality is statistics. Statics of workload and open cases or undone decisions, programs controlling the quality of the registry of court.

Another system of quality checks – as reaction of single complaints of court users – is the "Ombudsstelle ", which consists of judges of the Oberlandesgericht who are specialised in working with complaints of court users in a very quick and informal way.
