Report

2nd meeting
15 – 17 February 2017

Item 1: Opening of the meeting and adoption of the agenda

- 1. The CDDH Drafting Group on Migration and Human Rights (CDDH-MIG) held its 2nd meeting in Nicosia, Cyprus, from 15 to 17 February 2017 with Mr Morten RUUD (Norway) in the Chair. The list of participants appears in <u>Appendix I</u>.
- 2. The Chair opened the meeting and welcomed all participants. The Group adopted the agenda and had an exchange of views on the joint meeting with the Committee of Experts on Administrative Detention of Migrants (CJ-DAM) that was held in the morning of 15 February 2017.

<u>Item 2</u>: Contributions to the CDDH-MIG request for information on alternatives to detention in the context of migration

3. The Secretariat informed the Group of contributions received in response to the CDDH-MIG request for information on alternatives to detention in the context of migration. So far, 23 member States and 4 observers have sent in replies. The replies provide insights on various aspects that will continue to be incorporated into the analysis. It was decided that, where needed, the Secretariat could follow up directly with CDDH-MIG members on certain responses for clarification. Subject to prior approval, the replies may be shared with the Group and published along with other relevant meeting material. It was reiterated that member States and observers could still send in further replies before the 3rd meeting of CDDH-MIG.

<u>Item 3</u>: Discussion on the preliminary draft analysis of the legal and practical aspects of effective alternatives to detention in the context of migration

- 4. The Rapporteur, Mr Frank SCHÜRMANN, introduced the preliminary draft analysis and highlighted the central changes made since the 1st meeting of CDDH-MIG from 14 to 16 September 2016. The Group conveyed its thanks to the Rapporteur and the Secretariat for their excellent work, expressing its satisfaction with the revised version and noting that it fully reflected the comments provided at the 1st CDDH-MIG meeting.
- 5. The Group then examined, section by section, the preliminary draft analysis and provided a number of suggestions on the structure and substance as well as on certain editing issues. The Group asked the Rapporteur and the Secretariat to prepare a revised draft analysis in light of the comments received during the meeting.
- 6. The Group agreed that all relevant meeting materials of the CDDH-MIG should continue to be made available to CJ-DAM. In particular, efforts should be made to harmonise definitions and concepts in line with the jurisprudence of the European Court of Human Rights and other relevant human rights standards.

The conference will, in particular, focus on the immigration detention of children and effective alternatives.
